(i) Dearness Allowance: Dearness Allowance (DA) rates in respect of posts at Sl. No. 1 to 9 will be as declared by Reserve Bank of India / Indian Banks Association from time to time. DA rate for November, December 2019 & January 2020 is 71.7% of Pay. Presently the revision of DA is quarterly, as under —

February, March, April May, June, July August, September, October November, December, January.

(iii) Other Perks and Allowances: Other Perks and Allowances would be as decided from time to time.

Note 4: The officers and employees of the Authority who are on deputation shall be eligible for pension and retirement benefits, if any, as are available to them in their parent Ministry or Department or organization.

Note 5: Officers presently residing in GPRA Quarter at Delhi can retain the same upto 30.9.2023 in view of Ministry of Urban Development OM No. 12035 / 12 /2013-Pol.II dated 15.1.2014
