ORDER

In supersession of all earlier orders regarding delegation of powers to Head of Departments of NCLT and NCLAT, the President is pleased to designate Secretary, NCLT (Principal Bench), Members (in charge of Administration) of Regional Benches of NCLT and Registrar, NCLAT as 'Head of Department' under Rule 13(2) and Rule 3(f) of Delegation of Financial Power Rules, (DFPR), 1978.

2. Further, in accordance with the guidelines issued by the Ministry of Finance under O.M. No.F.10(13)-E(Coord)/75 dated 10.04.1975 and O.M. No.I/7/E-II (A)/2008 dated 30.05.2008, financial powers to the following extent is also delegated to Secretary, NCLT and Registrar, NCLAT for incurring contingent and miscellaneous expenditure in accordance with Annexure to Schedule V and VI of DFPR-1978 as revised and amended from time to time:

- 4. Beyond the delegated powers of Members (Administration) of Regional Benches of NCLT, the concurrence of Secretary, NCLT will be required to be taken by Regional Benches, who will exercise his powers as per conditions stipulated in succeeding paras.
- 5. The powers delegated are subject to the following conditions:-
 - (i) The powers delegated above will include financial sanctions for the proposal for Design and Development, Implementation, Operation and Maintenance of the e-Governance solution for the NCLT/NCLAT, being implemented through NICSI/NIC, approved vide this Ministry's letter No.A-45011/43/2015-Ad.IV dated 31.03.2017.

DS/Director (Finance) of IFD of the Ministry is designated as the Financial Adviser to NCLT/NCLAT.

(iii) Whenever the financial implication crosses the following limit, Secretary, NCLT and Registrar, NCLAT will exercise their powers with concurrence of DS/Director (Finance) [or his/her link officer in the absence of DS/Director (Finance) for any reason]:

- (iv) The proposals for financial concurrence will be directly submitted to DS/Director (Finance) without routing through Administrative Section.
- (v) No outsourcing is to be done against the sanctioned/earmarked strength.
- (vi) For more operational efficiency and availability of qualitative service, the scope of outsourced service with respect to requirement, existing establishment and financial resources is to be decided.
- (vii) Outsourcing of Services will be done in accordance with the provisions of the GFR 2017 and other rules/instructions prescribed by the Ministry of Finance from time to time.
- (viii) An annual report will be sent to the Ministry about the services outsourced.
- (ix) That the delegation of Financial Powers is subject to provisions of GFR 2017, fiscal orders, procedures, availability of funds and general instructions issued by the Ministry of Finance from time to time.
- (x) That the powers delegated are subject to provisions contained in Note 2 of Schedule V of DFPR 1978.
- (xi) No power is, however, is delegated in respect of-
 - (a) Creation of posts
 - (b) Write off of losses
 - (c) Re-appropriation of funds
 - (d) Purchase of Capital Assets
- All budget proposals relating to NCLT/NCLAT will be sent to Budget Section of this Ministry directly by NCLT/NCLAT.
- 7. This issues with the approval of the Chief Accounting Authority. The advice of Internal Finance/Integrated Finance was conveyed vide Dy. No.1530 dated 29.5.2017.
