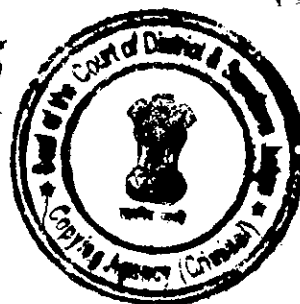

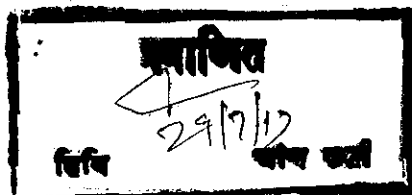

His statement is recorded for both accused separately as CW-1.

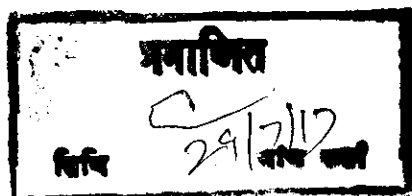
In view of the statement, I am of the view that both accused are avoiding their appearance before this Court. Hence, they are declared P.O.

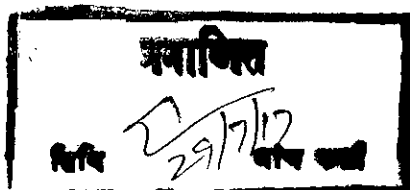
