HIGHLIGHTS

I. REGISTERED COMPANIES AS ON 30th JUNE 2017

1. The total number of companies registered in the country as on 30th June 2017, stood at 1,669,076. Of them 409,188 companies were closed; 1,017 companies were assigned dormant status as per the Companies Act, 2013; 5 companies have not filed their annual statutory annual filing for 2 years consecutively; 5,774 were under liquidation; 27,232 companies were in the process of being struck-off and 118 companies were in the process of being re- activated. Taking the above into account, there were 1,225,742 active companies as on 30th June 2017.

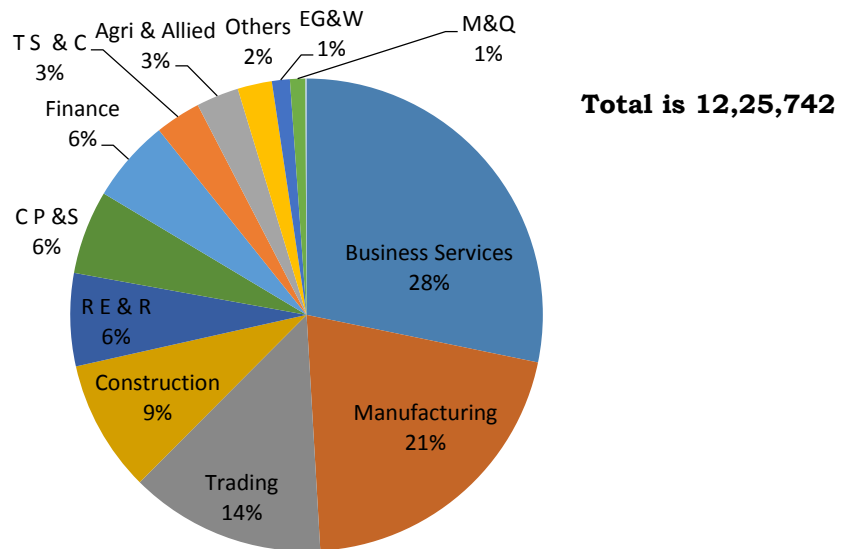
2. Out of the 409,188 closed companies, about 10,345 companies were liquidated/dissolved; 368,572 companies were defunct (and hence struck-off); 19,406 companies were amalgamated/ merged with other companies; 6,072 companies were converted to LLP and 4,793 were converted to LLP and dissolved. **Table-1.1** presents the summary picture of companies count as on 30th June 2017.

3. Out of the 1,215,159 active companies limited by shares; 1,135,731 were Private and 79,428 were Public companies, segregated into 7,323 Listed and 72,105 Unlisted Companies (**Table 1.2**).

4. State/UT-wise distribution of registered companies indicates that Maharashtra has the highest number of companies (333,065), followed by Delhi (306,733) and West Bengal (193,733). Similarly, amongst 'Active Companies', Maharashtra has the maximum number of active companies (250,592), followed by Delhi (228,401) and West Bengal (133,945) as on 30th June 2017 (**Table-1.3**).

5. Economic-activity wise classification of active companies reveals that highest number of companies are in Business Services (345,997) followed by Manufacturing (255,466), Trading (164,306) and Construction (110,625). Business Services comprise of Information Technology, Research & Development and other business activities (such as law, audit & accounts and consultancy, etc. (**Table-1.4 and Chart 1.1**).

Chart 1.1: Sector-wise Active Companies as on 30th June 2017

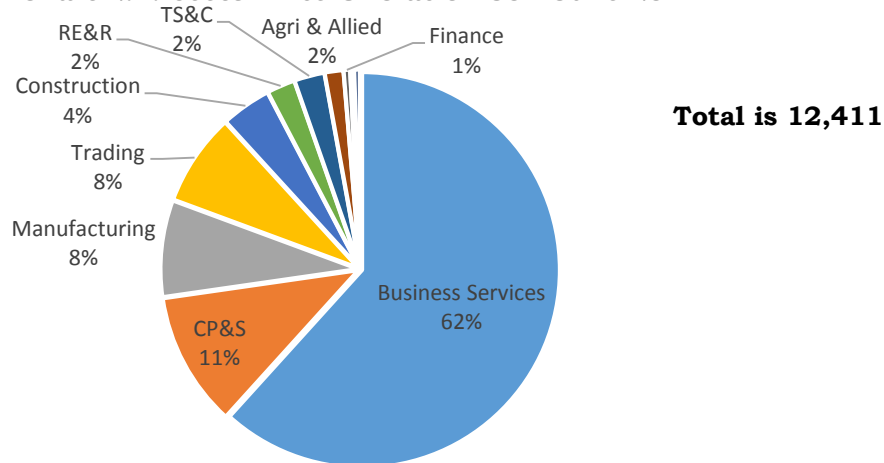

II. ONE PERSON COMPANY

6. Up to 30th June 2017, a total number of 12,411 One Person Companies (OPCs) were registered with collective authorized capital of Rs. 311.24 crore. Economic activity wise classification of OPCs up to 30th June 2017 reveals that the highest number of OPCs are in Business Services (7,658) followed by Community, Personal & Social Services (1,367), Manufacturing (982) and Trading (940) (**Chart 2.1**). During the month of June 2017, a total of 501 OPC were registered with authorized capital of Rs. 11.36 crore. Economic activity wise classification of OPC during the month reveals that highest number of 336 OPCs were registered in Business Services, followed by 41 in Community, personal & Social Services and 34 in Manufacturing (**Table 2.1**).

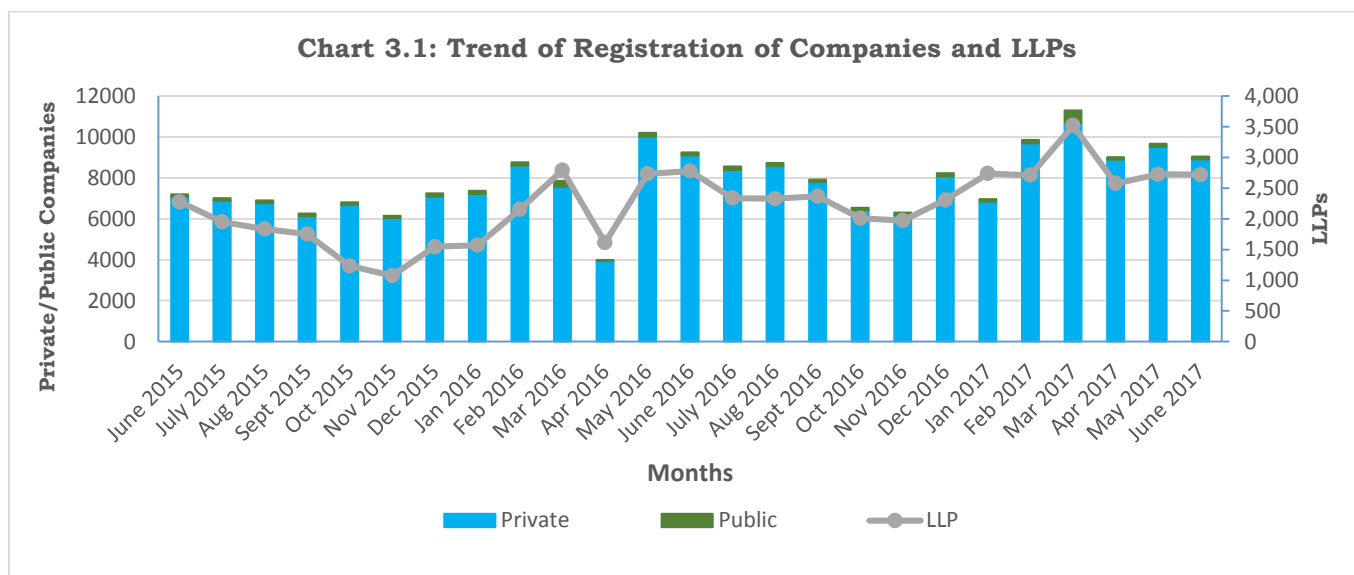
Chart 2.1: Sector-wise OPC as on 30th June 2017

III. TREND OF REGISTRATION OF NEW COMPANIES

7. An analysis of registration of new companies during June 2015 to June 2017 indicates that monthly registration of companies has increased after hitting its lowest of 3,994 in April 2016 (**Chart 3.1**). A total of 9,045 companies were registered in June 2017 as compared to 9,252 in June 2016. A slight decrease (-2.24%) in registration of companies has been witnessed in June 2017 over the previous month. A total of 2,720 LLPs were registered in June 2017 as compared to 2,778 LLPs in June 2016 (**Table 3.1**).

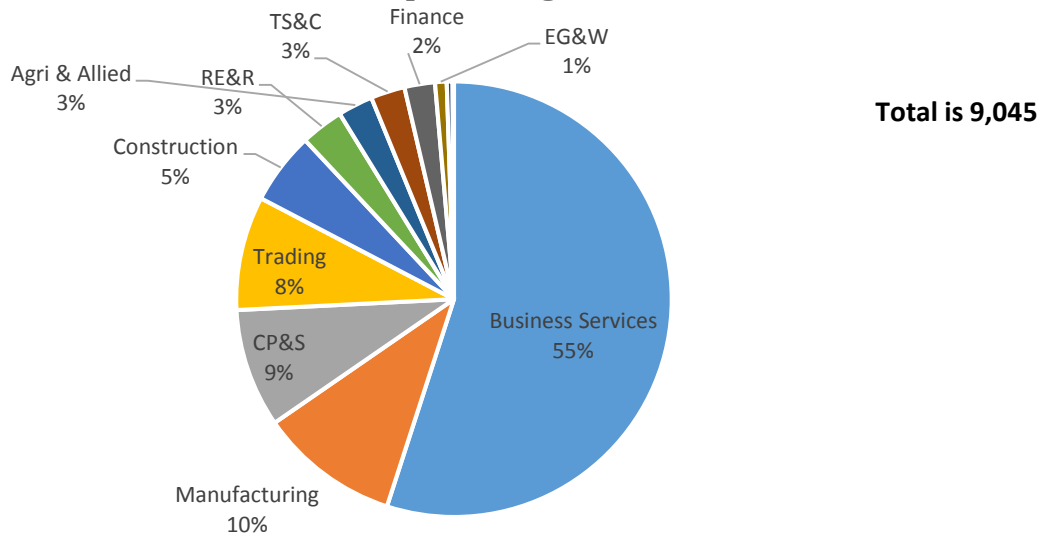


IV. REGISTRATION OF NEW COMPANIES DURING JUNE 2017

8. During the month of June 2017 a total of 9,045 companies were registered with collective authorized capital of Rs. 1,697.68 crores. Of them 9,010 companies were registered as Companies Limited by Shares with authorized capital of Rs. 1,697.57 crores; 35 companies were registered as Limited by Guarantees with authorized capital of Rs. 11 lakhs (**Table-4.1**).

9. Economic-activity wise classification of companies registered during June 2017 (**Table-4.2 and Chart 4.1**) reveals that the predominant share of companies is in Business Services (4,974) followed by Manufacturing (941), Community, personal & Social Services (797), Trading (765) and Construction (485).

Chart 4.1: Distribution of Companies Registered in June 2017



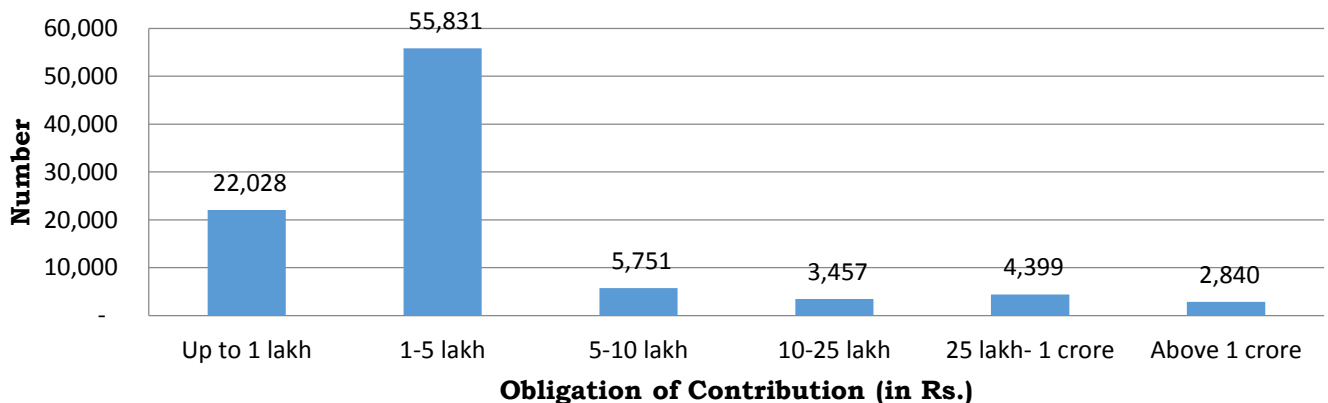

10. During June 2017, 1,573 (17.39%) companies were registered in Maharashtra, followed by 1,476 (16.32%) in Delhi, and 783 (8.55%) in Karnataka (**Table-4.3**).

V. Limited Liability Partnerships (LLPs)

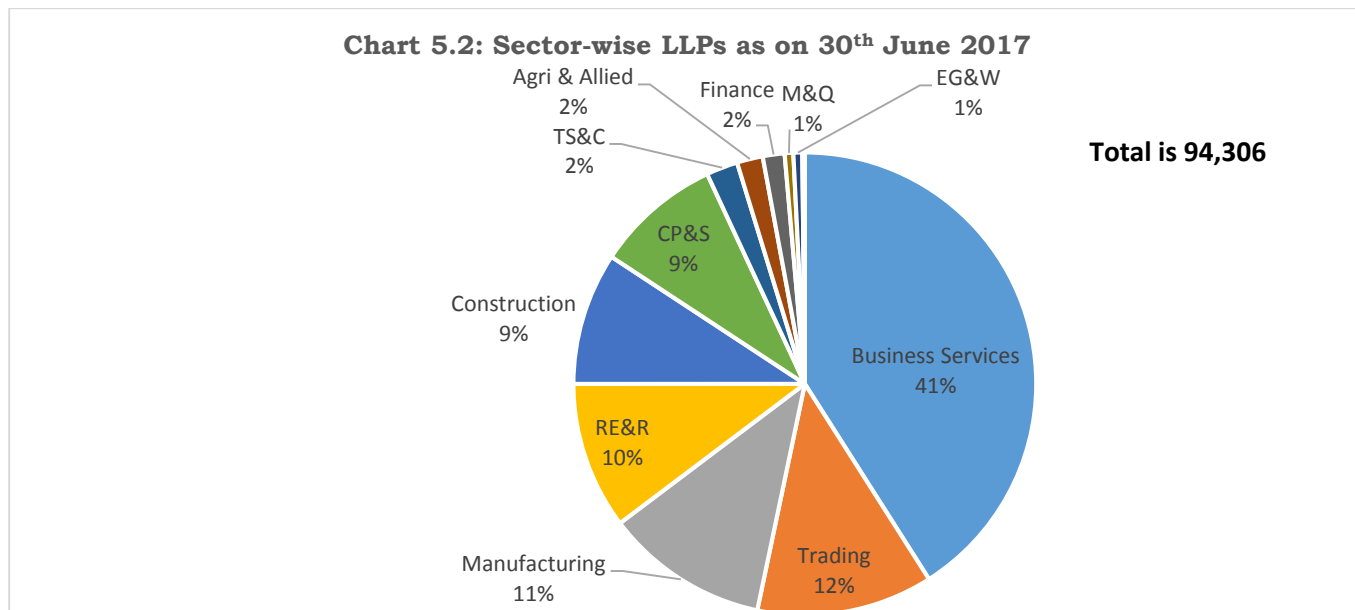
11. As on 30th June 2017, a total number of 94,306 LLPs were active in the country. About 82.56% active LLPs (77,859 in number) have obligation of contribution less than or equal to Rs. 5 lakhs each; and only about 3.01% (2,840 in number) of LLPs have obligation of contribution above Rs.1 crore each (**Table-5.1 and Chart 5.1**)

Chart 5.1: Obligation of Contribution wise distribution of LLPs



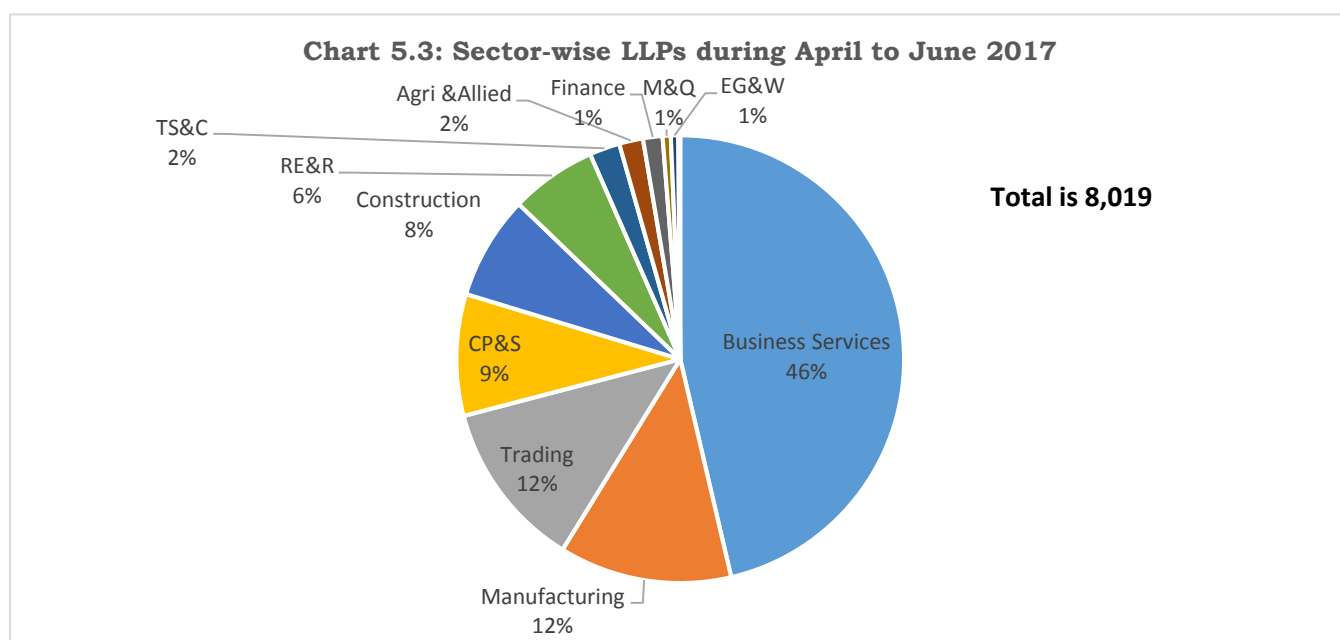
12. Broad economic sector wise classification of active LLPs as on 30th June 2017 reveals that Service sector account for 71,942 LLPs, followed by Industry and Agriculture sectors accounting for 20,658 and 1,704 respectively. Economic-activity wise classification of active LLPs as on 30th June 2017 reveals that a large number of LLPs are

in Business Services (38,651) followed by Trading (11,611), Manufacturing (10,774) and Real Estate & Renting (9,690) (**Table-5.2 & Chart 5.2**).

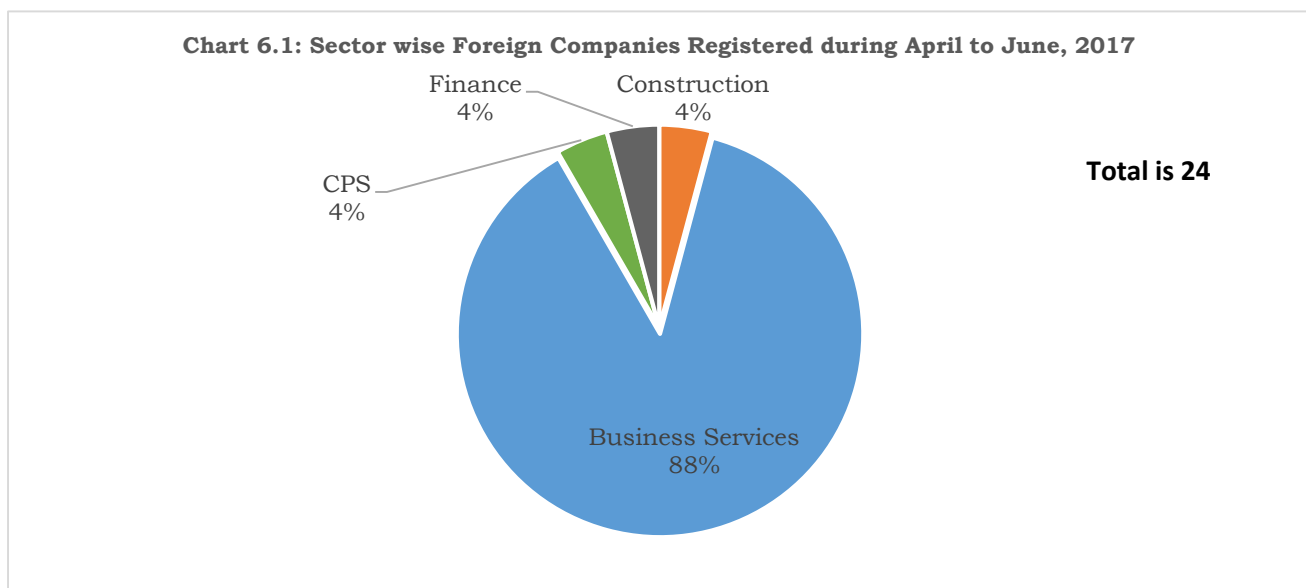
13. During April 2017 to June 2017, a total of 8,019 Limited Liability Partnerships (LLPs) were registered with collective obligation of contribution of Rs. 1,504.35 crores. Economic activity wise classification of LLPs during April to June 2017 indicates that highest number of 3,716 LLPs were registered in Business Services followed by 1,000 in Manufacturing, 971 in Trading and 704 in Community, Personal and Social Services (**Table 5.3 and Chart 5.3**).

VI. FOREIGN COMPANIES

14. As on 30th June 2017, a total of 4,542 foreign companies were doing business in India, of which 3,353 of them were active. During April 2017 to June 2017, a total of 24 foreign companies were registered in India including 5 in Delhi (20.8%) followed by 4 each (16.7%) in Karnataka and Tamil Nadu (**Table 5.4**). Economic activity wise classification of foreign companies reveals that highest number of 21 were registered in Business Services followed by 1 each in Community, Personal & Social Services, Construction and Finance. (**Table 6.1 and chart 6.1**).
