## **HIGHLIGHTS**

#### I. REGISTERED COMPANIES AS ON 30<sup>th</sup> November, 2019


The total number of companies registered in the country as on 30<sup>th</sup> November, 2019 stood at 1,954,812. Of them 732,631 companies were closed. 2,104 companies were assigned dormant status as per the Companies Act, 2013; 6,478 were under liquidation; 48,374 companies were in the process of being struck-off. After being struck off previously, 69 Companies were in the process of being re-activated. Taking the above into account, there were 1,165,156 active companies as on 30<sup>th</sup> November, 2019.

1. Out of the 732,631 closed companies, 10,876 companies were liquidated/dissolved; 679,845 companies were declared defunct (and hence struck-off after issuance of notice u/s 248). 24,270 companies were amalgamated/ merged with other companies; 12,766 companies were converted to Limited Liability Partnership (LLP) and 4,874 were converted to LLP and dissolved. **Table-1.1** presents the summary picture of companies count as on 30<sup>th</sup> November, 2019.

2. Out of the 1,165,156 active companies, 1,157,598 were limited by shares; 7,252 were limited by guarantee and 306 were unlimited companies. Out of the companies limited by shares, 63,220 were public, 1,094,378 were private including 25,763 one person companies. Among the public limited companies, 6,844 were listed (**Table 1.2**).

3. State/UT-wise distribution of registered companies indicates that Maharashtra has the highest number of companies (386,013), followed by Delhi (342,729) and West Bengal (205,155). Amongst 'Active Companies', Maharashtra has the maximum number of active companies (227,464), followed by Delhi (200,397) and West Bengal (125,488) as on 30<sup>th</sup> November, 2019. (**Table-1.3**).


4. Economic-activity wise classification of active companies reveals that highest number of companies were in Business Services (375,747) followed by Manufacturing (232,684), Trading (149,363) and Construction (98,688). Business Services comprise of Information Technology, Research & Development and other business activities such as law, audit & accounts and consultancy, etc. **(Table-1.4 and Chart 1.1)**.



'M&Q' is Mining & Quarrying, 'TS&C' is Transport, Storage and Communication, and 'CP&S is Community, Personal & Social Services, 'RE&R' is Real Estate and Renting, 'EG&W', is Electricity Gas & Water. 13,948 active companies (Others) are having invalid Economic Activity (NIC-2004) Code.

### II. ONE PERSON COMPANY


**5.** Up to 30<sup>th</sup> November, 2019, a total number of 25,763 One Person Companies (OPCs) were registered with collective authorized capital of Rs. 749.08 crore. Economic activity wise classification of OPCs up to 30<sup>th</sup> November reveals that the highest number of OPCs were in Business Services (14,587) followed by Community, Personal & Social Services (3,163), Manufacturing (2,544) and Trading (2,472) (**Chart 2.1**). During the month of November 2019, a total of 687 OPC were registered with authorized capital of Rs. 21.57 crore. Economic activity wise classification of OPC during the month reveals that highest number of 272 OPCs were registered in Business Services, followed by 137 in Manufacturing, 101 in Trading and 87 in Community, personal & Social Services. #### III. TREND OF REGISTRATION OF NEW COMPANIES


6. An analysis of registration of new companies during November 2017 to November 2019 indicates that monthly registration of companies has increased after hitting lowest of 7,740 Companies in August 2018 (Chart 3.1). A total of 10,607 companies were registered in November 2019 as compared to 8,745 in November 2018. A increase (6.79%) in registration of companies has been witnessed in November 2019 over the previous month (Table 3.1).



#### IV. REGISTRATION OF NEW COMPANIES DURING NOVEMBER, 2019

7. During the month of November 2019, a total of 10,607 companies were registered with collective authorized capital of Rs. 1975.07 crore. Of them 10,550 companies were registered as Companies Limited by Shares with authorized capital of Rs. 1975.08 crore; **(Table-4.1)**.

8. Economic-activity wise classification of companies registered during November 2019 (**Table-4.2 and Chart 4.1**) reveals that the predominant share of companies is in Business Services (3,279) followed by Manufacturing (2,210), Community, personal & Social Services (1,350), Trading (1,306) and Construction (612).



'EG&W' is Electricity, Gas and Water, 'TS&C' is Transport, Storage and Communication, 'CP&S' is Community, personal & Social Services, 'RE&R' is Real Estate and Renting.

9. During November 2019, 1,907 (17.98%) companies were registered in Maharashtra, followed by 1,259 (11.87%) in Delhi, and 1,024 (9.65%) in Uttar Pradesh **(Table-4.3).**
