

HIGHLIGHTS

I. REGISTERED COMPANIES AS ON 31st OCTOBER 2016


- 1. The total number of companies registered in the country as on 31st October 2016, stood at 1,598,853. Of them, 2,95,116 companies were closed; 706 companies were assigned dormant status as per the Companies Act, 2013; 138,410 companies have not filled their statutory annual filling for 2 years consecutively; 5,648 companies were under liquidation; 26,643 companies were in the process of being struck-off and 253 companies were in the process of being re-activated. Taking the above into account, there were 1,132,077 active companies as on 31st October, 2016.
- 2. Out of the 295,116 closed companies, about 10,310 companies were liquidated/dissolved; 257,913 companies were defunct (and hence struck-off); 18,177 companies were amalgamated/ merged with other companies; 3,927 companies were converted to LLP and 4,789 were converted to LLP and dissolved. **Table-1.1** presents the summary picture of companies count as on 31st October 2016.
- 3. Out of the 1,125,103 active companies limited by shares; 1,061,214 were Private and 63,889 were Public companies, segregated into 6,725 Listed and 57,164 Unlisted Companies (**Table 1.2**).
- 4. State/UT-wise distribution of registered companies indicates that Maharashtra has the highest number of companies (320,642), followed by Delhi (295,732) and West Bengal (190,927). Similarly, amongst 'Active Companies', Maharashtra has the maximum number of active companies (234,980), followed by Delhi (212,182) and West Bengal (139,973) as on 31st October, 2016 (**Table-1.3**).
- 5. Economic-activity wise classification of active companies reveals that highest number of companies were in Business Services (318,607) followed by Manufacturing (228,740), Trading (160,150) and Construction (112,227). Business Services comprise of Information Technology, Research & Development and other business activities such as law, audit & accounts and consultancy, etc. (**Table-1.4 and Chart 1.1**).



'M&Q' is Mining & Quarrying, 'TS&C' is Transport, Storage and Communication, 'RE&R' is Real Estate and Renting and 'CP&S is 'Community, Personal & Social Services'. 20,625 active companies (Others) are having invalid Economic Activity (NIC-2004) Code.

II. ONE PERSON COMPANY


6. Up to 31st October 2016, a total number of 8,865 One Person Companies (OPCs) were registered with collective authorized capital of Rs. 233.79 crore. Economic activity wise classification of OPCs up to 31st October 2016 reveals that the highest number of OPCs were in Business Services (5,294) followed by Community, Personal & Social Services (1,064), Manufacturing (730) and Trading (692) (Chart 2.1). During the month of October 2016, a total of 340 OPC were registered with authorized capital of Rs. 15.14 crore. Economic activity wise classification of OPC during the month reveals that highest number of 230 OPCs were registered in Business Services, followed by 26 in Trading and 22 in Manufacturing (Table 2.1).


III. TREND OF REGISTRATION OF NEW COMPANIES

8. An analysis of registration of new companies during January 2015 to October 2016 indicates that monthly registration of companies has increased after hitting its lowest of 3,994 in April 2016 (Chart 3.1). A total of 6,542 companies were registered in October 2016 as compared to 6,807 in October 2015. A decrease(-17.43%) in registration of companies has been witnessed in October 2016 over the previous month. (Table 3.1).



IV. REGISTRATION OF NEW COMPANIES DURING OCTOBER 2016

- 9. During the month of October 2016, a total of 6,542 companies were registered with collective authorized capital of Rs. 462.73 crore. Of them 6,504 companies were registered as Companies Limited by Shares with authorized capital of Rs. 462.42 crore; 38 companies were registered as Limited by Guarantees with authorized capital of Rs. 31.10 lakh(**Table-4.1**).
- 10. Economic-activity wise classification of companies registered during October 2016 (**Table-4.2 and Chart 4.1**) reveals that the predominant share of companies were in Business Services (3,658) followed by Manufacturing (726), Trading (525), Construction (356) and Community, personal & Social Services (311).

11. During October 2016, 1,195 (18.27%) companies were registered in Maharashtra, followed by 1,041(15.91%) in Delhi, and 614 (9.39%) in Uttar Pradesh (**Table-4.3**).
