## **HIGHLIGHTS**

### **I. REGISTERED COMPANIES AS ON 30<sup>TH</sup> SEPTEMBER, 2019**

1. The total number of companies registered in the country as on 30<sup>th</sup> September, 2019 stood at 1,933,106. Of them 686,874 companies were closed, 2,055 companies were assigned dormant status as per the Companies Act, 2013; 6,426 were under liquidation; 43,107 companies were in the process of being struck-off. After being struck off previously, 73 Companies were in the process of being re-activated. Taking the above into account, there were 1,194,571 active companies as on 30th September, 2019.

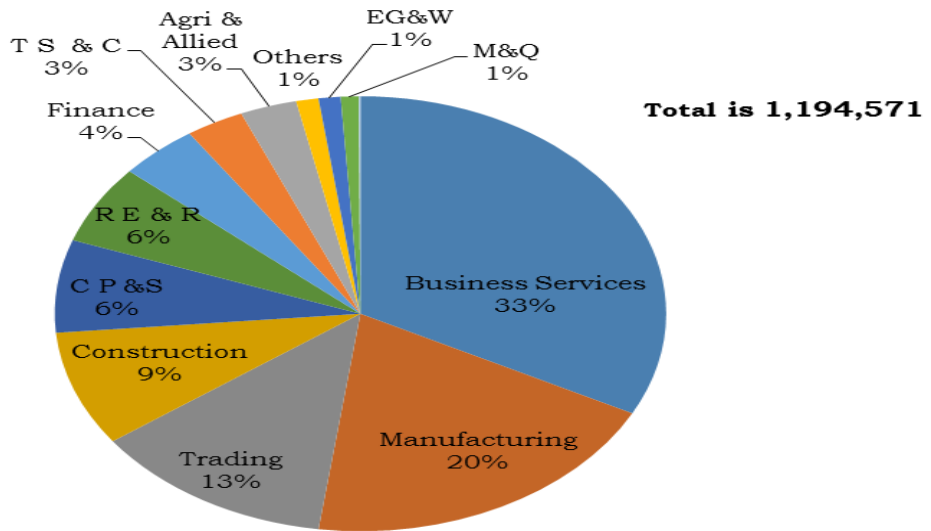
2. Out of the 686,874 closed companies, 10,815 companies were liquidated/dissolved; 635,077 companies were declared defunct (and hence struck-off after issuance of notice u/s 248). 23,756 companies were amalgamated/ merged with other companies; 12,352 companies were converted to Limited Liability Partnership (LLP) and 4,874 were converted to LLP and dissolved. **Table-1.1** presents the summary picture of companies count as on 30th September, 2019.

3. Out of the 1,194,571 active companies, 1,187,094 were limited by shares; 7,165 were limited by guarantee and 312 were unlimited companies. Out of the companies limited by shares, 64,298 were public, 1,122,796 were private including 26,070 One person companies. Among the public limited companies, 6,860 were listed (**Table 1.2**).

4. State/UT-wise distribution of registered companies indicates that Maharashtra has the highest number of companies (382,067), followed by Delhi (340,512) and West Bengal (204,396). Amongst 'Active Companies', Maharashtra has the maximum number of active companies (231,039), followed by Delhi (206,378) and West Bengal (129,413) as on 30th September, 2019. (**Table-1.3**).

5. Economic-activity wise classification of active companies reveals that highest number of companies were in Business Services (389,131) followed by Manufacturing (234,356), Trading (153,359) and Construction (102,394). Business Services comprise of Information Technology, Research & Development and other business activities such as law, audit & accounts and consultancy, etc. (**Table-1.4 and Chart 1.1**).

**Chart 1.1: Sector-wise Active Companies as on 30th September, 2019**

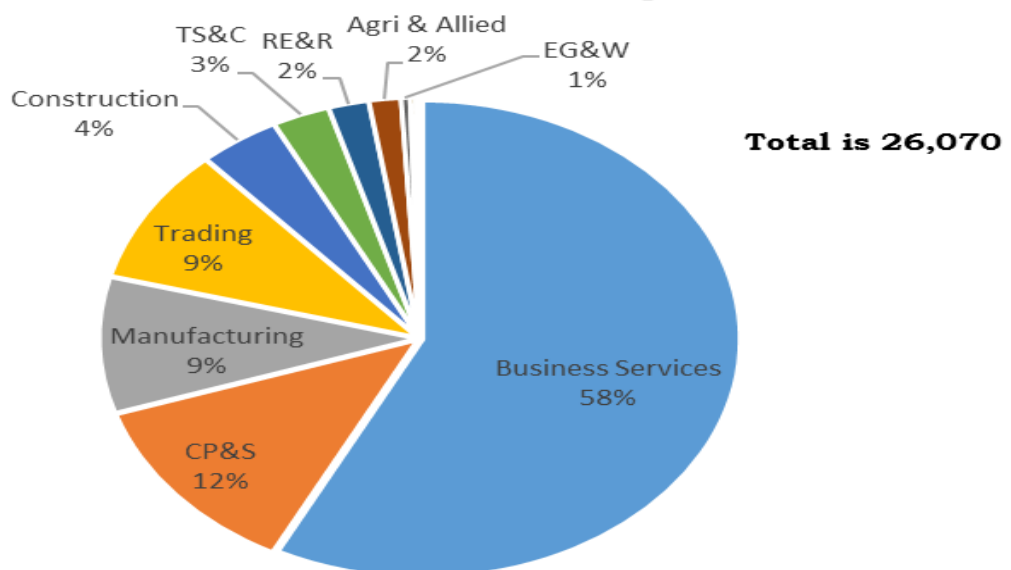

**II. ONE PERSON COMPANY**

6. Up to 30th September, 2019, a total number of 26,070 One Person Companies (OPCs) were registered with collective authorized capital of Rs. 748.52 crore. Economic activity wise classification of OPCs up to 30th September, 2019 reveals that the highest number of OPCs were in Business Services (15,001) followed by Community, Personal & Social Services (3,236), Trading (2,401) and Manufacturing (2,399) (**Chart 2.1**). During the month of September 2019, 620 OPCs were registered with authorized capital of Rs. 21.75 crore. Economic activity wise classification of OPC registered during the month reveals that highest number of 237 OPCs were in Business Services, followed by 96 in Community, personal & Social Services and 93 in Manufacturing and Trading each (**Table 2.1**).

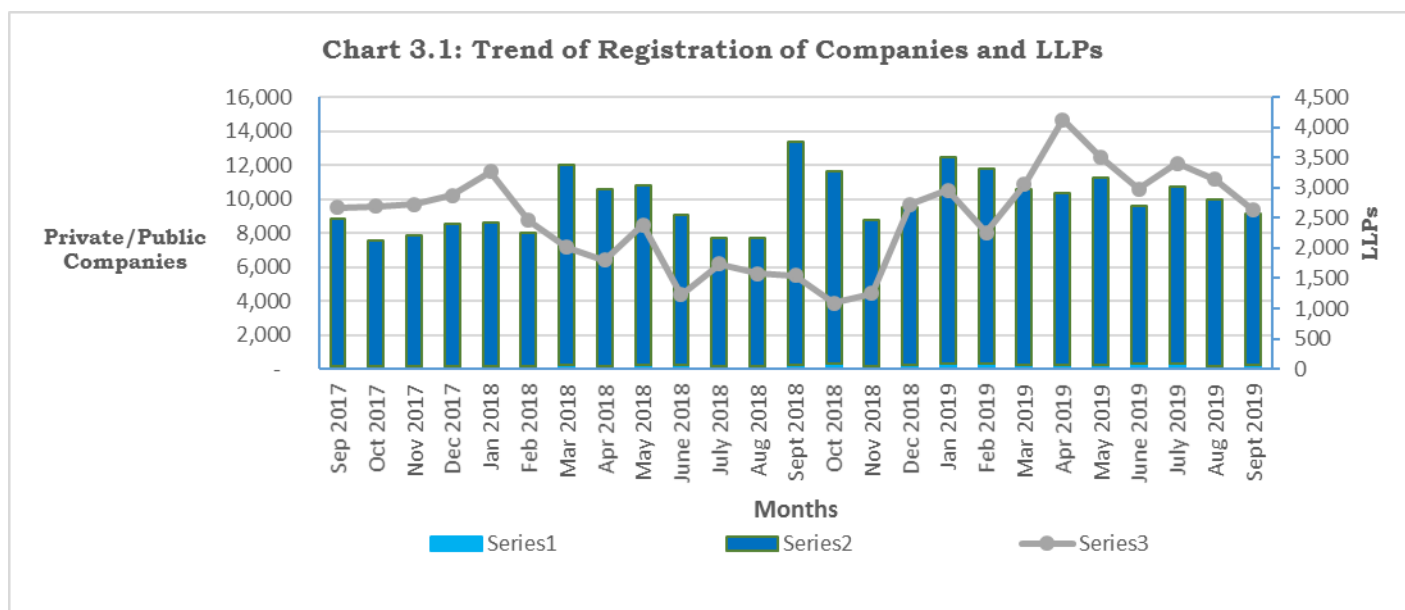
**Chart 2.1: Sector-wise OPC as on 30th September, 2019**

### III. TREND OF REGISTRATION OF NEW COMPANIES

An analysis of registration of new companies during September 2017 to September 2019 indicates that monthly registration of companies has increased after hitting lowest of 7,556 Companies in October 2017 (**Chart 3.1**). A total of 9,171 companies were registered in September 2019 as compared to 13,396 in September 2018. A decrease (8%) in registration of companies has been witnessed in September 2019 over the previous month (**Table 3.1**). A total of 2,627 LLPs were registered in September 2019 as compared to 1,551 LLPs in September 2018 (**Table 3.1**).

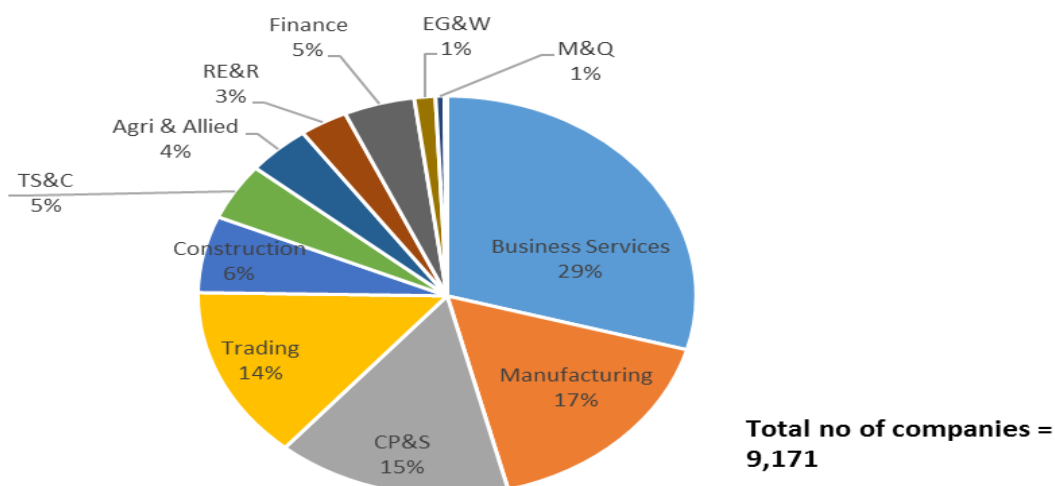


### IV. REGISTRATION OF NEW COMPANIES DURING SEPTEMBER 2019

8. During the month of September 2019 a total of 9,171 companies were registered with collective authorized capital of Rs. 4,991.07 crore. Of them 9,101 companies were registered as Companies Limited by Shares with authorized capital of Rs. 4,991.07 crore; 70 companies were registered as Limited by Guarantee. (**Table-4.1**).

9. Economic-activity wise classification of companies registered during September 2019 (**Table-4.2 and Chart 4.1**) reveals that the predominant share of companies is in Business Services (2,692) followed by Manufacturing (1,532), Community, personal & Social Services (1,395), Trading (1,283), and Construction (569).

**Chart 4.1: Distribution of Companies Registered in September, 2019**



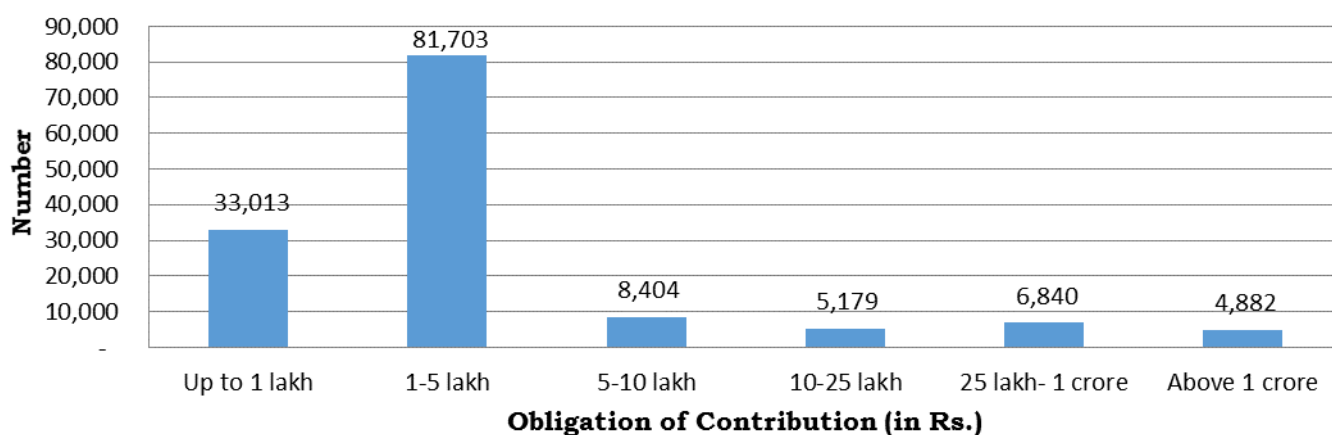

10. During September 2019, 1,597 (17.41%) companies were registered in Maharashtra, followed by 1,111 (12.11%) in Delhi, and 1,007 (10.98%) in Uttar Pradesh (**Table-4.3**).

#### **V. Limited Liability Partnerships (LLPs)**

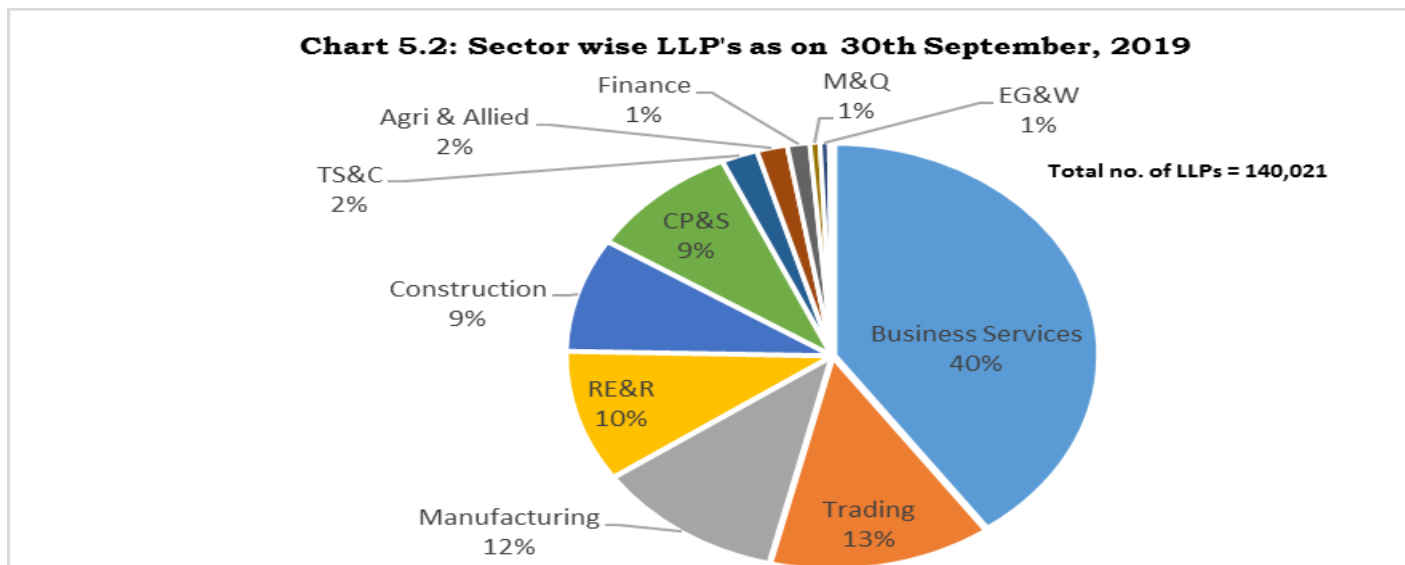
11. As on 30th September 2019, a total number of 140,021 LLPs were active in the country. About 81.93% active LLPs (114,716 in number) have obligation of contribution less than or equal to Rs. 5 lakh each; and only about 3.49% (4,882 in number) of LLPs have obligation of contribution above Rs.1 crore each (**Table-5.1 and Chart 5.1**)

**Chart 5.1: Obligation of Contribution wise distribution of LLPs**



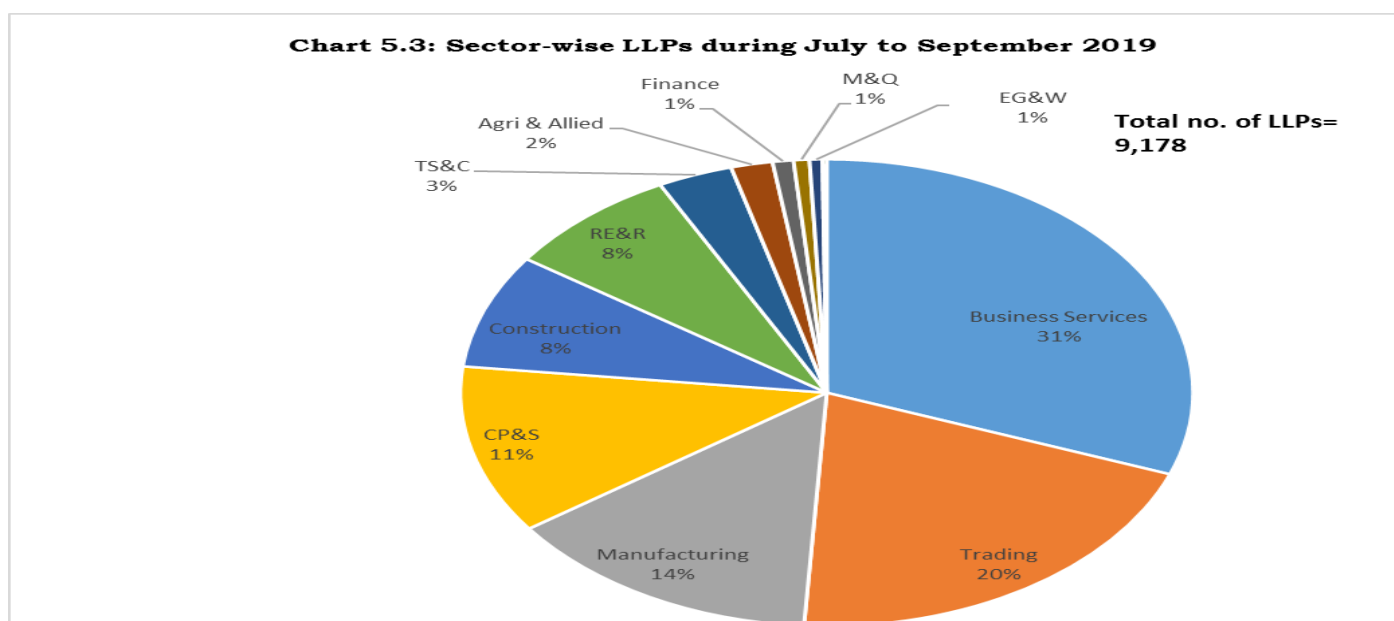
12. Broad economic sector wise classification of active LLPs as on 30th September, 2019 reveals that Service sector account for 107,460 LLPs, followed by Industry and Agriculture sectors accounting for 29,962 and 2,598 respectively. Economic-activity wise

classification of active LLPs as on 30th September, 2019 further reveals that a large number of LLPs are in Business Services (56,269) followed by Trading (19,055), Manufacturing (16,208) and Real Estate & Renting (13,962) (**Table-5.2 & Chart 5.2**).

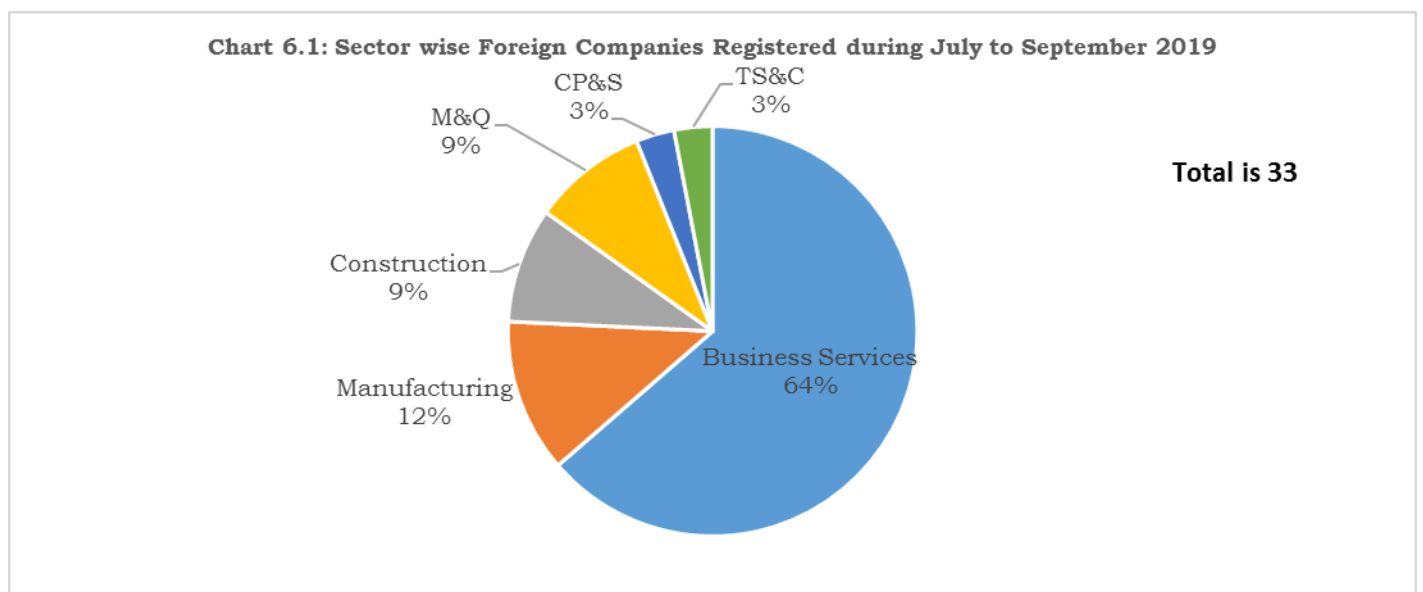
13. During July to September 2019, a total of 9,178 Limited Liability Partnerships (LLPs) were registered with collective obligation of contribution of Rs. 1,120.25 crore. Economic activity wise classification of LLPs during July to September 2019 indicates that highest number of 2,816 LLPs were registered in Business Services followed by 1,864 in Trading, 1,295 in Manufacturing and 1,074 in Community, Personal and Social Services. (**Table 5.3 and Chart 5.3**).

## VI. FOREIGN COMPANIES

14. As on 30th September 2019, a total of 4,836 foreign companies were registered in India, of which 3,388 were active. During July 2019 to September 2019, a total of 33 foreign companies were registered in India including 11 (33.33%) in Maharashtra, followed by 10 (30.30%) in Haryana, and 5 (15.15%) in Delhi. Economic activity wise classification of foreign companies reveals that highest number of 21 were registered in Business Services followed by 4 in Manufacturing, 3 in Mining & Quarrying and Construction each and 1 in Community, personal & Social Services, and in Transport, storage each. **(Table 6.1 and chart 6.1).**
