

# **HIGHLIGHTS**

### I. REGISTERED COMPANIES AS ON 30th SEPTEMBER 2016


- 1. The total number of companies registered in the country as on 30<sup>th</sup> September 2016, stood at 1,592,336. Of them 292,623 companies were closed; 691 companies were assigned dormant status as per the Companies Act, 2013; 1,38,467 companies have not filed their annual statutory filings for 2 years consecutively; 5,623 were under liquidation; 28,038 companies were in the process of being struck-off and 244 companies were in the process of being re- activated. Taking the above into account, there were 1,126,650 active companies as on 30<sup>th</sup> September 2016.
- 2. Out of the 292,623 closed companies, about 10,309 companies were liquidated/dissolved; 255,741 companies were defunct (and hence struck-off); 17,991 companies were amalgamated/ merged with other companies; 3,793 companies were converted to LLP; 4,780 companies were converted to LLP and dissolved. **Table-1.1** presents the summary picture of companies count as on 30<sup>th</sup> September 2016.
- 3. Out of the 1,119,712 active companies limited by shares; 1,055,847 were Private and 63,865 were Public companies, segregated into 6,735 Listed and 57,130 Unlisted Companies (**Table 1.2**).
- 4. State/UT-wise distribution of registered companies indicates that Maharashtra has the highest number of companies (319,442), followed by Delhi (294,714) and West Bengal (190,689). Similarly, amongst 'Active Companies', Maharashtra has the maximum number of active companies (234,110), followed by Delhi (211,481) and West Bengal (139,848) as on 30<sup>th</sup> September, 2016 (**Table-1.3**).
- 5. Economic-activity wise classification of active companies reveals that highest number of companies were in Business Services (315,244) followed by Manufacturing (228,198), Trading (159,785) and Construction (111,983). Business Services comprise of Information Technology, Research & Development and other business activities such as law, audit & accounts and consultancy, etc. (**Table-1.4 and Chart 1.1**).



'M&Q' is Mining & Quarrying, 'TS&C' is Transport, Storage and Communication, and 'CP&S is 'Community, Personal & Social Services'. 20,651 active companies (Others) are having invalid Economic Activity (NIC-2004) Code.

#### II. ONE PERSON COMPANY

6. Up to 30<sup>th</sup> September 2016, a total number of 8,530 One Person Companies (OPCs) were registered with collective authorized capital of Rs. 228.21 crore. Economic activity wise classification of OPCs up to 30<sup>th</sup> September 2016 reveals that the highest number of OPCs were in Business Services (5,067) followed by Community, Personal & Social Services (1050), Manufacturing (709) and Trading (666) (Chart 2.1). During the month of September 2016, a total of 397 OPC were registered with authorized capital of Rs. 9.19 crore. Economic activity wise classification of OPC during the month reveals that highest number of 286 OPCs were registered in Business Services, followed by 32 in Trading and 28 in Manufacturing (Table 2.1).


#### III. TREND OF REGISTRATION OF NEW COMPANIES AND LLPs

7. An analysis of registration of new companies during September 2013 to September 2016 indicates that monthly registration of companies has increased after hitting its lowest of 765 in April 2014 (Chart 3.1). A total of 7,923 companies were registered in September 2016 as compared to 6,268 in September 2015. A decrease (-9%) in registration of companies has been witnessed in May 2016 over the previous month. Monthly registration of LLPs has also increased over the months. A total of 7,923 LLPs were registered in September 2016 compared to 6,268 LLPs in September 2015 (Table 3.1).



# IV. REGISTRATION OF NEW COMPANIES DURING SEPTEMBER 2016

- 8. During the month of September 2016, a total of 7,923 companies were registered with collective authorized capital of Rs. 2,221.59 crore. Of them 7,880 companies were registered as Companies Limited by Shares with authorized capital of Rs. 2,221.29 crore; 43 companies were registered as Limited by Guarantees with authorized capital of Rs. 30 lakh; (**Table-4.1**).
- 9. Economic-activity wise classification of companies registered during September 2016 (**Table-4.2 and Chart 4.1**) reveals that the predominant share of companies were in Business Services (4,471) followed by Manufacturing (854), Trading (681), Construction (478) and Real Estate and Renting (349).



10. During September 2016, 1,355 (17.10%) companies were registered in Delhi, followed by 1,345(16.98%) in Maharashtra, and 734 (9.26%) in Uttar Pradesh **(Table-4.3)**.


### V. LIMITED LIABILITY PARTNERSHIPS (LLP)

11. As on 30<sup>th</sup> September 2016, a total number of 73,312 LLPs were registered in the country, of which 72,019 of them were active. About 82.29% active LLPs (59,262 in number) have obligation of contribution less than or equal to Rs. 5 lakhs each; and only about 2.93% (2,109 in number) of LLPs have obligation of contribution above Rs.1crore each (Table-5.1 and Chart 5.1)




12. Broad economic sector wise classification of active LLPs as on 30<sup>th</sup> September 2016 reveals that Service sector account for 54,593 LLPs, followed by Industry and

Agriculture sectors accounting for 16,075 and 1,344 respectively. Economic-activity wise classification of active LLPs as on 30<sup>th</sup> September 2016 reveals that a large number of LLPs are in Business Services (28,642) followed by Trading (8,877), Real Estate & Renting (8,035) and Manufacturing (8,071) (**Table-5.2 & Chart 5.2**).


13. During July 2016 to September 2016, a total of 7,030 Limited Liability Partnerships (LLPs) were registered with collective obligation of contribution of Rs. 1,093.40 crore. Economic activity wise classification of LLPs indicates that highest number of 3,013 LLPs were registered in Business Services, followed by 887 in Trading and 854 in Manufacturing (Table 6.1 and Chart 6.1).

# VI. FOREIGN COMPANIES

14. As on 30<sup>th</sup> September 2016, a total of 4,433 foreign companies were doing business in India, of which 3,339 of them were active. During July to September 2016, a total of 32 companies foreign companies were registered in India including 10 in Delhi (31.25%) followed by Maharashtra with 8 (25%) and Haryana with 5 (15.63%) (**Table 6.2**). Economic activity wise classification of foreign companies reveals that highest number of 21 were registered in Business Services, followed by 4 in Manufacturing and 2 each in Community, Personal & Social Services and Mining & Quarrying.
