HIGHLIGHTS

I. REGISTERED COMPANIES AS ON 31st AUGUST, 2019

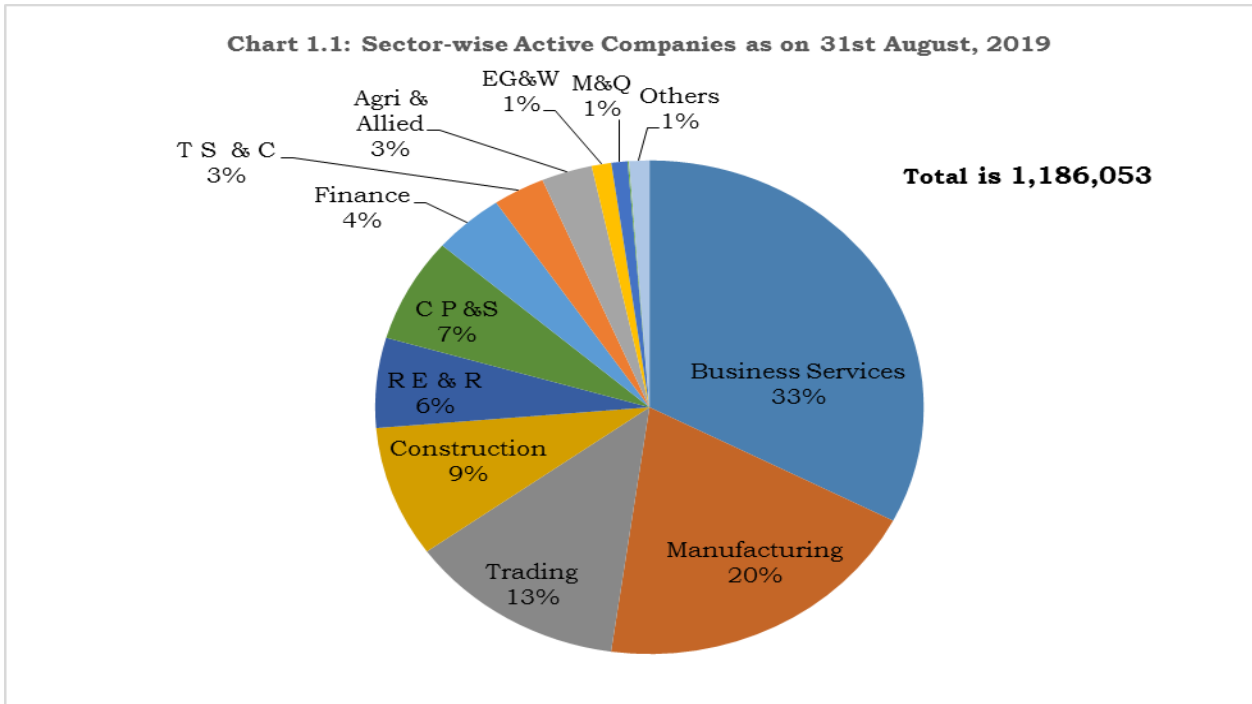
The total number of companies registered in the country as on 31st August, 2019 stood at 1,924,638. Of them 686,924 companies were closed. 2,054 companies were assigned dormant status as per the Companies Act, 2013; 6,426 were under liquidation; 43,108 companies were in the process of being struck-off. After being struck off previously, 73 Companies were in the process of being re-activated. Taking the above into account, there were 1,186,053 active companies as on 31st August, 2019.

1. Out of the 686,924 closed companies, 10,813 companies were liquidated/dissolved; 635,131 companies were declared defunct (and hence struck-off after issuance of notice u/s 248). 23,756 companies were amalgamated/ merged with other companies; 12,350 companies were converted to Limited Liability Partnership (LLP) and 4,874 were converted to LLP and dissolved. **Table-1.1** presents the summary picture of companies count as on 31st August, 2019.

2. Out of the 1,186,053 active companies, 1,178,638 were limited by shares; 7,103 were limited by guarantee and 312 were unlimited companies. Out of the companies limited by shares, 64,110 were public, 1,114,528 were private including 25,503 one person companies. Among the public limited companies, 6,860 were listed (**Table 1.2**).

3. State/UT-wise distribution of registered companies indicates that Maharashtra has the highest number of companies (380,591), followed by Delhi (339,506) and West Bengal (203,986). Amongst 'Active Companies', Maharashtra has the maximum number of active companies (229,554), followed by Delhi (205,370) and West Bengal (128,996) as on 31st August, 2019. (**Table-1.3**).

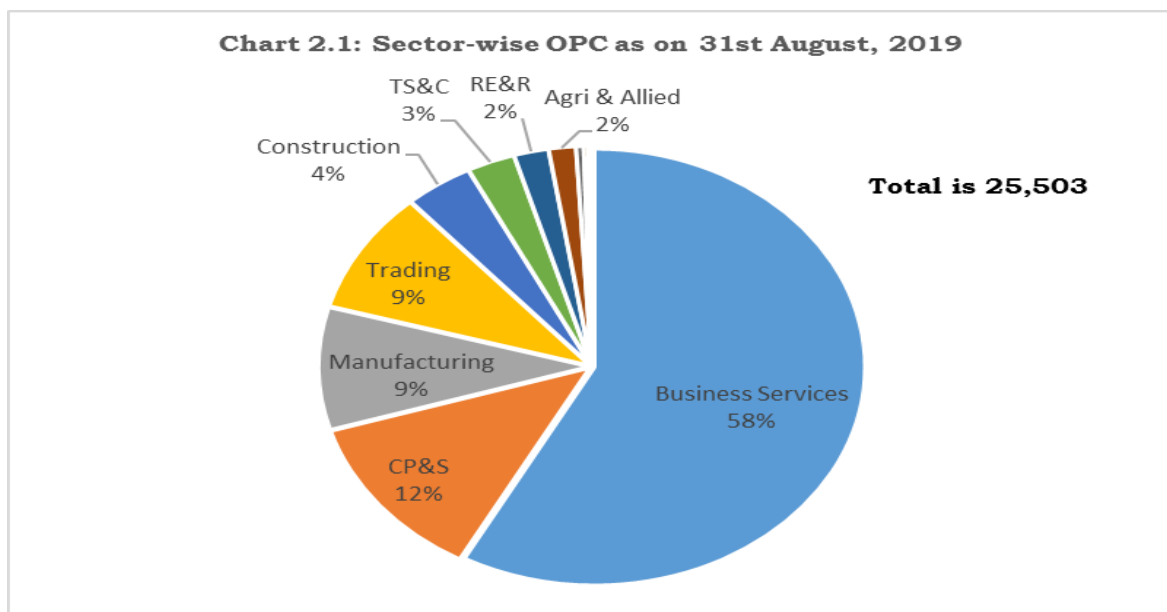
4. Economic-activity wise classification of active companies reveals that highest number of companies were in Business Services (386,629) followed by Manufacturing (232,932), Trading (152,157) and Construction (101,855). Business Services comprise of Information Technology, Research & Development and other business activities such as law, audit & accounts and consultancy, etc. (**Table-1.4 and Chart 1.1**).



'M&Q' is Mining & Quarrying, 'TS&C' is Transport, Storage and Communication, and 'CP&S' is Community, Personal & Social Services, 'RE&R' is Real Estate and Renting, 'EG&W', is Electricity Gas & Water. 14,136 active companies (Others) are having invalid Economic Activity (NIC-2004) Code.

II. ONE PERSON COMPANY

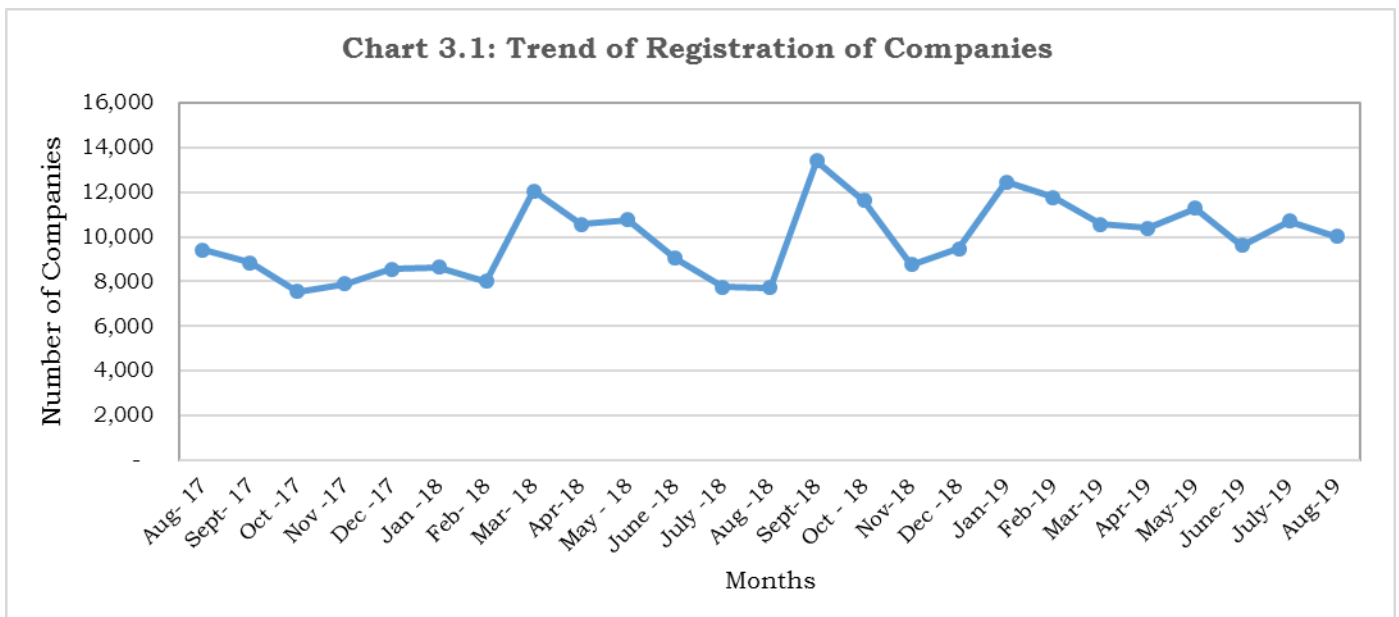
5. Up to 31st August, 2019, a total number of 25,503 One Person Companies (OPCs) were registered with collective authorized capital of Rs. 731.12 crore. Economic activity wise classification of OPCs up to 31st August reveals that the highest number of OPCs were in Business Services (14,786) followed by Community, Personal & Social Services (3,148), Trading (2,314) and Manufacturing (2,312) (**Chart 2.1**). During the month of August, 2019, a total of 653 OPC were registered with authorized capital of Rs. 22.70 crore. Economic activity wise classification of OPC during the month reveals that highest number of 223 OPCs were registered in Business Services, followed by 130 in Trading, 103 in Community, personal & Social Services and 99 in Manufacturing. (**Table 2.1**).



'TS&C' is Transport, Storage and Communication, 'CP&S' is 'Community, personal & Social Services', 'RE&R' is Real Estate and Renting.

III. TREND OF REGISTRATION OF NEW COMPANIES

6. An analysis of registration of new companies during August 2017 to August 2019 indicates that monthly registration of companies has increased after hitting lowest of 7,556 Companies in October 2017 (**Chart 3.1**). A total of 10,004 companies were registered in August, 2019 as compared to 7,740 in August 2018. A decrease (6.50%) in registration of companies has been witnessed in August 2019 over the previous month (**Table 3.1**).

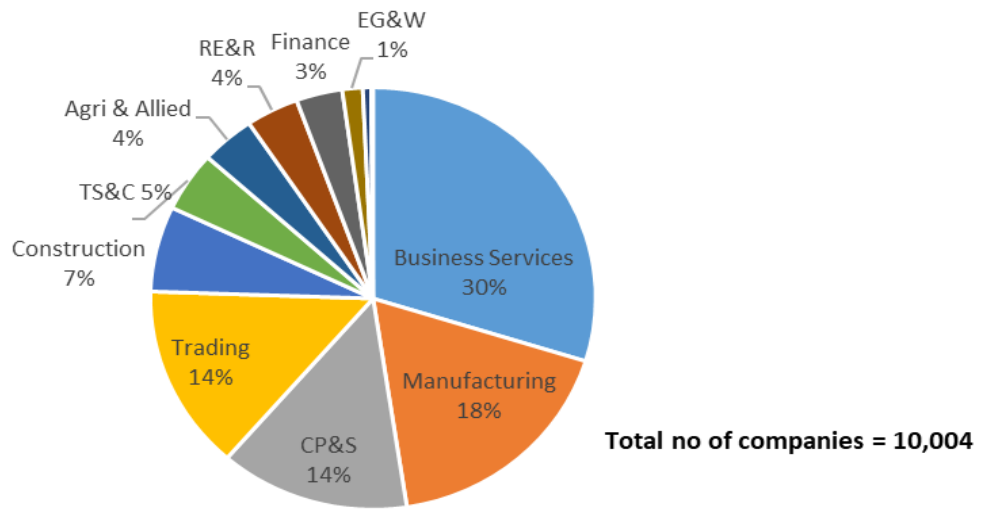


IV. REGISTRATION OF NEW COMPANIES DURING AUGUST, 2019

7. During the month of August, 2019, a total of 10,004 companies were registered with collective authorized capital of Rs. 1599.68 crore. Of them 9,949 companies were registered as Companies Limited by Shares with authorized capital of Rs. 1599.68 crore; (**Table-4.1**).

8. Economic-activity wise classification of companies registered during August 2019 (**Table-4.2 and Chart 4.1**) reveals that the predominant share of companies is in Business Services (2,981) followed by Manufacturing (1,778), Trading (1,416) Community, personal & Social Services (1,381), and Construction (655).

9. During August 2019, 1,911 (19.10%) companies were registered in Maharashtra, followed by 1,215 (12.15%) in Delhi, and 969 (9.69%) in Uttar Pradesh (**Table-4.3**).
