HIGHLIGHTS

I. REGISTERED COMPANIES AS ON 31st DECEMBER 2017

1. The total number of companies registered in the country as on 31st December 2017, stood at 1,720,682. Of them 537,556 companies were closed; 1,155 companies were assigned dormant status as per the Companies Act, 2013; 3 companies have not filed their annual statutory annual filing for 2 years consecutively; 5,976 were under liquidation; 32,109 companies were in the process of being struck-off and 111 companies were in the process of being re-activated. Taking the above into account, there were 1,143,772 active companies as on 31st December 2017.

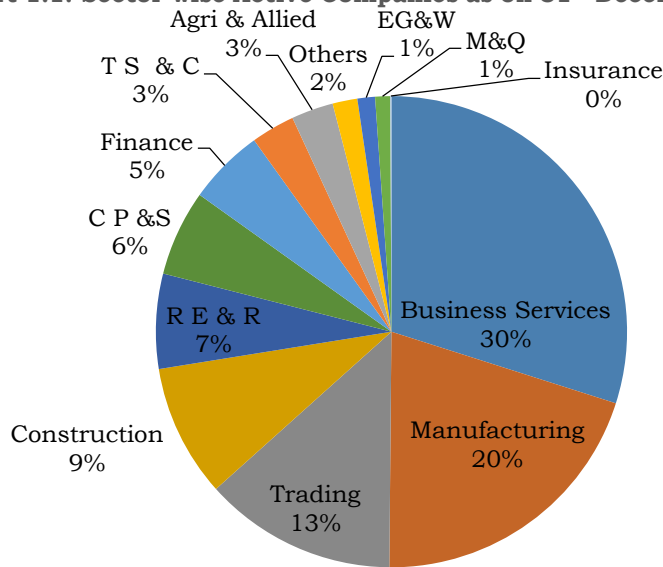
2. Out of the 537,556 closed companies, about 10,480 companies were liquidated/dissolved; 494,932 companies were defunct (and hence struck-off); 20,265 companies were amalgamated/ merged with other companies; 7,085 companies were converted to LLP and 4,794 were converted to LLP and dissolved. **Table-1.1** presents the summary picture of companies count as on 31st December 2017.

3. Out of the 1,135,939 active companies limited by shares; 1,065,030 were Private and 70,909 were Public companies, segregated into 7,258 Listed and 63,651 Unlisted Companies (**Table 1.2**).

4. State/UT-wise distribution of registered companies indicates that Maharashtra has the highest number of companies (342,452), followed by Delhi (314,168) and West Bengal (195,613). Similarly, amongst 'Active Companies', Maharashtra has the maximum number of active companies (225,560), followed by Delhi (209,882) and West Bengal (134,548) as on 31st December 2017 (**Table-1.3**).

5. Economic-activity wise classification of active companies reveals that highest number of companies were in Business Services (342,144) followed by Manufacturing (231,356), Trading (151,297) and Construction (104,038). Business Services comprise of Information Technology, Research & Development and other business activities (such as law, audit & accounts and consultancy, etc. (**Table-1.4 and Chart 1.1**).

Chart 1.1: Sector-wise Active Companies as on 31st December 2017



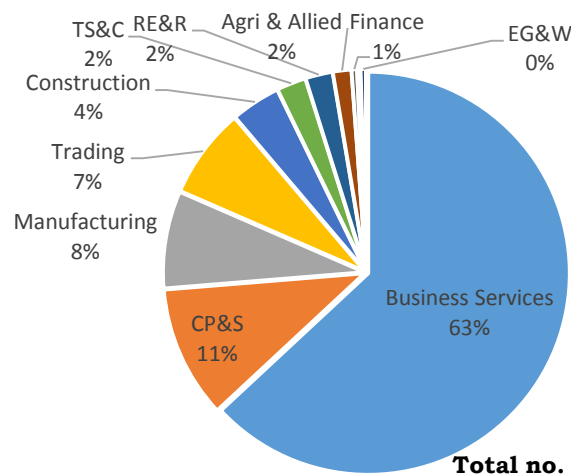

II. ONE PERSON COMPANY

6. Up to 31st December 2017, a total number of 15,239 One Person Companies (OPCs) were registered with collective authorized capital of Rs. 392.97 crore. Economic activity wise classification of OPCs up to 31st December 2017 reveals that the highest number of OPCs were in Business Services (9,611) followed by Community, Personal & Social Services (1,620), Manufacturing (1,192) and Trading (1,109) (**Chart 2.1**). During the month of December 2017, a total of 477 OPC were registered with authorized capital of Rs. 10.92 crore. Economic activity wise classification of OPC during the month reveals that highest number of 331 OPCs were registered in Business Services, followed by 43 in Community, personal & Social Services and 40 in Manufacturing (**Table 2.1**).

Chart 2.1: Sector-wise OPC as on 31st December 2017

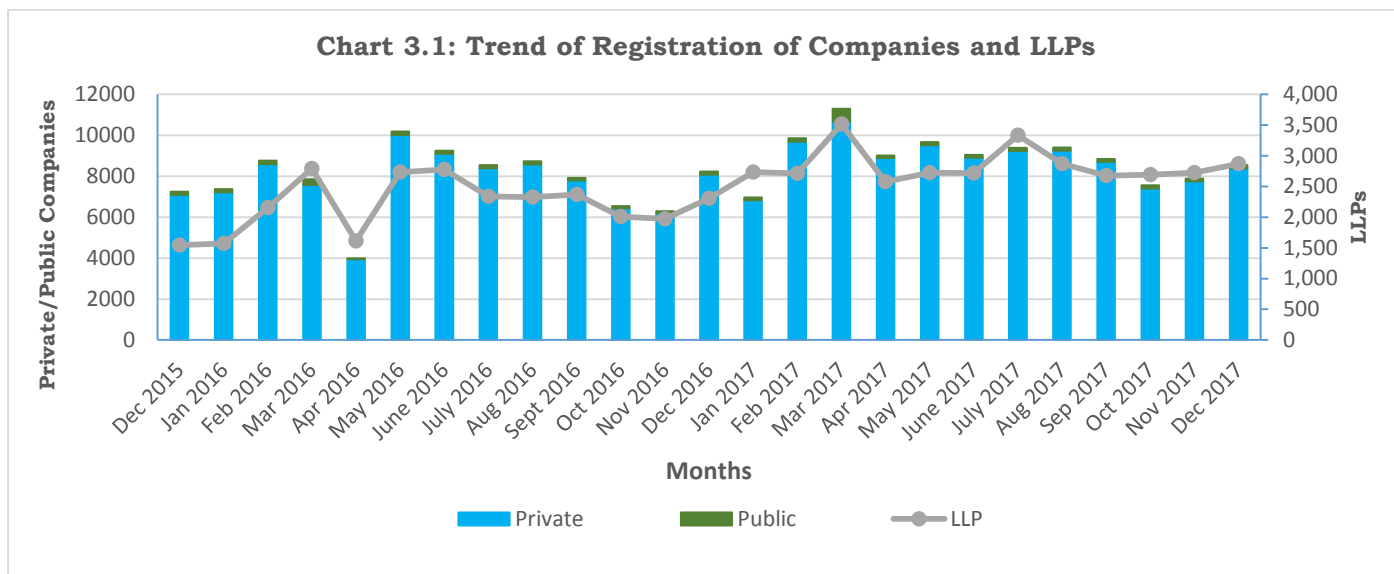

III. TREND OF REGISTRATION OF NEW COMPANIES

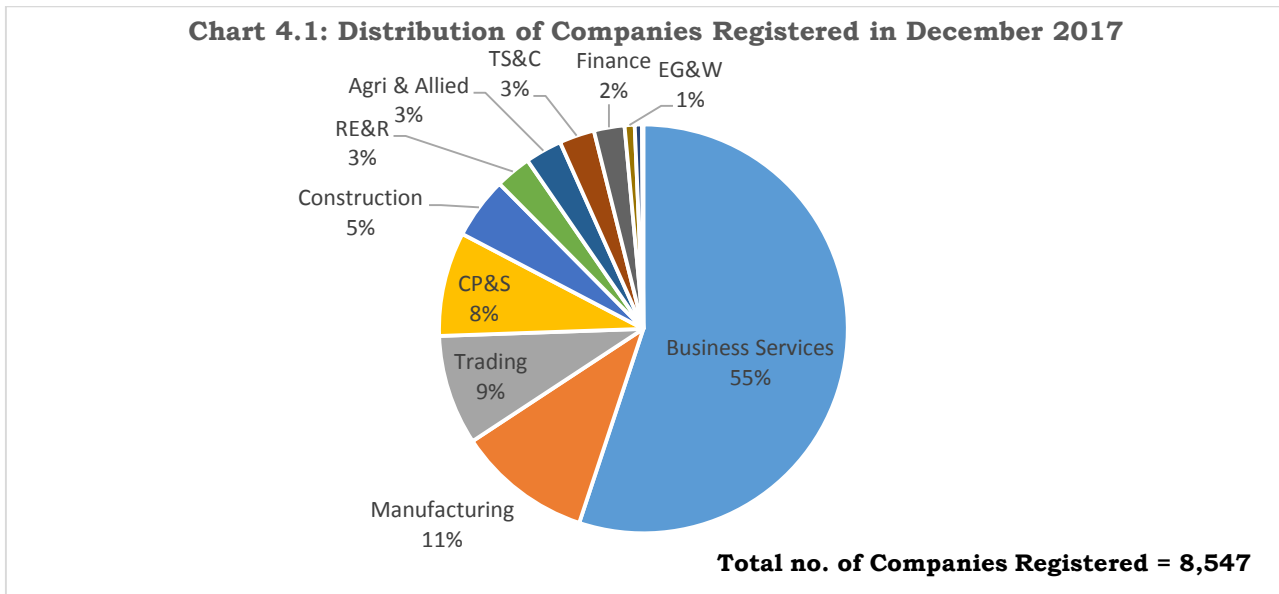
7. An analysis of registration of new companies during December 2015 to December 2017 indicates that monthly registration of companies has increased after hitting lowest of 3,994 Companies in April 2016 (**Chart 3.1**). A total of 8,547 companies were registered in December 2017 as compared to 8,232 in December 2016. An increase (8.40%) in registration of companies has been witnessed in December 2017 over the previous month. A total of 2,870 LLPs were registered in December 2017 as compared to 2,308 LLPs in December 2016 (**Table 3.1**).



IV. REGISTRATION OF NEW COMPANIES DURING DECEMBER 2017

8. During the month of December 2017 a total of 8,547 companies were registered with collective authorized capital of Rs. 4,238.19 crores. Of them 8,520 companies were registered as Companies Limited by Shares with authorized capital of Rs. 4,238.18 crores; 27 companies were registered as Limited by Guarantees with authorized capital of Rs. 1 lakh (**Table-4.1**).

9. Economic-activity wise classification of companies registered during December 2017 (**Table-4.2 and Chart 4.1**) reveals that the predominant share of companies is in Business Services (4,708) followed by Manufacturing (911), Trading (744), Community, personal & Social Services (704) and Construction (417).

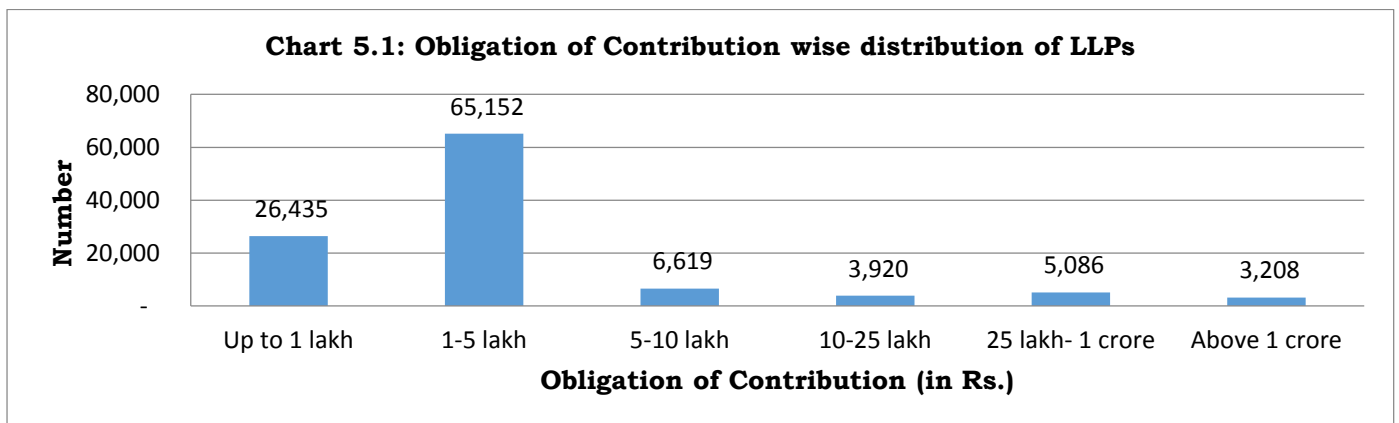

10. During December 2017, 1,547 (18.10%) companies were registered in Maharashtra, followed by 1,165 (13.63%) in Delhi, and 792 (9.27%) in Uttar Pradesh (**Table-4.3**).

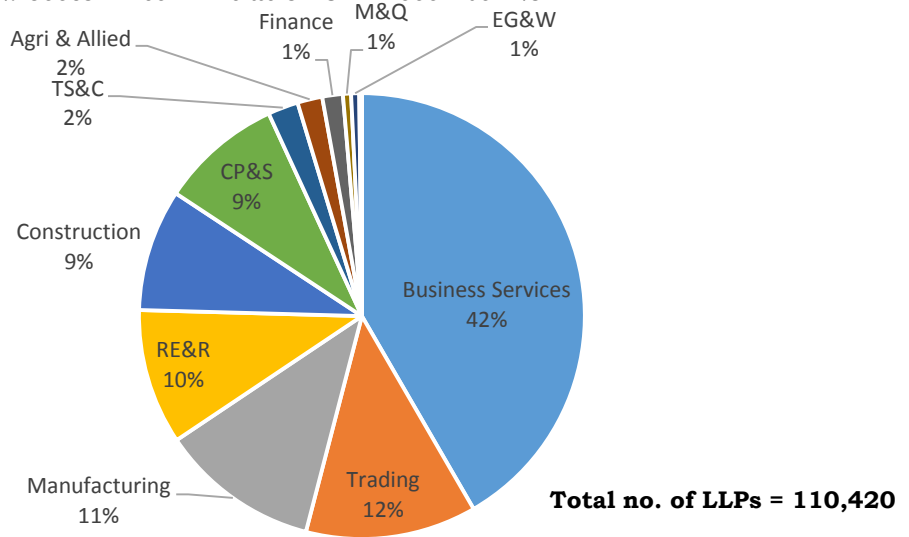
V. Limited Liability Partnerships (LLPs)

11. As on 31st December 2017, a total number of 110,420 LLPs were active in the country. About 82.94% active LLPs (91,587 in number) have obligation of contribution less than or equal to Rs. 5 lakhs each; and only about 2.91% (3,208 in number) of LLPs have obligation of contribution above Rs.1 crore each (**Table-5.1 and Chart 5.1**)



12. Broad economic sector wise classification of active LLPs as on 31st December 2017 reveals that Service sector account for 84,589 LLPs, followed by Industry and Agriculture sectors accounting for 23,836 and 1,993 respectively. Economic-activity wise classification of active LLPs as on 31st December 2017 reveals that a large number of LLPs are in Business Services (45,979) followed by Trading (13,696), Manufacturing (12,770) and Real Estate & Renting (10,850) (**Table-5.2 & Chart 5.2**).

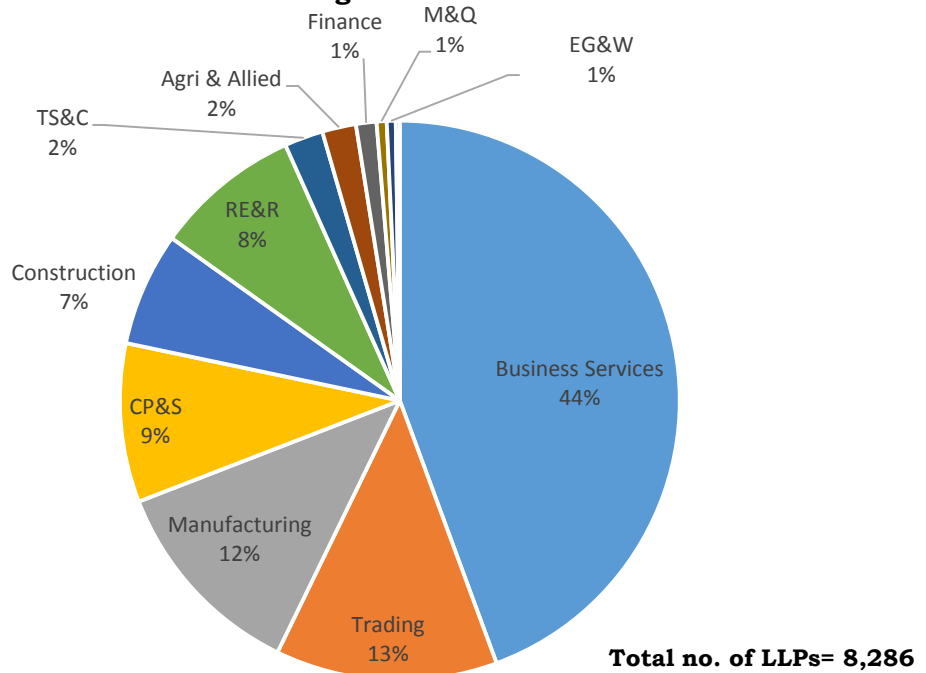
Chart 5.2: Sector wise LLP's as on 31st December 2017

13. During October 2017 to December 2017, a total of 8,286 Limited Liability Partnerships (LLPs) were registered with collective obligation of contribution of Rs. 1,219.97 crores. Economic activity wise classification of LLPs during October to December 2017 indicates that highest number of 3,677 LLPs were registered in Business Services followed by 1,062 in Trading, 988 in Manufacturing and 760 in Community, Personal and Social Services (**Table 5.3 and Chart 5.3**).

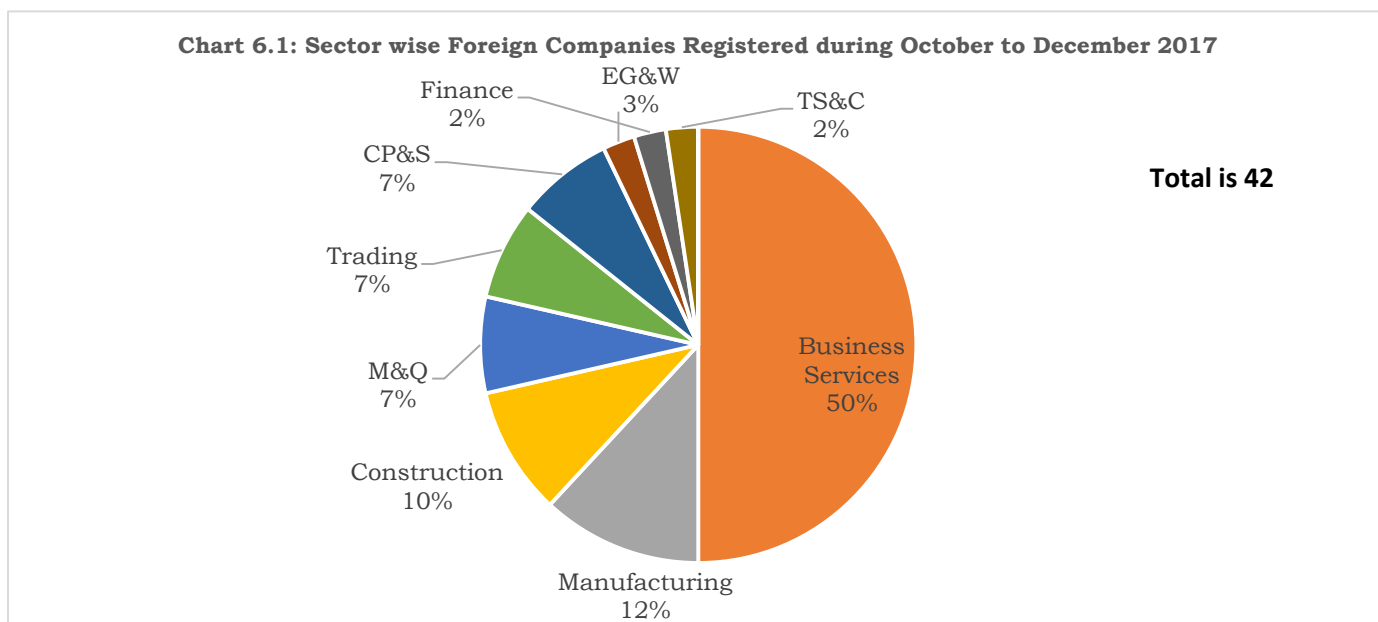
Chart 5.3: Sector-wise LLPs during October to December 2017

VI. FOREIGN COMPANIES

14. As on 31st December 2017, a total of 4,625 foreign companies were registered in India, of which 3,380 of them were active. During October 2017 to December 2017, a total of 42 foreign companies were registered in India including 12 in Maharashtra (28.57%) followed by 8 (19.04%) in Delhi and 8 (19.04%) in Haryana. Economic activity wise classification of foreign companies reveals that highest number of 21 were registered in Business Services followed by 5 in Manufacturing, 4 in Construction. **(Table 6.1 and chart 6.1).**
