HIGHLIGHTS

I. REGISTERED COMPANIES AS ON 28th FEBRUARY 2018


1. The total number of companies registered in the country as on 28th February 2018, stood at 1,737,253. Of them 539,202 companies were closed; 1,204 companies were assigned dormant status as per the Companies Act, 2013; 3 companies have not filed their statutory annual filings consecutively for last two years; 5,989 companies were under liquidation; 33,274 companies were in the process of being struck-off and 111 companies were in the process of being re-activated. Taking the above into account, there were 1,157,470 active companies as on 28th February, 2018.

2. Out of the 5,39,202 closed companies, about 10,501 companies were liquidated/dissolved; 4,95,711 companies were defunct (and hence struck-off); 20,613 companies were amalgamated/ merged with other companies; 7,583 companies were converted to LLP and 4,794 companies were converted to LLP and dissolved. **Table-1.1** presents the summary picture of companies count as on 28th February, 2018.

3. Out of the 1,149,594 active companies limited by shares; 1,078,465 were Private and 71,129 were Public companies, segregated into 7,242 Listed and 63,887 Unlisted Companies (**Table 1.2**).

4. State/UT-wise distribution of registered companies indicates that Maharashtra has the highest number of companies (345,655), followed by Delhi (316,437) and West Bengal (196,219). Similarly, amongst 'Active Companies', Maharashtra has the maximum number of active companies (228,148), followed by Delhi (211,610) and West Bengal (134,648) as on 28th February, 2018 (**Table-1.3**).


5. Economic-activity wise classification of active companies reveals that highest number of companies were in Business Services (350,386) followed by Manufacturing (232,665), Trading (152,187) and Construction (104,687). Business Services comprise of Information Technology, Research & Development and other business activities (such as law, audit & accounts and consultancy, etc.) (**Table-1.4 and Chart 1.1**).



'M&Q' is Mining & Quarrying, 'TS&C' is Transport, Storage and Communication, and 'CP&S is 'Community, Personal & Social Services', 'RE&R' is Real Estate and Renting. 19,426 active companies (Others) are having invalid Economic Activity (NIC-2004) Code.

II. ONE PERSON COMPANY


6. Up to 28th February, 2018, a total number of 16,126 One Person Companies (OPCs) were registered with collective authorized capital of Rs. 402.03 crore. Economic activity wise classification of OPCs up to 28th February, 2018 reveals that the highest number of OPCs were in Business Services (10,218) followed by Community, Personal & Social Services (1,698), Manufacturing (1,263) and Trading (1,166) (Chart 2.1). During the month of February 2018, a total of 440 OPC were registered with authorized capital of Rs. 11.05 crore. Economic activity wise classification of OPCs were registered in Business Services that highest number of 308 OPCs were registered in Business Services, followed by 34 in Community, Personal & Social Services and 32 in Manufacturing (Table 2.1).



'TS&C' is Transport, Storage and Communication, 'CP&S' is 'Community, personal & Social Services', 'RE&R' is Real Estate and Renting.

III. TREND OF REGISTRATION OF NEW COMPANIES


7. An analysis of registration of new companies during February 2016 to February 2018 indicates that monthly registration of companies has increased after hitting its lowest of 3,994 in April 2016 (**Chart 3.1**). A total of 8,011 companies were registered in February 2018 as compared to 9,863 in February 2017. A decrease (7.41%) in registration of companies has been witnessed in February 2018 over the previous month (**Table 3.1**).



IV. REGISTRATION OF NEW COMPANIES DURING FEBRUARY 2018

8. During the month of February 2018 a total of 8,011 companies were registered with collective authorized capital of Rs. 6,677.47 crores. Of them 7,993 companies were registered as Companies Limited by Shares with authorized capital of Rs. 6,677.47 crores; 18 companies were registered as Limited by Guarantees with authorized capital of Rs.0 crore (**Table-4.1**).

9. Economic-activity wise classification of companies registered during February 2018 (**Table-4.2 and Chart 4.1**) reveals that the predominant share of companies were in Business Services (4,444) followed by Manufacturing (901), Community, Personal & Social Services (640), Trading (638) and Construction (446).



'EG&W' is Electricity, Gas and Water, 'TS&C' is Transport, Storage and Communication, 'CP&S' is Community, personal & Social Services, 'RE&R' is Real Estate and Renting.

10. During February 2017, 1,481 (18.49%) companies were registered in Maharashtra, followed by 1,103 (13.77%) in Delhi, and 818 (10.21%) in Uttar Pradesh **(Table-4.3)**.

annual filings. During this period the status of company remains Active in Progress.
Under Section 248 of the Companies Act, 2013 Registrar of Companies is empowered to strike off the names of defunct companies. This is different from liquidation of Companies (either by Tribunal or Voluntary).
