

HIGHLIGHTS

I. REGISTERED COMPANIES AS ON 31st MARCH 2019


- 1. The total number of companies registered in the country as on 31st March 2019, stood at 1,873,044. Of them 670,018 companies were closed; 1,615 companies were assigned dormant status as per the Companies Act, 2013; 6,327 companies were under liquidation; 38,610 companies were in the process of being struck-off. After being struck off previously, 100 companies were in the process of being re-activated. Taking the above into account, there were 1,156,374 active companies as on 31st March 2019.
- 2. Out of the 670,018 closed companies, 10,640 companies were liquidated/dissolved; 621,966 companies were defunct (and hence struck-off); 22,532 companies were amalgamated/merged with other companies; 10,086 companies were converted to LLP; 4,794 companies were converted to LLP and dissolved. **Table-1.1** presents the summary picture of companies count as on 31st March 2019.
- 3. Out of the 1,156,374 active companies, 1,149,167 were limited by shares; 6,890 were limited by guarantee and 317 were unlimited Companies. Out of the Companies limited by shares, 63,989 were public, 1,085,178 were private including 22,760 one person Companies. Among the public Companies, 6,915 were listed. (**Table 1.2**).
- 4. Authorized Capital wise distribution of active companies as on 31st March, 2019 (**Table-1.3**) indicates that about 67.31% of companies (778,345 in number) have authorized capital less than or equal to Rs.10 lakh each and about 2.36% of companies (27,352 in number) have authorized capital of above Rs.10 crore each.
- 5. State/UT-wise distribution of registered companies indicates that Maharashtra has the highest number of companies (370,986), followed by Delhi (333,733) and West Bengal (201,792). Similarly, amongst 'Active Companies', Maharashtra has the maximum number of active companies (223,259), followed by Delhi (204,143) and West Bengal (129,514) as on 31st March, 2019. (**Table-1.4**).
- 6. Economic-activity wise classification of active companies reveals that highest number of companies were in Business Services (378,205) followed by Manufacturing (227,260), Trading (148,446) and Construction (100,258). Business Services comprise of Information Technology, Research & Development and other business activities (such as law, audit & accounts and consultancy, etc.) (**Table-1.5 and Chart 1.1**).



'M&Q' is Mining & Quarrying, 'TS&C' is Transport, Storage and Communication, and 'CP&S is 'Community, Personal & Social Services', 'RE&R' is Real Estate and Renting. 19,407 active companies (Others) are having invalid Economic Activity (NIC-2004) Code.

II. ONE PERSON COMPANY


- 7. Up to 31st March 2019, a total number of 22,760 One Person Companies (OPCs) were registered with collective authorized capital of Rs. 622.57 crore. Economic activity wise classification of OPCs up to 31st March 2019 reveals that the highest number of OPCs were in Business Services (13,884) followed by Community, Personal & Social Services (2,681), Manufacturing (1,859) and Trading (1,799) (Chart 2.1). During the financial year 2018-19 (i.e. from 1st April 2018 to 31st March 2019), a total of 6,602 OPCs were registered in India. Maharashtra has registered 1,150 (17.42%) OPCs followed by Karnataka with 774 (11.72%) (Table 7.2). Economic activity wise classification of OPC reveals that highest number of 3,586 were registered in Business Services, followed by 1000 in Community, Personal & Social Services and 638 in Trading. (Table 2.1).
- 8. During the month of March 2019, a total of 600 OPCs were registered with authorized capital of Rs. 19.32 crore. Economic activity wise classification of OPC during the month reveals that highest number of 273 OPCs were registered in Business Services, followed by 110 in Community, Personal & Social Services and 71 in Trading (**Table 2.1**). Highest number of 102 OPCs were registered in Maharashtra (17%), 70 in Uttar Pradesh (11.67%) and 58 in Delhi (9.67%) and Karnataka (9.67%) each during the month of March 2019. (**Table-7.2**).

III. REGISTRATION OF COMPANIES DURING FY 2018-19


- 9. During the financial year 2018-19 (i.e., from 1st April, 2018 to 31st March, 2019), a total of 123,938 companies were registered with collective authorized capital of Rs. 84,051.46 crore. Of them 123,476 Companies were registered as Companies Limited by Shares with authorized capital of Rs. 84,050.76 crore; 462 Companies Limited by Guarantees with authorized capital of Rs. 0.70 crore. (**Table-3.1**).
- 10. During the financial year 2018-19, Maharashtra had 23,022 (18.57%) newly registered companies, followed by Delhi with 15,928 (12.85%) and Uttar Pradesh with 12,403 (10.01%) companies (**Table-3.2**).
- 11. Economic-activity wise classification of companies registered during financial year 2018-19, (**Table-3.3 and Chart 3.1**) reveals that the predominant share of companies were in Business Services (56,636) followed by Manufacturing (15,860), Community, Personal & Social Services (13,726) and Trading (12,155).

IV. REGISTRATION OF NEW COMPANIES DURING MARCH 2019


- 12. During the month of March 2019 a total of 10,570 companies were registered with collective authorized capital of Rs. 5,350.67 crore. Of them 10,523 companies were registered as Companies Limited by Shares with authorized capital of Rs. 5,350.61 crore; 47 companies were registered as Limited by Guarantees with Rs. 0.05 Crore authorized capital; (**Table-4.1**).
- 13. Economic-activity wise classification of companies registered during March, 2019 (**Table-4.2 and Chart 4.1**) reveals that the predominant share of companies were in Business Services (4,198) followed by Manufacturing (1,484), Community, Personal & Social Services (1,243), Trading (1,155) and Construction (661).



14. During March 2019, 1,960 (18.54%) companies were registered in Maharashtra, followed by 1,259 (11.91%) in Delhi, and 1,037 (9.81%) in Uttar Pradesh (**Table-4.3**).


V. TREND OF REGISTRATION OF NEW COMPANIES AND LLPs

15. An analysis of registration of new companies during March 2017 to March, 2019 indicates that monthly registration of companies has increased after hitting its lowest of 7,556 in October,2017 (**Chart 5.1**). A total of 10,570 companies were registered in March 2019 as compared to 12,039 in March 2018. A decrease (10.24%) in registration of companies has been witnessed in March 2019 over the previous month. A total of 3,056 LLPs were registered in March 2019 as compared to 2,019 in March 2018 (**Table 5.1**).




VI. Limited Liability Partnerships (LLP)

16. As on 31st March, 2019 a total number of 145,186 LLPs were registered in the country, of which 131,331 were active. About 82.18% active LLPs (107,924 in number) have obligation of contribution less than or equal to Rs. 5 lakh each; and only about 3.21% (4,218 in number) of LLPs have obligation of contribution above Rs.1 crore each (**Table-6.1 and Chart 6.1**)




17. Broad economic sector wise classification of active LLPs as on 31st March 2019 reveals that Service sector account for 100,477 LLPs, followed by Industry and Agriculture sectors accounting for 28,395 and 2,458 respectively. Economicactivity wise classification of active LLPs as on 31st March 2019 reveals that a large number of LLPs were in Business Services (53,596) followed by Trading (16,843), Manufacturing (15,443) and Real Estate & Renting (13,188) (**Table-6.2 & Chart 6.2**).

VII. Registration of LLPs during FY 2018-19:

18. During the financial year 2018-19 (i.e., from 1st April 2018 to 31st March 2019) a total of 23,748 Limited Liability Partnerships (LLPs) were registered with collective obligation of contribution of Rs. 14,159.26 crore. Economic activity wise classification of LLPs during the financial year 2018-19 indicates that highest number of 9,205 LLPs were registered in Business Services, followed by 3,385 in Trading and 2,797 in Manufacturing (**Table 6.3 & Chart 6.3**).



19. Maharashtra has 7,266 (30.60 %) newly LLPs registered, followed by Delhi with 3,066 (12.91 %), and Gujarat with 2,237 (9.42 %) during Financial Year 2018-19 (**Table 7.2**).

VIII. Registration of LLPs during March 2019:


20. A total of 3,056 Limited Liability Partnerships (LLPs) were registered during March 2019 with collective obligation of contribution of Rs. 677.06 crore. Economic activity wise classification of LLPs during the month reveals that highest number of 1,186 LLPs were registered in Business Services, followed by 545 in Trading and 366 in Community, Personal & Social services (**Table-6.4 and Chart 6.4**). Highest number of 898 LLPs were registered in Maharashtra (28.63%) followed by 344 in Delhi (14.71%) during the month of March 2019 (**Table-7.2**).

IX. Foreign Companies

21. As on 31st March 2019, a total of 4,771 foreign companies were doing business in India, of which 3,376 were active. During the financial year 2018-19, a total of 118 foreign companies were registered in India including 43 (36.44%) in Maharashtra followed by 25 (21.19 %) in Delhi and 18 in Haryana (15.25%) (**Table 7.2**). Economic activity wise classification of foreign companies reveals that highest number of 66 were registered in Business Services, followed by 12 in Manufacturing and 10 in Transport Storage and Communication (**Table 7.1 and Chart 7.1**).

22. During the month of March 2019, 20 foreign companies were registered in India with 6 in Maharashtra, 4 each in Delhi and Haryana (**Table 7.2**). Of these 20 foreign companies, 8 were registered under Business Services, 3 under Manufacturing and 2 each under Agriculture & Allied, Community, Personal & Social Services and Trading.
