

HIGHLIGHTS

I. REGISTERED COMPANIES AS ON 31st OCTOBER 2017


- 1. The total number of companies registered in the country as on 31st October 2017, stood at 17,04,319. Of them 5,34,674 companies were closed; 1,123 companies were assigned dormant status as per the Companies Act, 2013; 3 companies have not filed their statutory annual filings consecutively for last two years; 5,957 companies were under liquidation; 31,666 companies were in the process of being struck-off and 112 companies were in the process of being re-activated. Taking the above into account, there were 11,30,784 active companies as on 31st October, 2017.
- 2. Out of the 5,34,674 closed companies, about 10,443 companies were liquidated/dissolved; 4,92,735 companies were defunct (and hence struck-off); 19,984 companies were amalgamated/ merged with other companies; 6,719 companies were converted to LLP and 4,793 companies were converted to LLP and dissolved. **Table-1.1** presents the summary picture of companies count as on 31st October, 2017.
- 3. Out of the 11,22,990 active companies limited by shares; 10,52,258 were Private and 70,732 were Public companies, segregated into 7,277 Listed and 63,455 Unlisted Companies (**Table 1.2**).
- 4. State/UT-wise distribution of registered companies indicates that Maharashtra has the highest number of companies (3,39,507), followed by Delhi (3,11,976) and West Bengal (1,94,938). Similarly, amongst 'Active Companies', Maharashtra has the maximum number of active companies (2,23,202), followed by Delhi (2,08,363) and West Bengal (1,34,239) as on 31st October, 2017 (**Table-1.3**).
- 5. Economic-activity wise classification of active companies reveals that highest number of companies were in Business Services (3,34,329) followed by Manufacturing (2,30,168), Trading (1,50,473) and Construction (1,03,450). Business Services comprise of Information Technology, Research & Development and other business activities such as law, audit & accounts and consultancy, etc. (**Table-1.4 and Chart 1.1**).



'M&Q' is Mining & Quarrying, 'TS&C' is Transport, Storage and Communication, and 'CP&S is 'Community, Personal & Social Services', 'RE&R' is Real Estate and Renting. 19,492 active companies (Others) are having invalid Economic Activity (NIC-2004) Code.

II. ONE PERSON COMPANY


6. Up to 31st October, 2017, a total number of 14,373 One Person Companies (OPCs) were registered with collective authorized capital of Rs. 365.65 crore. Economic activity wise classification of OPCs up to 31st October, 2017 reveals that the highest number of OPCs were in Business Services (8,982) followed by Community, Personal & Social Services (1,551), Manufacturing (1,130) and Trading (1,069) (Chart 2.1). During the month of October 2017, a total of 463 OPC were registered with authorized capital of Rs. 9.41 crore. Economic activity wise classification of OPC during the month reveals that highest number of 328 OPCs were registered in Business Services, followed by 38 in Community, Personal & Social Services and 31 in Manufacturing (Table 2.1).



'TS&C' is Transport, Storage and Communication, 'CP&S' is 'Community, personal & Social Services', 'RE&R' is Real Estate and Renting.


III. TREND OF REGISTRATION OF NEW COMPANIES

7. An analysis of registration of new companies during October 2015 to October 2017 indicates that monthly registration of companies has increased after hitting its lowest of 3,994 in April 2016 (Chart 3.1). A total of 7,556 companies were registered in October 2017 as companied to 6,542 in October 2016. A decrease (-14.61%) in registration of companies has been witnessed in October 2017 over the previous month (Table 3.1).



IV. REGISTRATION OF NEW COMPANIES URING OCTOBER 2017

- 8. During the month of October 2017 a total of 7,556 companies were registered with collective authorized capital of Rs. 1,394.61 crores. Of them 7,524 companies were registered as Companies Limited by Shares with authorized capital of Rs. 1,394.09 crores; 32 companies were registered as Limited by Guarantees with authorized capital of Rs.52.00 lakhs (**Table-4.1**).
- 9. Economic-activity wise classification of companies registered during October 2017 (**Table-4.2 and Chart 4.1**) reveals that the predominant share of companies was in Business Services (4,242) followed by Manufacturing (805), Trading (595), Community, Personal & Social Services (589) and Construction (404).



'EG&W' is Electricity, Gas and Water, 'TS&C' is Transport, Storage and Communication, 'CP&S' is Community, personal & Social Services, 'RE&R' is Real Estate and Renting.

10. During October 2017, 1,413 (18.70%) companies were registered in Maharashtra, followed by 1,079 (14.28%) in Delhi, and 758 (10.03%) in Uttar Pradesh (**Table-4.3**).

2. Under Section 248 of the Companies Act, 2013 Registrar of Companies is empowered to strike off the names of defunct companies. This is different from liquidation of Companies (either by Tribunal or Voluntary).
