HIGHLIGHTS

I. REGISTERED COMPANIES AS ON 30th SEPTEMBER 2017

1. The total number of companies registered in the country as on 30th September 2017, stood at 1,696,792. Of them 532,063 companies were closed; 1,107 companies were assigned dormant status as per the Companies Act, 2013; 3 companies have not filed their annual statutory annual filing for 2 years consecutively; 5,947 were under liquidation; 30,859 companies were in the process of being struck-off and 113 companies were in the process of being re-activated. Taking the above into account, there were 1,126,700 active companies as on 30th September 2017.

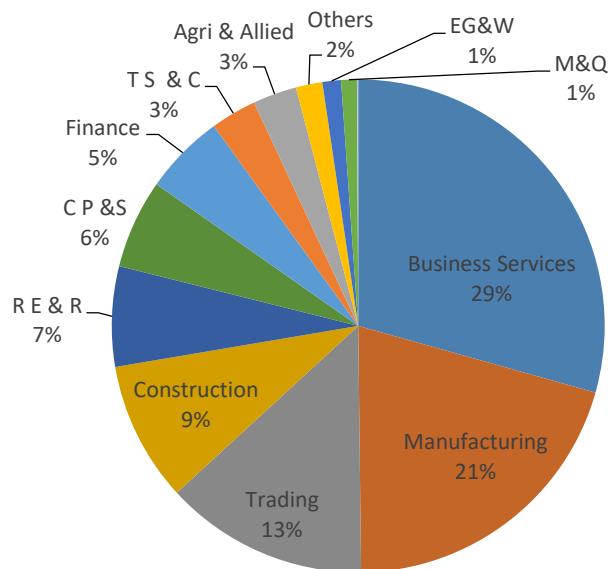
2. Out of the 532,063 closed companies, about 10,437 companies were liquidated/dissolved; 490,453 companies were defunct (and hence struck-off); 19,789 companies were amalgamated/ merged with other companies; 6,591 companies were converted to LLP and 4,793 were converted to LLP and dissolved. **Table-1.1** presents the summary picture of companies count as on 30th September 2017.

3. Out of the 1,118,735 active companies limited by shares; 1,048,069 were Private and 70,666 were Public companies, segregated into 7,285 Listed and 63,381 Unlisted Companies (**Table 1.2**).

4. State/UT-wise distribution of registered companies indicates that Maharashtra has the highest number of companies (338,088), followed by Delhi (310,911) and West Bengal (194,690). Similarly, amongst 'Active Companies', Maharashtra has the maximum number of active companies (222,206), followed by Delhi (207,443) and West Bengal (134,259) as on 30th September 2017 (**Table-1.3**).

5. Economic-activity wise classification of active companies reveals that highest number of companies were in Business Services (330,823) followed by Manufacturing (230,422), Trading (150,441) and Construction (103,291). Business Services comprise of Information Technology, Research & Development and other business activities such as law, audit & accounts and consultancy, etc. (**Table-1.4 and Chart 1.1**).

Chart 1.1: Sector-wise Active Companies as on 30th September 2017



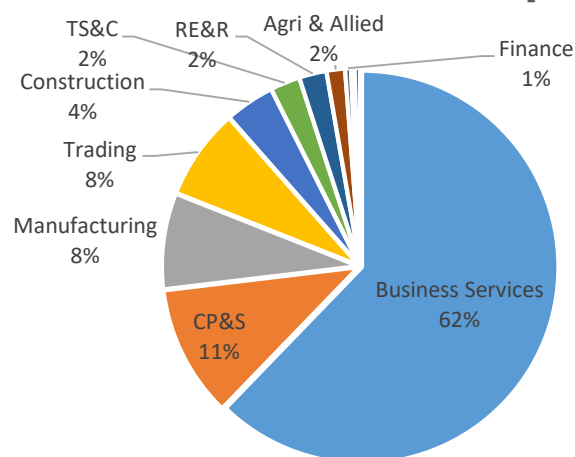

II. ONE PERSON COMPANY

6. Up to 30th September 2017, a total number of 13,927 One Person Companies (OPCs) were registered with collective authorized capital of Rs. 358.00 crore. Economic activity wise classification of OPCs up to 30th September 2017 reveals that the highest number of OPCs were in Business Services (8,666) followed by Community, Personal & Social Services (1,515), Manufacturing (1,100) and Trading (1,044) (**Chart 2.1**). During the month of September 2017, a total of 509 OPC were registered with authorized capital of Rs. 12.16 crore. Economic activity wise classification of OPC during the month reveals that highest number of 339 OPCs were registered in Business Services, followed by 40 in Community, personal & Social Services and 39 in Trading (**Table 2.1**).

Chart 2.1: Sector-wise OPC as on 30th September 2017

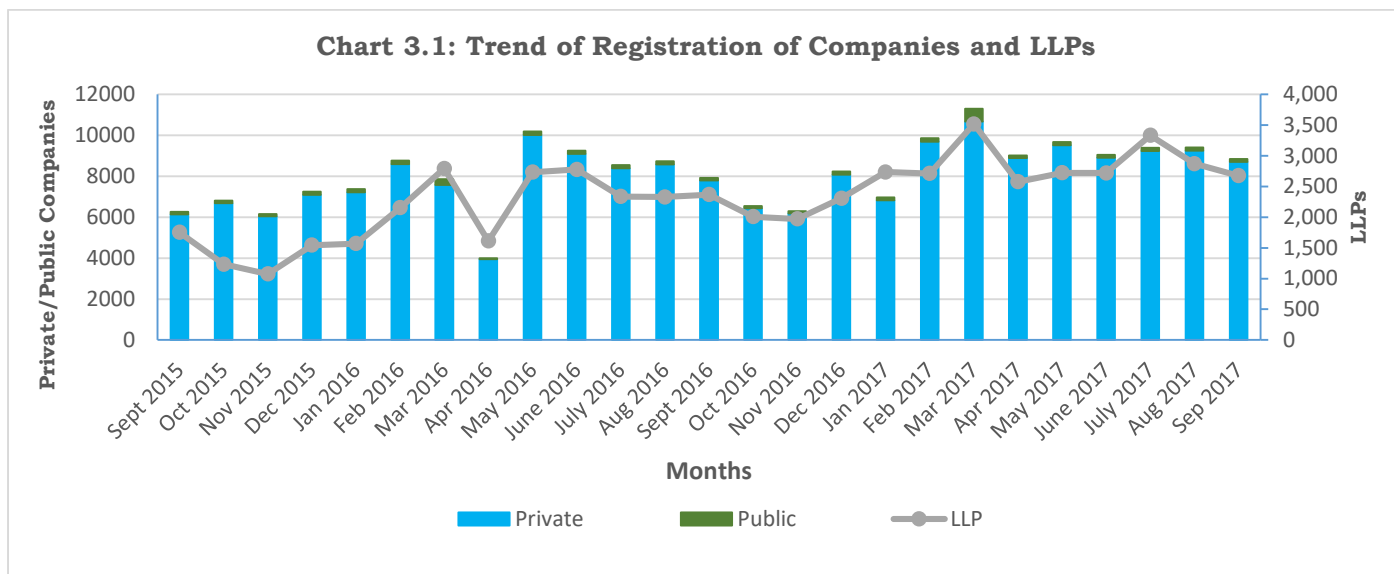

III. TREND OF REGISTRATION OF NEW COMPANIES

7. An analysis of registration of new companies during September 2015 to September 2017 indicates that monthly registration of companies has increased after hitting lowest of 3,994 Companies in April 2016 (**Chart 3.1**). A total of 8,849 companies were registered in September 2017 as compared to 7,923 in September 2016. A slight decrease (-6%) in registration of companies has been witnessed in September 2017 over the previous month. A total of 2,675 LLPs were registered in September 2017 as compared to 2,376 LLPs in September 2016 (**Table 3.1**).

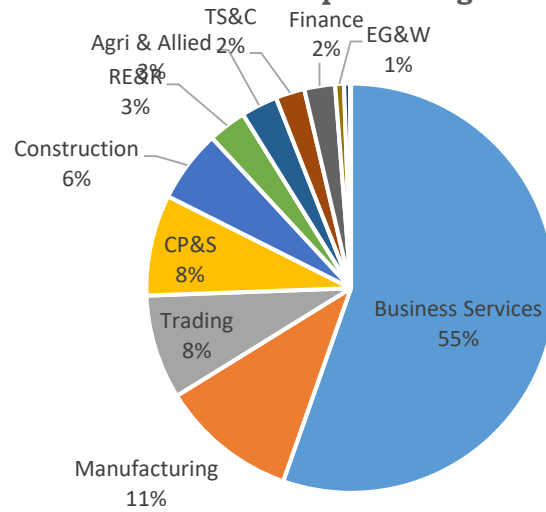


IV. REGISTRATION OF NEW COMPANIES DURING SEPTEMBER 2017

8. During the month of September 2017 a total of 8,849 companies were registered with collective authorized capital of Rs. 1,356.86 crores. Of them 8,831 companies were registered as Companies Limited by Shares with authorized capital of Rs. 1,356.85 crores; 18 companies were registered as Limited by Guarantees with authorized capital of Rs. 1 lakh (**Table-4.1**).

9. Economic-activity wise classification of companies registered during September 2017 (**Table-4.2 and Chart 4.1**) reveals that the predominant share of companies is in Business Services (4,900) followed by Manufacturing (957), Trading (729), Community, personal & Social Services (706) and Construction (506).

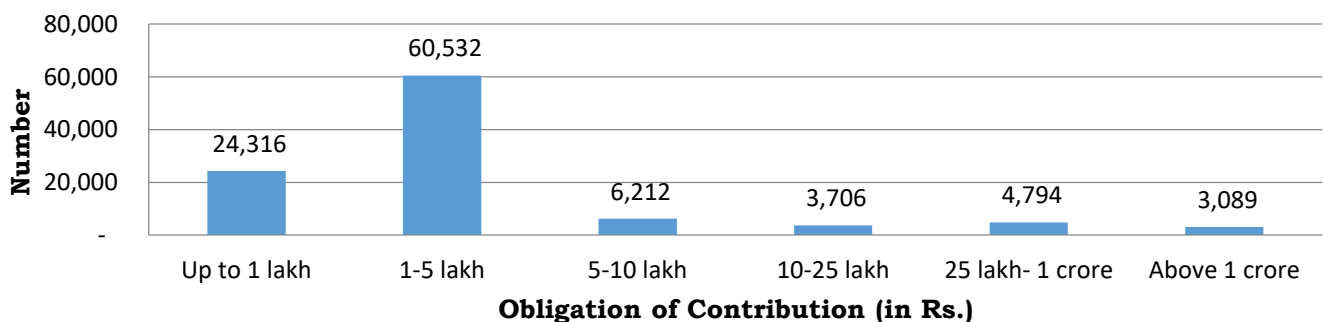

10. During September 2017, 1,525 (17.23%) companies were registered in Maharashtra, followed by 1,312 (14.83%) in Delhi, and 876 (9.90%) in Uttar Pradesh (**Table-4.3**).

V. Limited Liability Partnerships (LLPs)

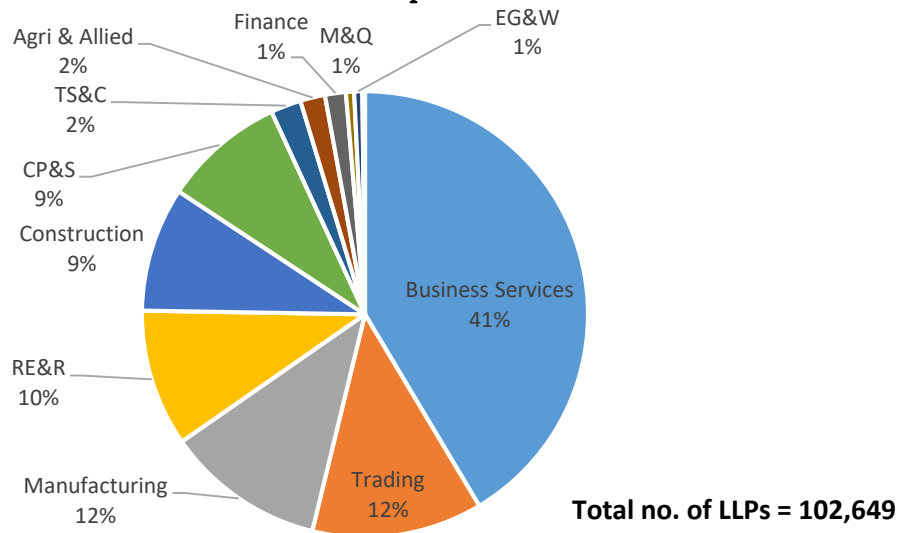
11. As on 30th September 2017, a total number of 102,649 LLPs were active in the country. About 82.66% active LLPs (84,848 in number) have obligation of contribution less than or equal to Rs. 5 lakhs each; and only about 3.01% (3,089 in number) of LLPs have obligation of contribution above Rs.1 crore each (**Table-5.1 and Chart 5.1**)

12. Broad economic sector wise classification of active LLPs as on 30th September 2017 reveals that Service sector account for 78,495 LLPs, followed by Industry and Agriculture sectors accounting for 22,312 and 1,840 respectively. Economic-activity wise classification of active LLPs as on 30th September 2017 reveals that a large number of LLPs are in Business Services (42,531) followed by Trading (12,695), Manufacturing (11,841) and Real Estate & Renting (10,192) (**Table-5.2 & Chart 5.2**).

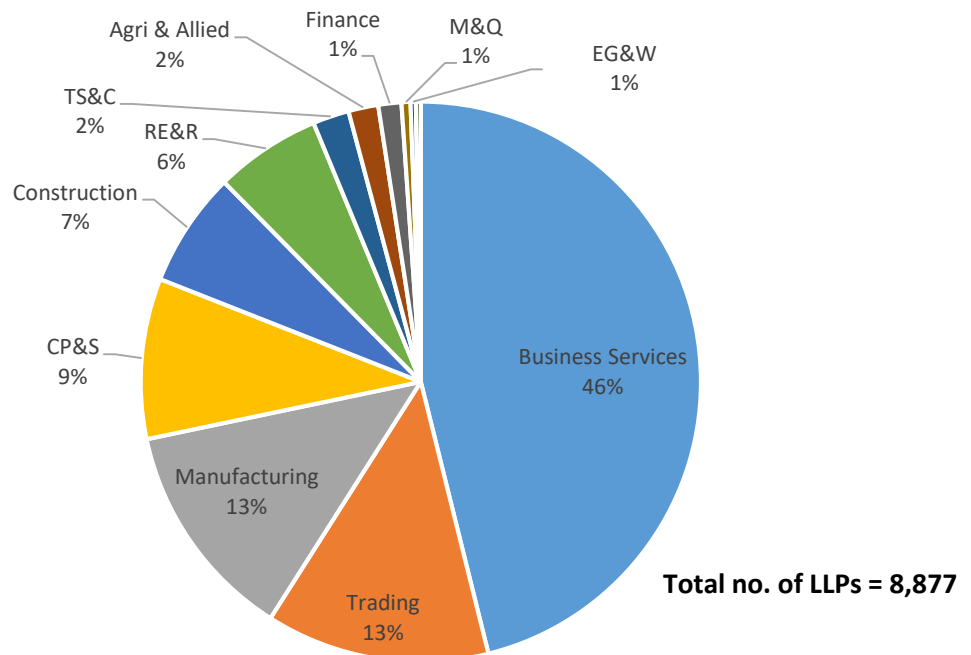
Chart 5.2: Sector wise LLPs as on 30th September 2017

13. During July 2017 to September 2017, a total of 8,877 Limited Liability Partnerships (LLPs) were registered with collective obligation of contribution of Rs. 1,119.80 crores. Economic activity wise classification of LLPs during July to September 2017 indicates that highest number of 4,094 LLPs were registered in Business Services followed by 1,145 in Trading, 1,127 in Manufacturing and 822 in Community, Personal and Social Services (**Table 5.3 and Chart 5.3**).

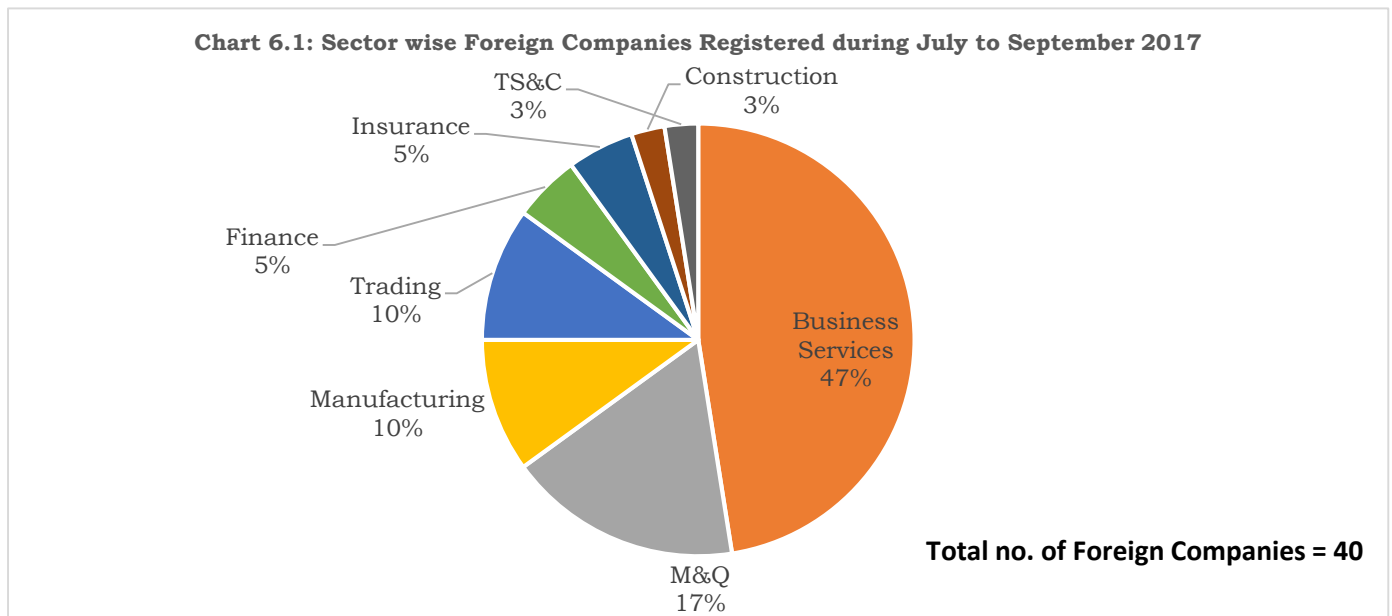
Chart 5.3: Sector-wise LLPs during July to September 2017

VI. FOREIGN COMPANIES

14. As on 30th September 2017, a total of 4,586 foreign companies were registered in India, of which 3,364 of them were active. During July 2017 to September 2017, a total of 40 foreign companies were registered in India including 14 in Maharashtra (35.00%) followed by 9 (22.50%) in Delhi and 5 (12.50%) in Haryana. Economic activity wise classification of foreign companies reveals that highest number of 19 were registered in Business Services followed by 7 in Mining & Quarrying, 4 each in Manufacturing and Trading. **(Table 6.1 and chart 6.1).**
