

HIGHLIGHTS

I. REGISTERED COMPANIES AS ON 30th September 2018


- 1. The total number of companies registered in the country as on 30th September, 2018 stood at 1,803,277. Of them 646,097 companies were closed. 1,523 companies were assigned dormant status as per the Companies Act, 2013; 6,208 were under liquidation; 39,791 companies were in the process of being struck-off. After being struck off previously, 102 Companies were in the process of being re-activated. Taking the above into account, there were 1,109,556 active companies as on 30th September, 2018.
- 2. Out of the 646,097 closed companies, 10,574 companies were liquidated/dissolved; 599,275 companies were declared defunct (and hence struck-off after issuance of notice u/s 248). 21,894 companies were amalgamated/ merged with other companies; 9,560 companies were converted to Limited Liability Partnership (LLP) and 4,794 were converted to LLP and dissolved. **Table-1.1** presents the summary picture of companies count as on 30th September, 2018.
- 3. Out of the 1,109,556 active companies, 1,102,561 were limited by shares; 6,653 were limited by guarantee and 342 were unlimited companies. Out of the companies limited by shares, 64,398 were public, 1,038,163 were private including 19,124 one person companies. Among the public limited companies, 6,961 were listed (**Table 1.2**).
- 4. State/UT-wise distribution of registered companies indicates that Maharashtra has the highest number of companies (357,994), followed by Delhi (325,095) and West Bengal (198,707). Amongst 'Active Companies', Maharashtra has the maximum number of active companies (224,377), followed by Delhi (196,689) and West Bengal (126,937) as on 30th September, 2018 (**Table-1.3**).
- 5. Economic-activity wise classification of active companies reveals that highest number of companies were in Business Services (353,163) followed by Manufacturing (222,029), Trading (143,890) and Construction (97,790). Business Services comprise of Information Technology, Research & Development and other business activities such as law, audit & accounts and consultancy, etc. (**Table-1.4 and Chart 1.1**).



'M&Q' is Mining & Quarrying, 'TS&C' is Transport, Storage and Communication, and 'CP&S is Community, Personal & Social Services, 'RE&R' is Real Estate and Renting, 'EG&W', is Electricity Gas & Water. 18,195 active companies (Others) are having invalid Economic Activity (NIC-2004) Code.


II. ONE PERSON COMPANY

6. Up to 30th September, 2018, a total number of 19,124 One Person Companies (OPCs) were registered with collective authorized capital of Rs. 497.43 crore. Economic activity wise classification of OPCs up to 30th September, 2018 reveals that the highest number of OPCs were in Business Services (12,130) followed by Community, Personal & Social Services (2,073), Manufacturing (1,473) and Trading (1,390) (Chart 2.1). During the month of September, 2018, a total of 667 OPC were registered with authorized capital of Rs. 18.30 crore. Economic activity wise classification of OPC during the month reveals that highest number of 354 OPCs were registered in Business Services, followed by 101 in Community, personal & Social Services and 66 in Trading (Table 2.1).




III. TREND OF REGISTRATION OF NEW COMPANIES

An analysis of registration of new companies during September 2016 to September 2018 indicates that monthly registration of companies has increased after hitting lowest of 6,301 Companies in November 2016 (Chart 3.1). A total of 13,396 companies were registered in September, 2018 as compared to 8,849 in September 2017. An increase (73.07%) in registration of companies has been witnessed in September 2018 over the previous month (Table 3.1). A total of 1,551 LLPs were registered in September 2018 as compared to 2,675 LLPs in September 2017 (Table 3.1).



IV. REGISTRATION OF NEW COMPANIES DURING SEPTEMBER 2018

- 8. During the month of September, 2018 a total of 13,396 companies were registered with collective authorized capital of Rs. 2,653.59 crores. Of them 13,337 companies were registered as Companies Limited by Shares with authorized capital of Rs. 2,653.59 crores; 59 companies were registered as Limited by Guarantee. (**Table-4.1**).
- 9. Economic-activity wise classification of companies registered during September, 2018 (**Table-4.2 and Chart 4.1**) reveals that the predominant share of companies is in Business Services (5,761) followed by Manufacturing (1,849), Community, personal & Social Services (1,520), Trading (1,392) and Construction (831).




10. During September, 2018, 2,558 (19.10%) companies were registered in Maharashtra, followed by 1,693 (12.64%) in Delhi, and 1,308 (9.76%) in Uttar Pradesh (Table-4.3).

V. <u>Limited Liability Partnerships (LLPs)</u>

11. As on 30th September 2018, a total number of 118,818 LLPs were active in the country. About 81.77% active LLPs (97,159 in number) have obligation of contribution less than or equal to Rs. 5 lakhs each; and only about 3.36% (3,998 in number) of LLPs have obligation of contribution above Rs.1 crore each **(Table-5.1 and Chart 5.1)**




Broad economic sector wise classification of active LLPs as on 30th September 2018 reveals that Service sector account for 90,714 LLPs, followed by Industry and Agriculture sectors accounting for 25,872 and 2,231 respectively. Economic-activity wise classification of active LLPs as on 30th September 2018 further reveals that a large number of LLPs are in Business Services (48,727) followed by Trading (14,885), Manufacturing (14,055) and Real Estate & Renting (12,050) (**Table-5.2 & Chart 5.2**).


13. During July 2018 to September 2018, a total of 4,875 Limited Liability Partnerships (LLPs) were registered with collective obligation of contribution of Rs. 1,137.34 crores. Economic activity wise classification of LLPs during July to September 2018 indicates that highest number of 1,843 LLPs were registered in Business Services followed by 649 in Trading, 638 in Manufacturing and 509 in Real Estate and Renting (**Table 5.3 and Chart 5.3**).

VI. FOREIGN COMPANIES

14. As on 30th September 2018, a total of 4,702 foreign companies were registered in India, of which 3,373 of them were active. During July 2018 to September 2018, a total of 24 foreign companies were registered in India including 12 in Maharashtra (50%) followed by 4 (17%) in Delhi and 2 (8%) in Haryana. Economic activity wise classification of foreign companies reveals that highest number of 16 were registered in Business Services followed by 2 in each Manufacturing, Construction and Trading. (**Table 6.1 and chart 6.1**).
