

HIGHLIGHTS

I. REGISTERED COMPANIES AS ON 28th February 2019

The total number of companies registered in the country as on 28th February, 2019 stood at 1,862,642. Of them 670,100 companies were closed. 1,616 companies were assigned dormant status as per the Companies Act, 2013; 6,327 were under liquidation; 38,614 companies were in the process of being struck-off. After being struck off previously, 100 Companies were in the process of being re-activated. Taking the above into account, there were 1,145,885 active companies as on 28th February, 2019.


- 1. Out of the 670,100 closed companies, 10,640 companies were liquidated/dissolved; 622,048 companies were declared defunct (and hence struck-off after issuance of notice u/s 248). 22,532 companies were amalgamated/ merged with other companies; 10,086 companies were converted to Limited Liability Partnership (LLP) and 4,794 were converted to LLP and dissolved. **Table-1.1** presents the summary picture of companies count as on 28th February, 2019.
- 2. Out of the 1,145,885 active companies, 1,138,725 were limited by shares; 6,843 were limited by guarantee and 317 were unlimited companies. Out of the companies limited by shares, 63,736 were public, 1,074,989 were private including 22,180 one person companies. Among the public limited companies, 6,915 were listed (**Table 1.2**).
- 3. State/UT-wise distribution of registered companies indicates that Maharashtra has the highest number of companies (369,051), followed by Delhi (332,492) and West Bengal (201,336). Amongst 'Active Companies', Maharashtra has the maximum number of active companies (221,315), followed by Delhi (202,891) and West Bengal (129,049) as on 28th February, 2019. (**Table-1.3**).
- 4. Economic-activity wise classification of active companies reveals that highest number of companies were in Business Services (374,039) followed by Manufacturing (225,795), Trading (147,293) and Construction (99,600). Business Services comprise of Information Technology, Research & Development and other business activities such as law, audit & accounts and consultancy, etc. (**Table-1.4 and Chart 1.1**).



'M&Q' is Mining & Quarrying, 'TS&C' is Transport, Storage and Communication, and 'CP&S is Community, Personal & Social Services, 'RE&R' is Real Estate and Renting, 'EG&W', is Electricity Gas & Water. 18,194 active companies (Others) are having invalid Economic Activity (NIC-2004) Code.

II. ONE PERSON COMPANY

6. Up to 28th February, 2019, a total number of 22,180 One Person Companies (OPCs) were registered with collective authorized capital of Rs. 604.29 crore. Economic activity wise classification of OPCs up to 28th February reveals that the highest number of OPCs were in Business Services (13,626) followed by Community, Personal & Social Services (2,570), Manufacturing (1,791) and Trading (1,730) (Chart 2.1). During the month of February 2019, a total of 657 OPC were registered with authorized capital of Rs. 22.84 crore. Economic activity wise classification of OPC during the month reveals that highest number of 327 OPCs were registered in Business Services, followed by 116 in Community, personal & Social Services, 75 in Trading and 57 in Manufacturing (Table 2.1).



'TS&C' is Transport, Storage and Communication, 'CP&S' is 'Community, personal & Social Services', 'RE&R' is Real Estate and Renting.


III. TREND OF REGISTRATION OF NEW COMPANIES

7. An analysis of registration of new companies during February 2017 to February 2019 indicates that monthly registration of companies has increased after hitting lowest of 7,556 Companies in October 2017 (Chart 3.1). A total of 11,776 companies were registered in February, 2019 as compared to 8,011 in February 2018. A decrease (5.52%) in registration of companies has been witnessed in February 2019 over the previous month (Table 3.1).



IV. REGISTRATION OF NEW COMPANIES DURING FEBRUARY 2019

- 8. During the month of February 2019 a total of 11,776 companies were registered with collective authorized capital of Rs. 4388.70 crore. Of them 11,727 companies were registered as Companies Limited by Shares with authorized capital of Rs. 4388.70 crore; (**Table-4.1**).
- 9. Economic-activity wise classification of companies registered during February 2019 (**Table-4.2 and Chart 4.1**) reveals that the predominant share of companies is in Business Services (4,773) followed by Manufacturing (1,607), Community, personal & Social Services (1,483), Trading (1,220) and Construction (685).



'EG&W' is Electricity, Gas and Water, 'TS&C' is Transport, Storage and Communication, 'CP&S' is Community, personal & Social Services, 'RE&R' is Real Estate and Renting.

10. During February 2019, 2,254 (19.14%) companies were registered in Maharashtra, followed by 1,425 (12.10%) in Delhi, and 1,154 (9.80%) in Uttar Pradesh (**Table-4.3**).
