

HIGHLIGHTS

I. REGISTERED COMPANIES AS ON 31st DECEMBER, 2015

- 1. The total number of companies registered in the country as on 31st December, 2015, stood at 1,519,715. Of them, 282,564 companies were closed; 497 companies were assigned dormant status as per the Companies Act, 2013; 138,843 companies have not filed their statutory annual filings for 3 years consecutively; 5,417 companies were under liquidation; 22,179 companies were in the process of being struck-off and 166 companies were in the process of being re-activated. Taking the above into account, there were 1,070,049 active companies as on 31st December, 2015.
- 2. Out of the 282,564 closed companies, about 10,346 companies were liquidated/dissolved; 249,748 companies were defunct (and hence struck-off); 16,541 companies were amalgamated/ merged with other companies; 5,929 companies were dissolved and converted to LLP. **Table-1.1** presents the summary picture of companies count as on 31st December, 2015.
- 3. Out of the 1,063,392 active companies limited by shares; 999,966 were Private companies limited by shares; and 63,426 were Public companies limited by shares, of which 6,872 were Listed and 56,554 were Unlisted Companies (**Table 1.2**).
- 4. Authorized Capital wise distribution of active companies as on 31st December, 2015 **(Table-1.3)** indicates that about 66.40% of companies (710,508 in number) have authorized capital less than or equal to Rs.10 lakh each and about 2.13% of companies (22,818 in number) have authorized capital of above Rs.10 crore each.
- 5. State/UT-wise distribution of registered companies indicates that Maharashtra has the highest number of companies (305,934), followed by Delhi (282,549) and West Bengal (187,707). Similarly, amongst 'Active Companies', Maharashtra has the maximum number of active companies (224,738), followed by Delhi (203,530) and West Bengal (138,663) as on 31st December, 2015 (**Table-1.4**).
- 6. Economic-activity wise classification of active companies reveals that highest number of companies are in Business Services (2.81 lakh) followed by Manufacturing (2.21 lakh), Trading (1.55 lakh) and Construction (1.09 lakh). Business Services comprise Information Technology, Research & Development


and other business activities (such as law, audit & accounts and consultancy, etc. (Table-1.5 and Chart 1.1).

II. ONE PERSON COMPANY


7. Up to 31st December, 2015, a total number of 5,018 One Person Company (OPC) were registered with collective authorized capital of Rs. 124.98 crore. Economic activity wise classification of OPC up to 31st December, 2015 reveals that highest number of OPC are in Business Services (2,819) followed by Community, personal & Social Services (772), Manufacturing (406) and Trading (376) (Chart 2.1). During the month of December, 2015, a total of 330 OPC were registered with authorized capital of Rs. 8.11 crore. Economic activity wise classification of OPC during the month reveals that highest number of 192 OPC were registered in Business Services, followed by 57 in Community, personal & Social Services and 24 in Manufacturing (Table 2.1). Highest number of 46 OPC were registered in Maharashtra (13.94%), 42 in Delhi (12.73%) and 38 in Karnataka (11.52%) during the month of December, 2015 (Table-6.1).


III. TREND OF REGISTRATION OF NEW COMPANIES AND LLPs

8. An analysis of registration of new companies during January 2013 to December 2015 indicates that monthly registration of companies is showing an increasing trend after hitting its lowest of 765 in April 2014 (Chart 3.1). A total of 7,244 companies were registered in December 2015 as compared to 6,446 in December, 2014. A slight increased in registration of companies has been witnessed in December, 2015 over the previous month. A decreasing trend is observed in monthly registration of LLPs in last few months with minimum registration of 1,074 LLPs in November, 2015 and has started picking up since November, 2015. IV. REGISTRATION OF NEW COMPANIES DURING DECEMBER, 2015

- 9. During the month of December, 2015, a total of 7,244 companies were registered with collective authorized capital of Rs. 900.37 crore. Of them 7,216 companies were registered as Companies Limited by Shares with authorized capital of Rs. 900.23 crore and 28 companies were registered as Limited by Guarantees with authorized capital of Rs. 14.00 lakh.(**Table-4.1**).
- 10. Economic-activity wise classification of companies registered during December, 2015 (**Table-4.2 and Chart 4.1**) reveals that the predominant share of companies are in Business Services (3,514) followed by Manufacturing (866), Trading (648), Construction (542) and Community, personal & Social Services (445).




11. During December, 2015, 1,323 (18.26%) companies were registered in Maharashtra, followed by 1,109 (15.31%) in Delhi, and 652 (9.00%) in Uttar Pradesh (**Table-4.3**).

V. <u>Limited Liability Partnerships (LLP) and Foreign Companies</u>

12. As on 31st December, 2015, a total number of 52,144 LLPs were registered in the country and 51,315 of them were active. About 89.92 % active LLPs (46,143 in number) have obligation of contribution less than or equal Rs. 5 lakh each; and only about 2.03% (1,041 in number) of LLPs have obligation of contribution of above Rs. crore each (**Table-5.1 and Chart 5.1**).




13. Broad economic sector wise classification of active LLPs as on 31st December, 2015 reveals that Service sector account for 38,625 LLPs, followed by Industry and Agriculture sectors accounting for 11,719 and 965 respectively. Economic-activity wise classification of active LLPs as on 31st December, 2015 reveals that a large number of LLPs are in Business Services (20,149) followed by Trading (6,119), Real Estate & Renting (6,087) and Manufacturing (5,572) (**Table-5.2 and Chart 5.2**).

14. A total of 1,545 Limited Liability Partnerships (LLPs) were registered during December, 2015 with collective obligation of contribution of Rs. 2,904.32 crore. Economic activity wise classification of LLPs during the month reveals that highest number of 592 LLPs were registered in Business Services, followed by 241 in Trading and 192 in Manufacturing (**Table-5.3 and Chart 5.3**). Highest number of 491 LLPs were registered in Maharashtra (31.78 %) followed by 202 in Delhi (13.07 %) during the month of December, 2015 (**Table-6.1**).

Foreign Companies

15. As on 31st December, 2015, a total of 3,337 foreign companies were doing business in India. During the month of December, 2015, 20 foreign companies were registered in India including 5 in Delhi, 4 in Karnataka and 3 each in Haryana and Maharashtra, 2 each in Gujarat and Uttar Pradesh and 1 in West Bengal. Out of these 20 foreign companies, 13 were registered under Business Services, 3 in Trading and 2 each in Transport, storage & Communications and Construction.
