HIGHLIGHTS

I. REGISTERED COMPANIES AS ON 31st DECEMBER, 2014

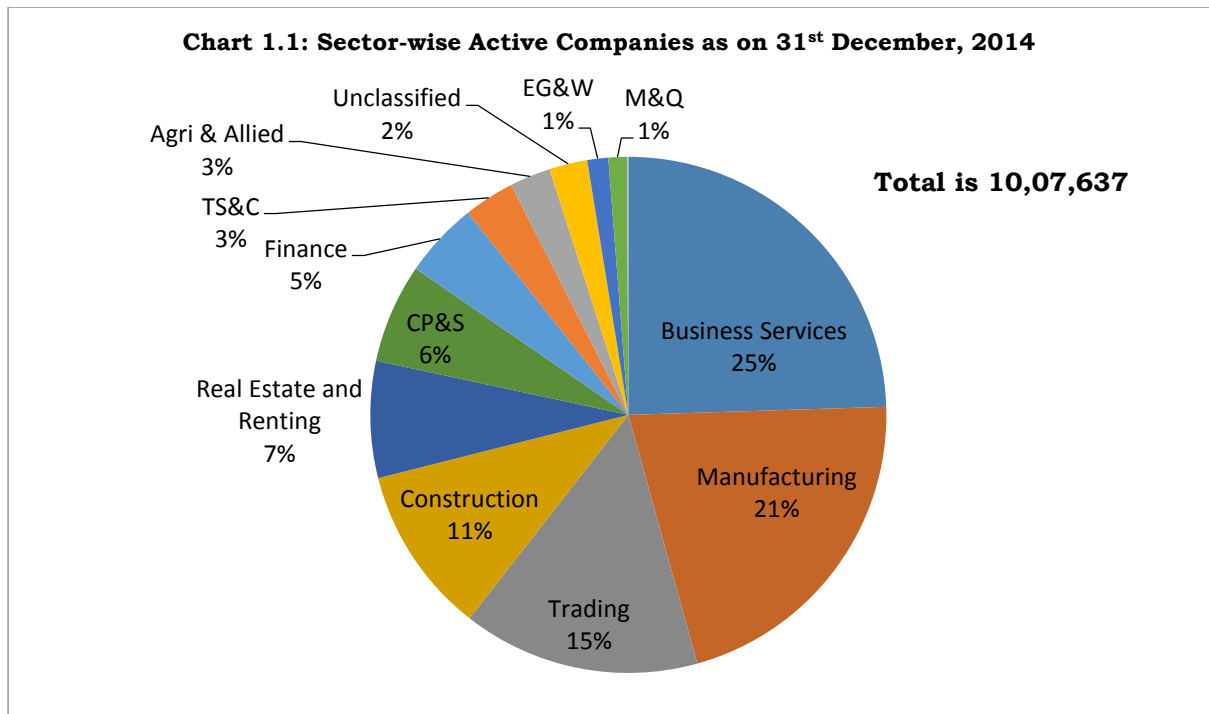
1. The total number of companies registered in the country as on 31st December, 2014, stood at 14,39,201. Of them, 2,63,024 companies were closed; 87 companies were assigned dormant status as per the Companies Act, 2013; 1,39,627 companies have not filed their statutory annual filings for 3 years consecutively; 5,220 companies were under liquidation; 22,803 companies were in the process of being struck-off and 803 companies were in the process of being re-activated. Taking the above into account, there were 10,07,637 active companies as on 31st December, 2014.

2. Out of the 2,63,024 closed companies, about 10,246 companies were liquidated/dissolved; 2,35,267 companies were defunct (and hence struck-off); 14,923 companies were amalgamated/ merged with other companies; 2,588 companies were dissolved and converted to LLP. **Table-1.1** presents the summary picture of companies count as on 31st December, 2014.

3. Authorized Capital wise distribution of active companies as on 31st December, 2014 (**Table-1.2**) indicates that about 65.55% of companies (6,60,460 in number) have authorized capital less than or equal to Rs.10 lakh each and about 2.13% of companies (21,415 in number) have authorized capital of above Rs.10 crore each.

4. State/UT-wise distribution of registered companies indicates that Maharashtra has the highest number of companies (2,91,089), followed by Delhi (2,68,732) and West Bengal (1,84,034). Similarly, amongst 'Active Companies', Maharashtra has the maximum number of active companies (2,12,649), followed by Delhi (1,94,841) and West Bengal (1,36,944) as on 31st December, 2014 (**Table-1.3**).

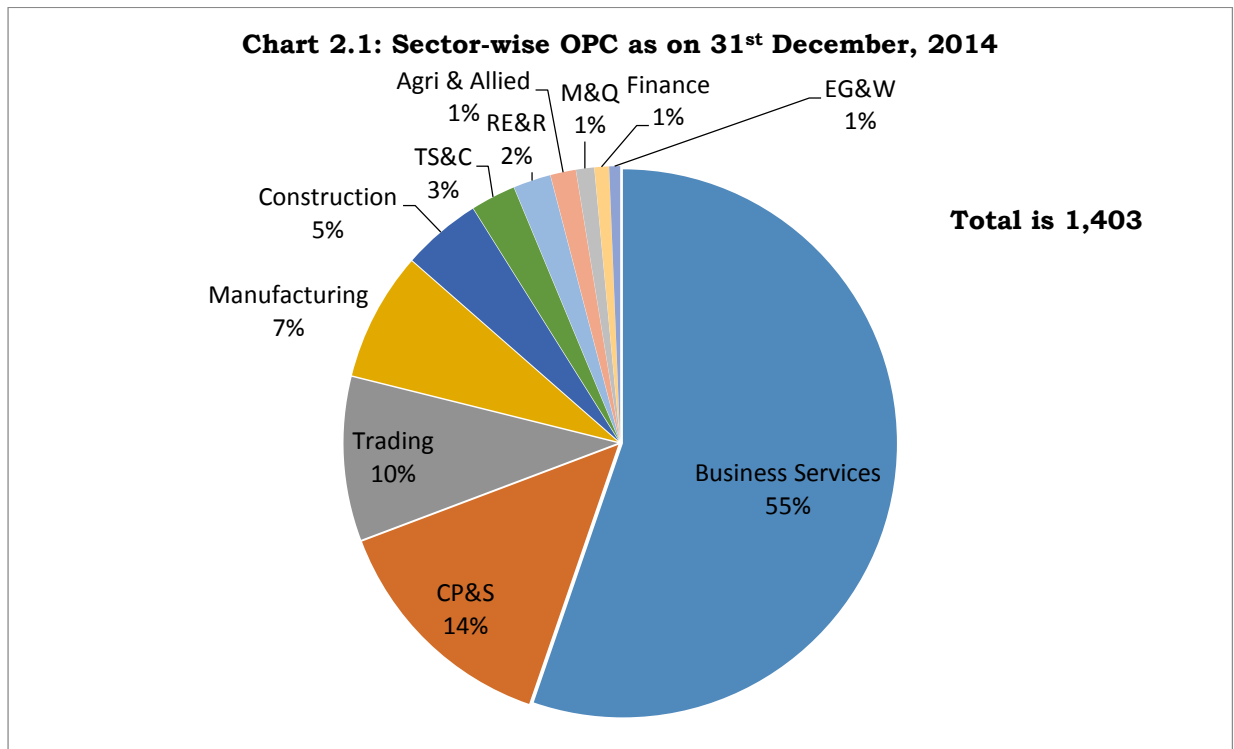
5. Economic-activity wise classification of active companies reveals that highest number of companies are in Business Services (2.47 lakh) followed by Manufacturing (2.13 lakh), Trading (1.50 lakh) and Construction (1.06 lakh). Business Services comprise Information Technology, Research & Development and other business activities (such as law, audit & accounts and consultancy, etc.) (**Table-1.4 and Chart 1.1**).

II. ONE PERSON COMPANY

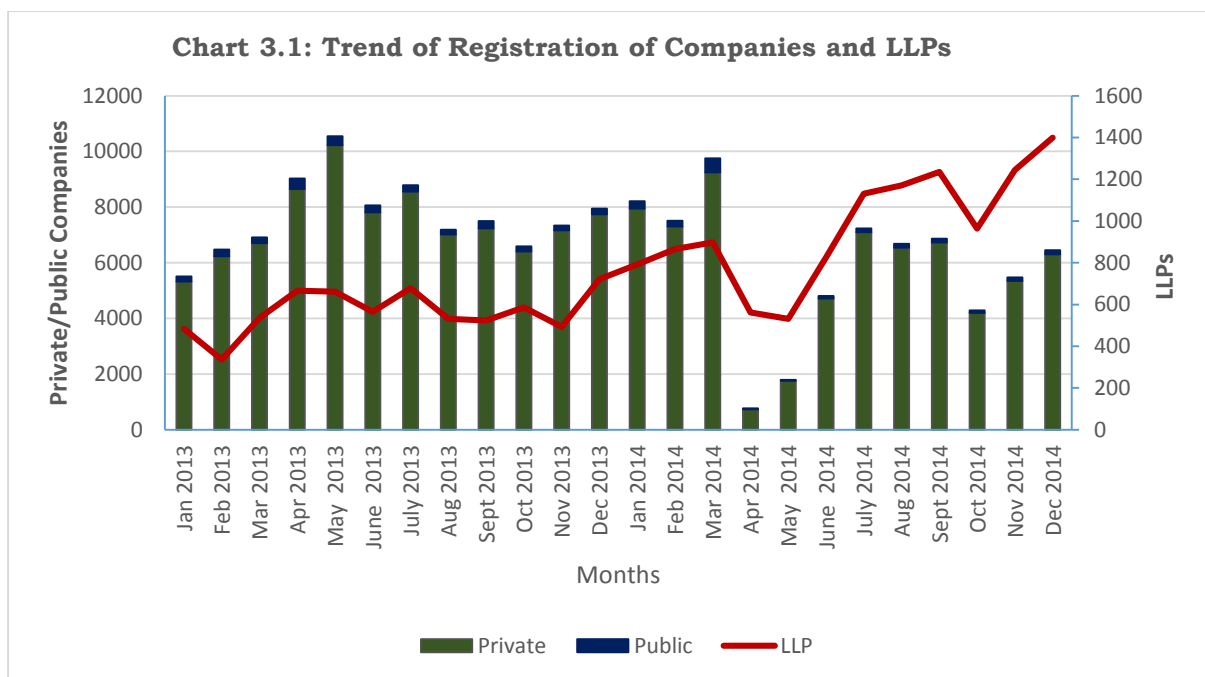
6. Up to 31st December, 2014, a total number of 1,403 One Person Companies (OPC) were registered with collective authorized capital of Rs. 31.31 crore. Economic activity wise classification of OPC up to 31st December, 2014 reveals that highest number of OPC are in Business Services (775) followed by Community, personal & Social Services (196), Trading (135) and Manufacturing (106) (**Chart 2.1**). During the month of December, 2014, a total of 277 OPC were registered with authorized capital of Rs. 5.90 crore. Economic activity wise classification of OPC during the month reveals that highest number of 129 OPC were registered in Business Services, followed by 62 in Community, personal & Social Services and 39 in Trading (**Table 2.1**). Highest number of 58 OPC were registered in Delhi (20.94 %) followed by 39 in Uttar Pradesh (14.08 %) and 36 in Maharashtra (13.00 %) during the month of December 2014.

III. TREND OF REGISTRATION OF NEW COMPANIES AND LLPs

7. An analysis of registration of new companies during January 2013 to December 2014 indicates that monthly registration of companies is showing an increasing trend after hitting its lowest of 765 in April 2014 (**Chart 3.1**). Although 6,446 companies were registered in December 2014 as compared to 7,944 in December 2013, increased registration of companies has been witnessed in December 2014 over the previous month. An increasing trend is also observed in monthly registration of LLPs in last few months with maximum registration of 1,399 LLPs in December 2014 (**Table 3.1**). Registration of new companies as well as LLPs has picked-up since April 2014, although a dip was witnessed in October 2014.

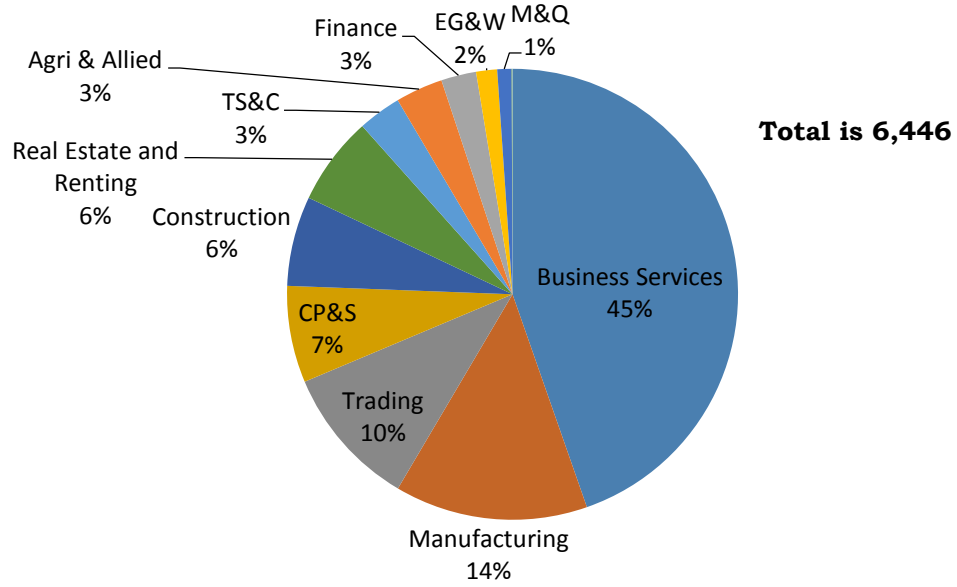


IV. REGISTRATION OF NEW COMPANIES DURING DECEMBER, 2014

8. During the month of December, 2014, a total of 6,446 companies were registered with collective authorized capital of Rs. 6,234.23 crore. Of them 6,424 companies were registered as Companies Limited by Shares with authorized capital of Rs. 6,233.53 crore; 20 companies were registered as Limited by Guarantees with authorized capital of Rs. 68 lakh; 2 companies were registered as Unlimited Company with authorized capital of Rs. 2 lakh (**Table-4.1**).

9. Economic-activity wise classification of companies registered during December, 2014 (**Table-4.2 and Chart 4.1**) reveals that the predominant share of companies are in Business Services (2,878) followed by Manufacturing (892), Trading (656), Community, personnel & Social Services (447) and Construction (415).

Chart 4.1: Distribution of Companies Registered in December, 2014



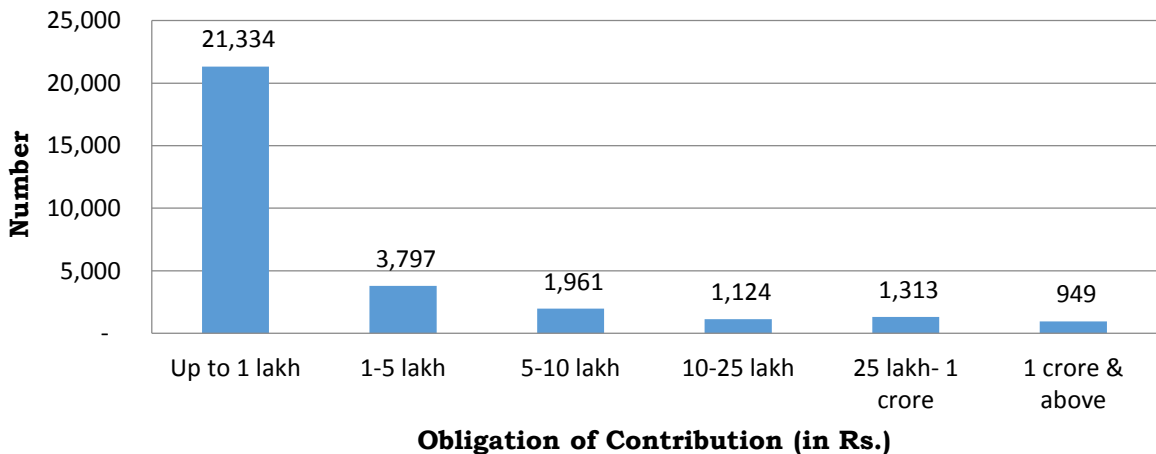

10. During December, 2014, 1,200 (18.62%) companies were registered in Delhi, followed by 954 (14.80%) in Maharashtra, and 662 (10.27%) in Uttar Pradesh (**Table-4.3**).

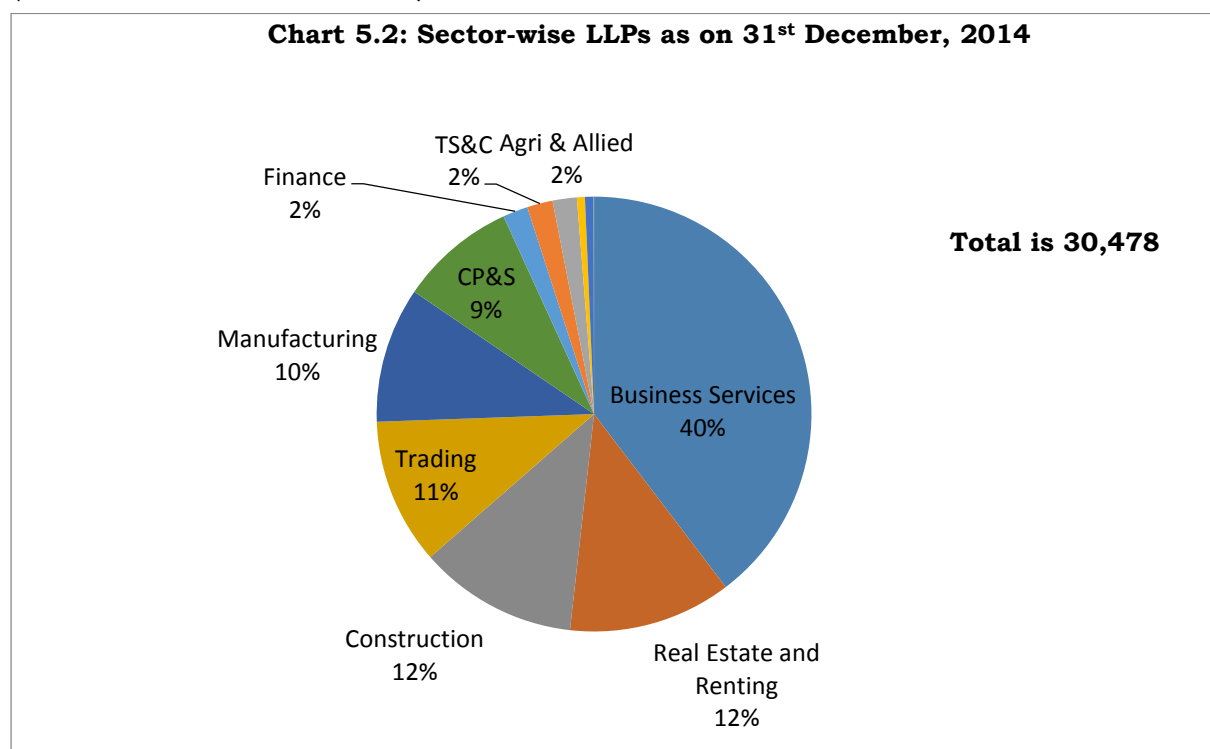
V. Limited Liability Partnerships (LLP) and Foreign Companies

11. As on 31st December, 2014, a total number of 30,845 LLPs were registered in the country and 30,478 of them were active. About 82.46% active LLPs (25,131 in number) have obligation of contribution less than or equal Rs. 5 lakh each; and only about 3.11% (949 in number) of LLPs have obligation of contribution of above Rs.1 crore each (**Table-5.1 and Chart 5.1**).

Chart 5.1: Obligation of Contribution wise distribution of LLPs



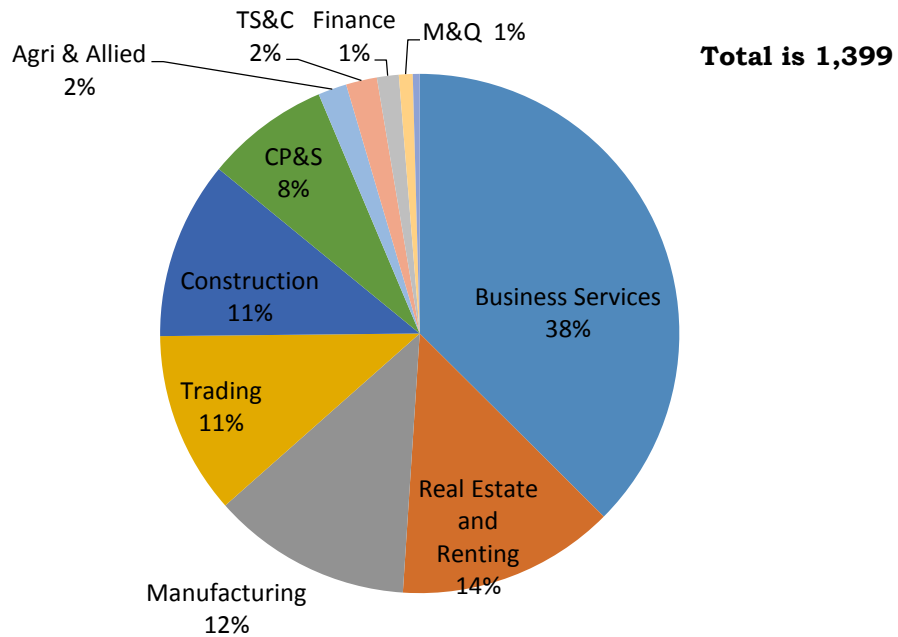
12. Broad economic sector wise classification of active LLPs as on 31st December, 2014 reveals that Service sector account for 22,884 LLPs, followed by Industry and Agriculture sectors accounting for 7,044 and 548 respectively. Economic-activity wise classification of active LLPs as on 31st December, 2014 reveals that a large number of LLPs are in Business Services (12,082) followed by Real Estate & Renting (3,696), Construction (3,599) and Trading (3,309) (**Table-5.2 and Chart 5.2**).



'TS&C' is Transport, Storage and Communication, CP&S is 'Community, personal & Social Services'.

13. A total of 1,399 Limited Liability Partnerships (LLPs) were registered during December, 2014 with collective obligation of contribution of Rs. 236.61 crore. Economic activity wise classification of LLPs during the month reveals that highest number of 524 LLPs were registered in Business Services, followed by 190 in Real Estate and Renting and 174 in Manufacturing (**Table-5.3 and Chart 5.3**). Highest number of 532 LLPs were registered in Maharashtra (38.03%) followed by 145 in Delhi (10.36%) during the month of December 2014.

Foreign Companies

14. As on 31st December, 2014, a total of 3,306 foreign companies were doing business in India. During the month of December, 2014, 23 foreign companies were registered in India including 7 in Maharashtra, 6 in Delhi, 3 each in Haryana and Karnataka, and 1 each in Gujarat, Tamil Nadu, Uttar Pradesh and West Bengal. Out of these 23 foreign companies, 13 were registered under Business Services during the month.
