HIGHLIGHTS

I. REGISTERED COMPANIES AS ON 28th FEBRUARY, 2015

1. The total number of companies registered in the country as on 28th February, 2015, stood at 1,452,243. Of them, 266,401 companies were closed; 151 companies were assigned dormant status as per the Companies Act, 2013; 139,507 companies have not filed their statutory annual filings for 3 years consecutively; 5,276 companies were under liquidation; 23,148 companies were in the process of being struck-off and 184 companies were in the process of being re-activated. Taking the above into account, there were 1,017,576 active companies as on 28th February, 2015.

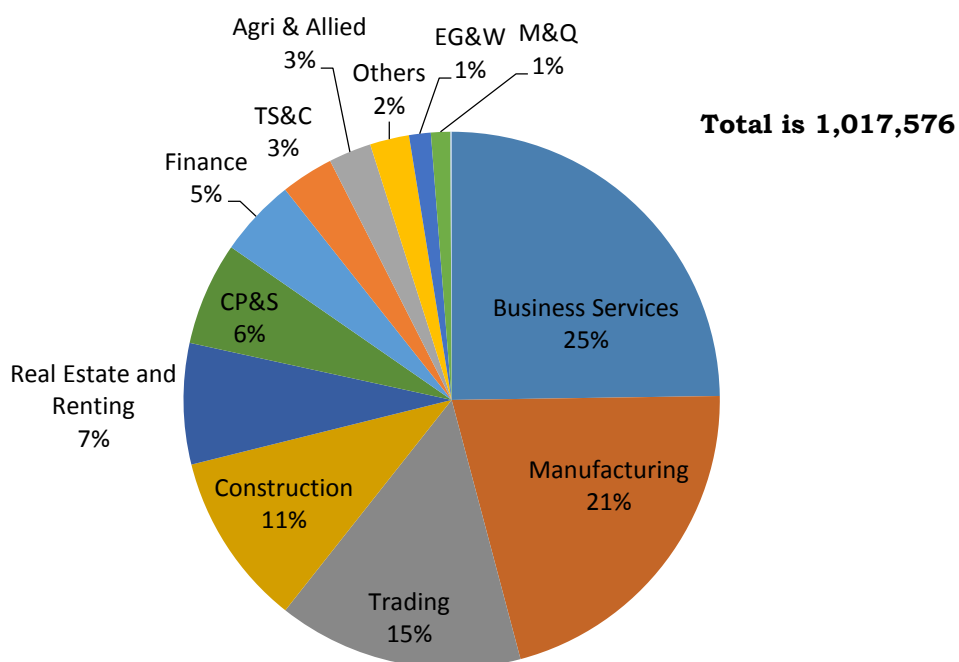
2. Out of the 266,401 closed companies, about 10,264 companies were liquidated/dissolved; 237,668 companies were defunct (and hence struck-off); 15,238 companies were amalgamated/ merged with other companies; 3,231 companies were dissolved and converted to LLP. **Table-1.1** presents the summary picture of companies count as on 28th February, 2015.

3. Authorized Capital wise distribution of active companies as on 28th February, 2015 (**Table-1.2**) indicates that about 65.67% of companies (668,269 in number) have authorized capital less than or equal to Rs.10 lakh each and about 2.13% of companies (21,659 in number) have authorized capital of above Rs.10 crore each.

4. State/UT-wise distribution of registered companies indicates that Maharashtra has the highest number of companies (293,407), followed by Delhi (271,185) and West Bengal (184,630). Similarly, amongst 'Active Companies', Maharashtra has the maximum number of active companies (214,528), followed by Delhi (196,536) and West Bengal (137,169) as on 28th February, 2015 (**Table-1.3**).

5. Economic-activity wise classification of active companies reveals that highest number of companies are in Business Services (2.52 lakh) followed by Manufacturing (2.15 lakh), Trading (1.50 lakh) and Construction (1.07 lakh). Business Services comprise Information Technology, Research & Development and other business activities (such as law, audit & accounts and consultancy, etc. (**Table-1.4 and Chart 1.1**).

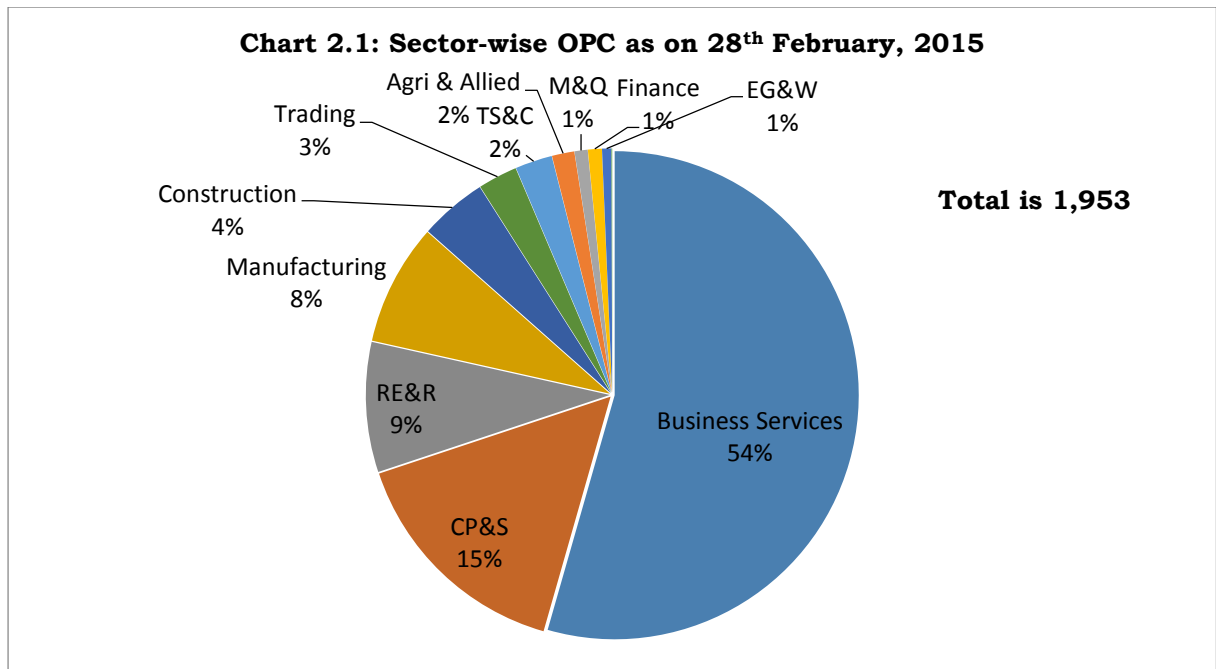
Chart 1.1: Sector-wise Active Companies as on 28th February, 2015

II. ONE PERSON COMPANY

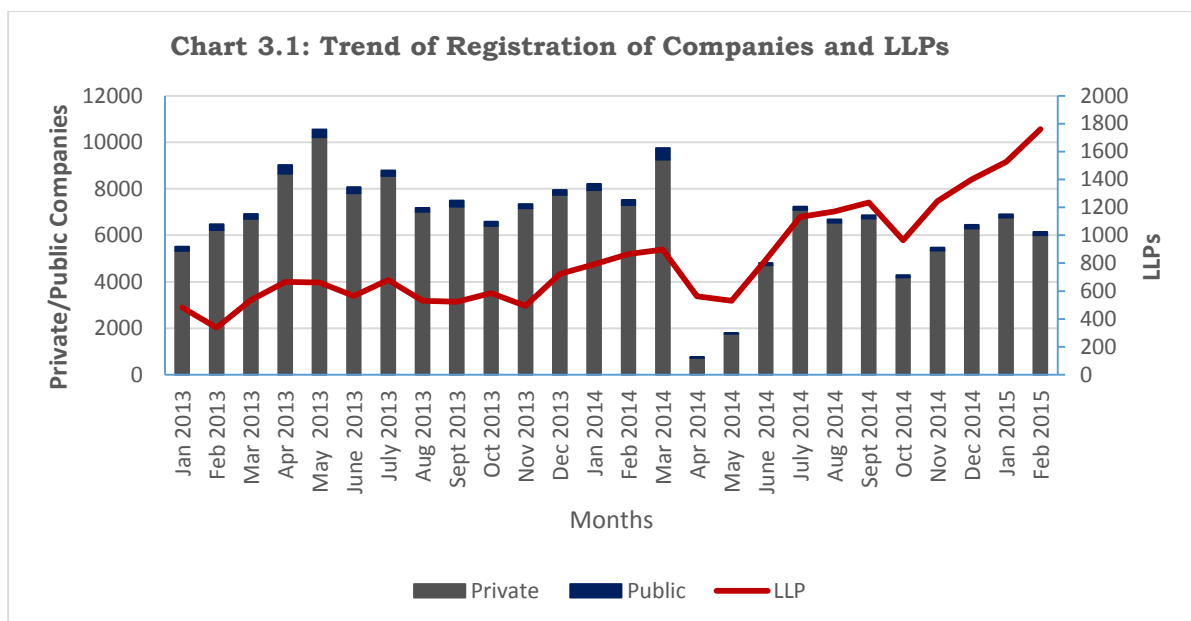
6. Up to 28th February, 2015, a total number of 1,953 One Person Companies (OPC) were registered with collective authorized capital of Rs. 44.83 crore. Economic activity wise classification of OPC up to 28th February, 2015 reveals that highest number of OPC are in Business Services (1,063) followed by Community, personal & Social Services (302), Real Estate and Renting (168) and Manufacturing (157) **(Chart 2.1)**. During the month of February, 2015, a total of 243 OPC were registered with authorized capital of Rs. 6.30 crore. Economic activity wise classification of OPC during the month reveals that highest number of 122 OPC were registered in Business Services, followed by 55 in Community, personal & Social Services and 20 in Manufacturing **(Table 2.1)**. Highest number of 46 OPC were registered in Delhi (18.93 %) followed by 42 in Maharashtra (17.28 %) and 33 in Uttar Pradesh (13.58 %) during the month of February 2015 **(Table-6.1)**.

III. TREND OF REGISTRATION OF NEW COMPANIES AND LLPs

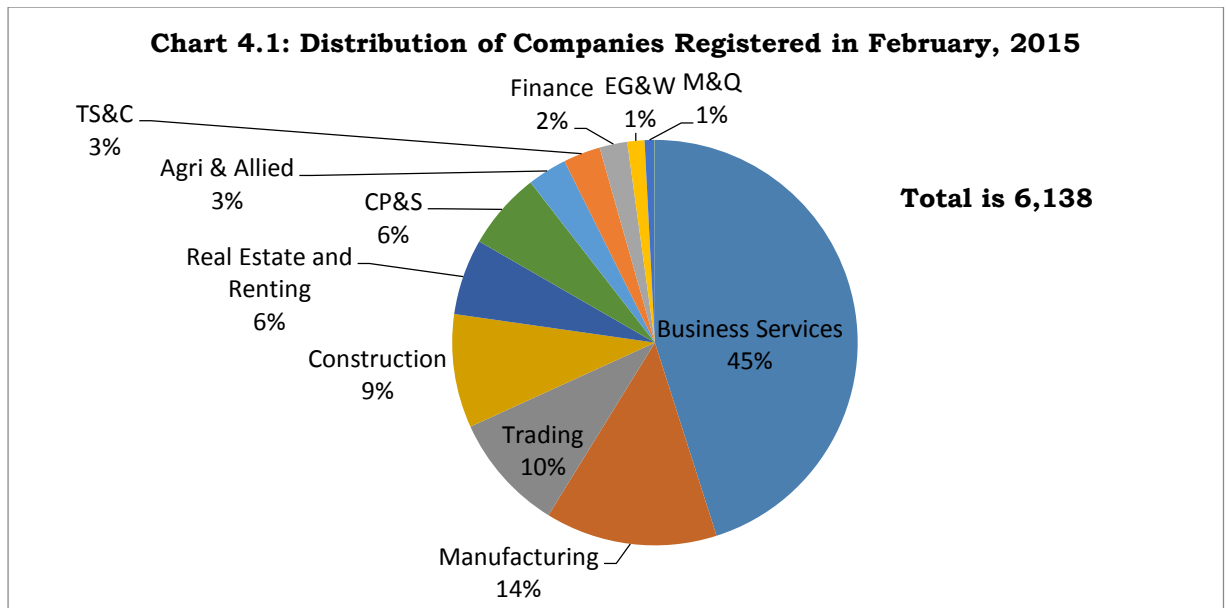
7. An analysis of registration of new companies during January 2013 to February 2015 indicates that monthly registration of companies is showing an increasing trend after hitting its lowest of 765 in April 2014 (**Chart 3.1**). A total of 6,138 companies were registered in February 2015 as compared to 7,513 in February 2014. A slight decrease in registration of companies has been witnessed in February 2015 over the previous month. An increasing trend is observed in monthly registration of LLPs in last few months with maximum registration of 1,761 LLPs in February 2015 (**Table 3.1**). Registration of new companies as well as LLPs has picked-up since April 2014, although a dip was witnessed in October 2014.



IV. REGISTRATION OF NEW COMPANIES DURING FEBRUARY, 2015

8. During the month of February, 2015, a total of 6,138 companies were registered with collective authorized capital of Rs. 4,037.04 crore. Of them 6,115 companies were registered as Companies Limited by Shares with authorized capital of Rs. 4,030.95 crore; 21 companies were registered as Limited by Guarantees with authorized capital of Rs. 8.00 lakh; 2 companies were registered as Unlimited Company with authorized capital of Rs. 6.01 crore (**Table-4.1**).

9. Economic-activity wise classification of companies registered during February, 2015 (**Table-4.2 and Chart 4.1**) reveals that the predominant share of companies are in Business Services (2,767) followed by Manufacturing (842), Trading (577), Construction (556) and Community, personal & Social Services (379).

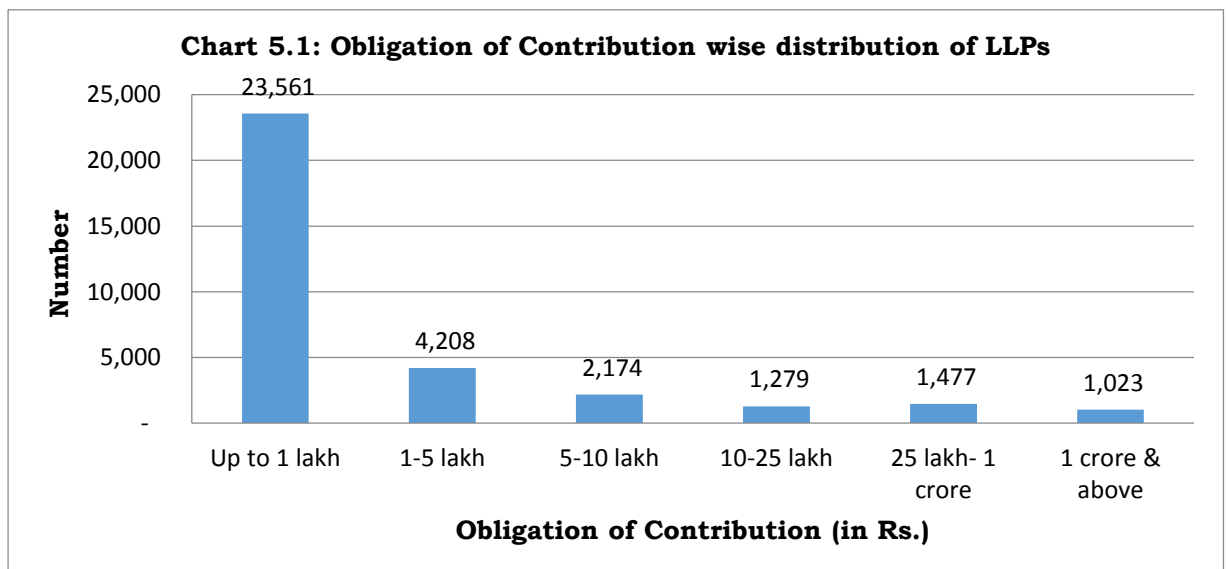

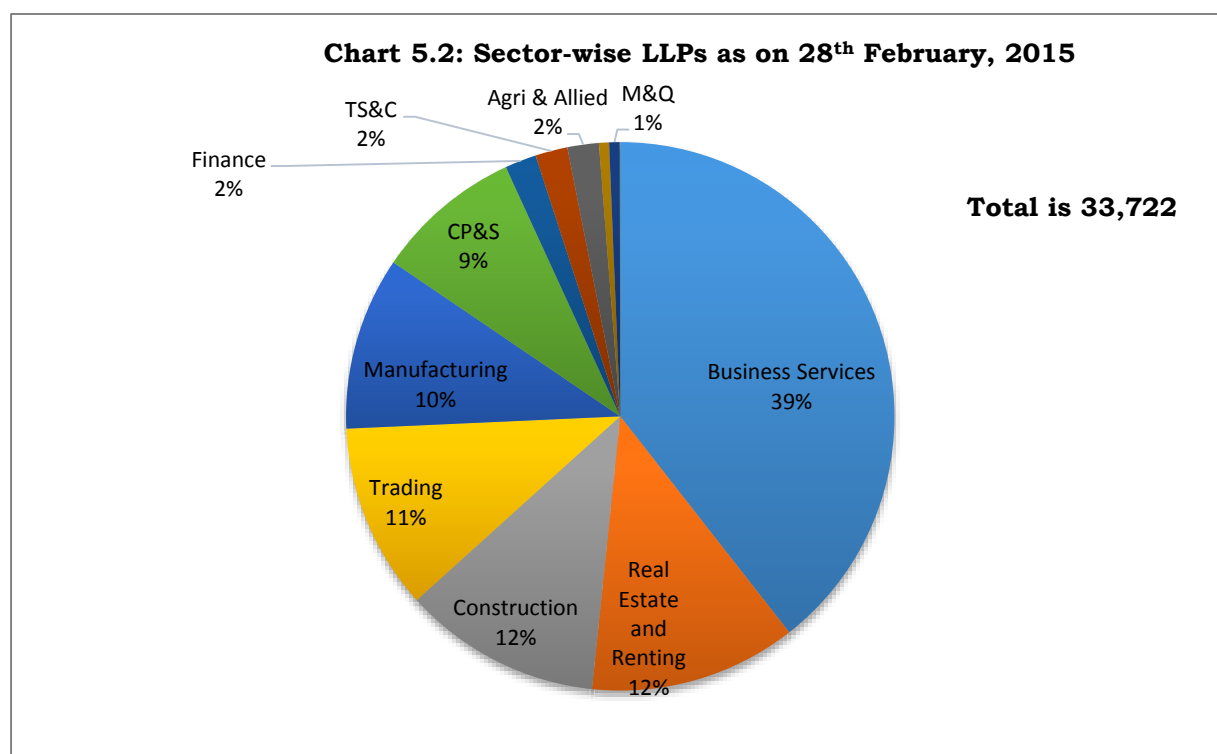
10. During February, 2015, 1,175 (19.14%) companies were registered in Delhi, followed by 1,001 (16.31%) in Maharashtra, and 640(10.43%) in Uttar Pradesh (**Table-4.3**).

V. Limited Liability Partnerships (LLP) and Foreign Companies

11. As on 28th February, 2015, a total number of 34,132 LLPs were registered in the country and 33,722 of them were active. About 82.35% active LLPs (27,769 in number) have obligation of contribution less than or equal Rs. 5 lakh each; and only about 3.03% (1,023 in number) of LLPs have obligation of contribution of above Rs.1 crore each (**Table-5.1 and Chart 5.1**).



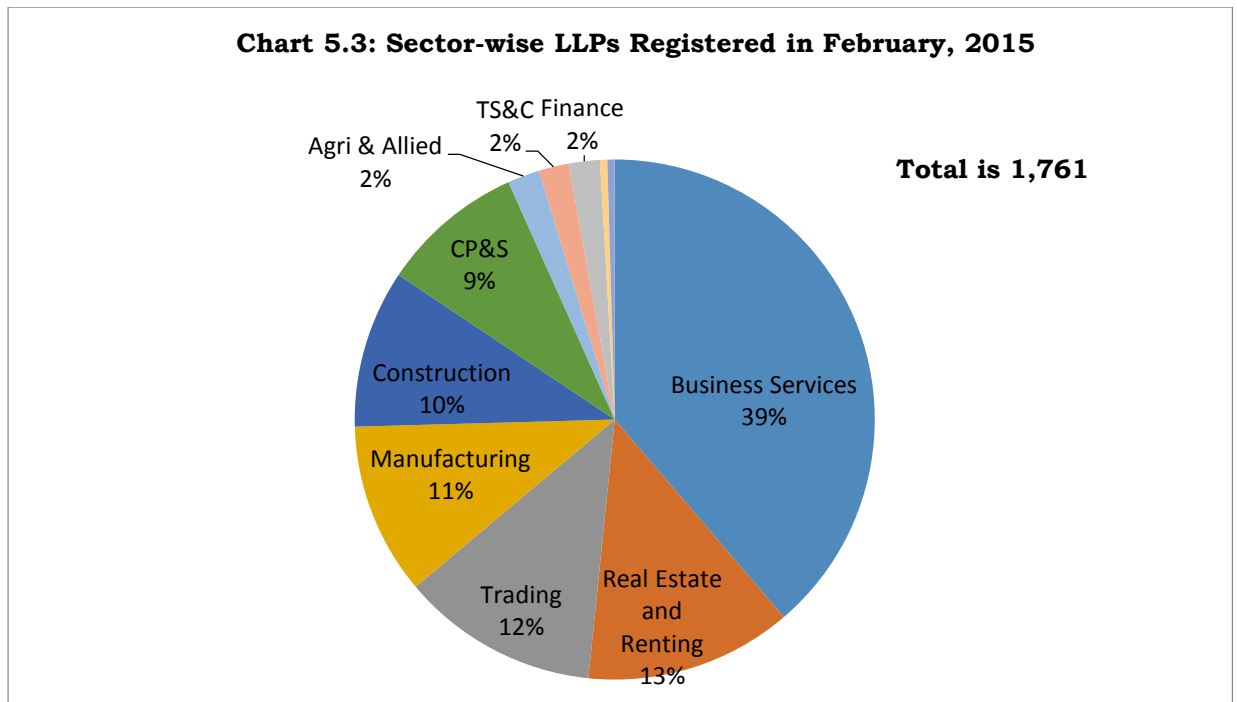
12. Broad economic sector wise classification of active LLPs as on 28th February, 2015 reveals that Service sector account for 25,311 LLPs, followed by Industry and Agriculture sectors accounting for 7,786 and 623 respectively. Economic-activity wise classification of active LLPs as on 28th February, 2015 reveals that a large number of LLPs are in Business Services (13,297) followed by Real Estate & Renting (4,119), Construction (3,934) and Trading (3,700) (**Table-5.2 and Chart 5.2**).

13. A total of 1,761 Limited Liability Partnerships (LLPs) were registered during February, 2015 with collective obligation of contribution of Rs. 271.74 crore. Economic activity wise classification of LLPs during the month reveals that highest number of 682 LLPs were registered in Business Services, followed by 227 in Real Estate and Renting and 216 in Trading (**Table-5.3 and Chart 5.3**). Highest number of 571 LLPs were registered in Maharashtra (32.42 %) followed by 308 in Delhi (17.49 %) during the month of February 2015 (**Table-6.1**).

Foreign Companies

14. As on 28th February, 2015, a total of 3,309 foreign companies were doing business in India. During the month of February, 2015, 18 foreign companies were registered in India including 4 each in Delhi and Karnataka, 3 each in Madhya Pradesh and Maharashtra, 2 in Rajasthan and 1 each in Gujarat and Uttar Pradesh. Out of these 18 foreign companies, 10 were registered under Business Services, 7 in Construction and the remaining one was registered under Mining & Quarrying.
