HIGHLIGHTS

I. REGISTERED COMPANIES AS ON 31st July, 2014

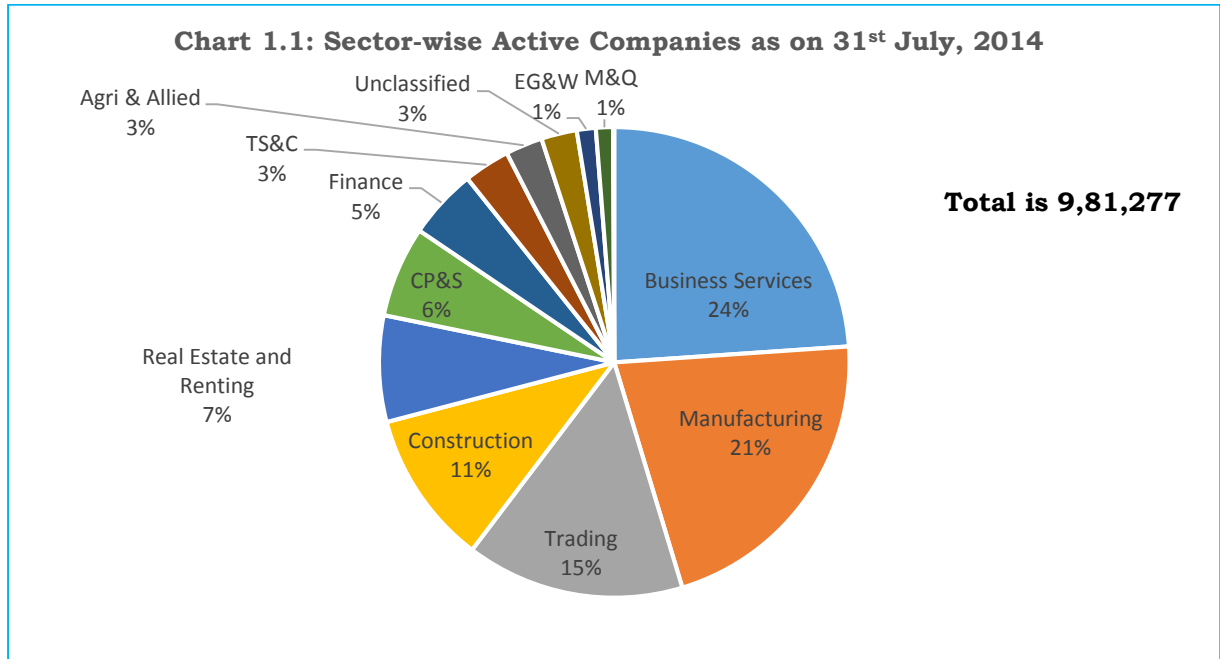
1. The total number of companies registered in the country as on 31st July, 2014, stood at 14,09,451. Of them, 2,58,003 companies were closed; 1,42,090 companies were lying dormant; 5,137 companies were under liquidation; 22,747 companies were in the process of being struck-off and 197 companies were in the process of being re-activated. Taking the above into account, there were 9,81,277 active companies as on 31st July, 2014.

2. Out of the 2,58,003 closed companies, about 10,215 companies were liquidated/dissolved; 2,31,638 companies were defunct (and hence struck-off); 14,149 companies were amalgamated/ merged with other companies; 2,001 companies were dissolved and converted to LLP. **Table-1.1** presents the summary picture of companies count as on 31st July, 2014.

3. Authorized Capital wise distribution of active companies as on 31st July, 2014 (**Table-1.2**) indicates that about 65.32% of companies (6,40,965 in number) have authorized capital less than or equal to Rs.10 lakh each and about 2.12% of companies (20,816 in number) have authorized capital of above Rs.10 crore each.

4. State/UT-wise distribution of registered companies indicates that Maharashtra has the highest number of companies (2,85,921), followed by Delhi (2,63,799) and West Bengal (1,82,188). Similarly, amongst 'Active Companies', Maharashtra has the maximum number of active companies (2,08,127), followed by Delhi (1,90,741) and West Bengal (1,35,103) as on 31st July, 2014 (**Table-1.3**).

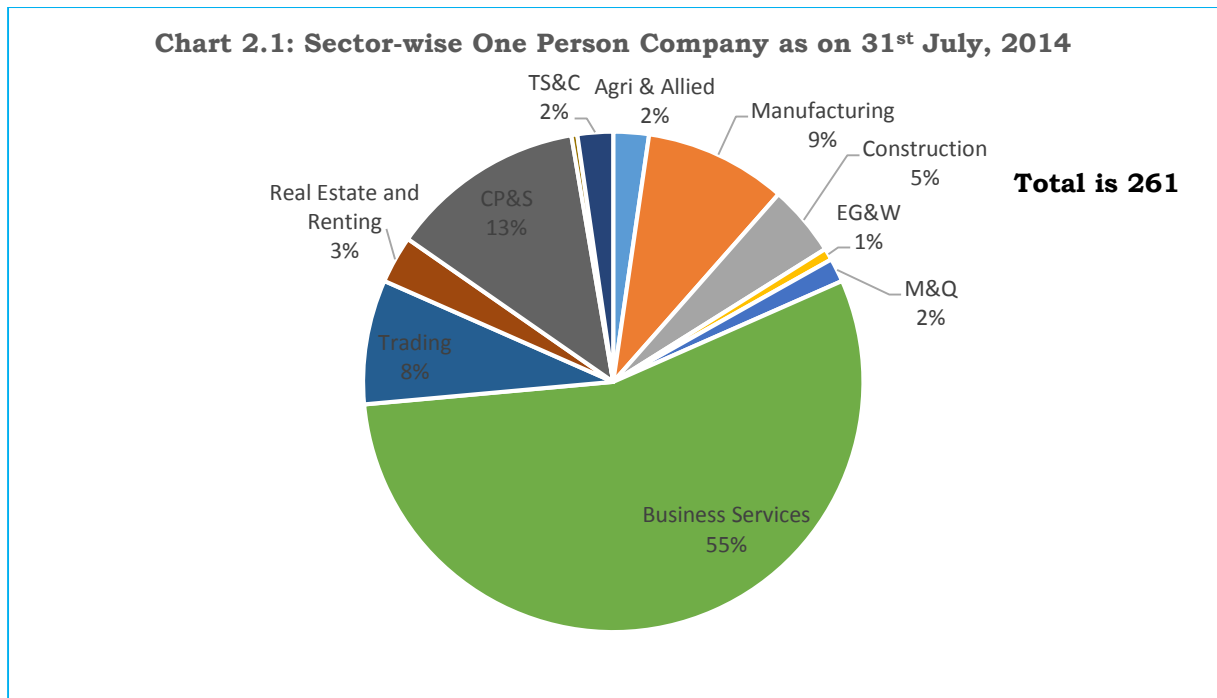
5. Economic-activity wise classification of active companies reveals that highest number of companies are in Business Services (2.35 lakh) followed by Manufacturing (2.10 lakh), Trading (1.47 lakh) and Construction (1.04 lakh). Business Services comprise Information Technology, Research & Development and other business activities (such as law, audit & accounts and consultancy, etc.) (**Table-1.4 and Chart 1.1**).



'M&Q' is Mining & Quarrying, 'EG&W' is Electricity, Gas and Water, 'TS&C' is Transport, Storage and Communication. 24,036 active companies (unclassified category) are having invalid Economic Activity (NIC-2004) Code.

II. One Person Company

6. Up to 31st July, 2014, a total number of 261 One Person Companies (OPC) were registered with collective authorized capital of Rs. 6.34 crore. Economic activity wise classification of OPC up to 31st July, 2014 reveals that highest number of OPC are in Business Services (144) followed by Manufacturing (24), Community, personal & social services (33) and Trading (21) **(Chart 2.1)**. During the month of July, 2014, a total of 183 OPC were registered with authorized capital of Rs. 4.94 crore. Economic activity wise classification of OPC during the month reveals that highest number of 100 OPC were registered in Business Services, followed by 24 in Community, personal & social services, 18 in Manufacturing and 17 in Trading **(Table 2.1)**. Highest number of 30 OPC were registered in Maharashtra (16.39 %) followed by 27 in Delhi (14.75 %) and 20 in Uttar Pradesh (10.93%) during the month of July 2014.

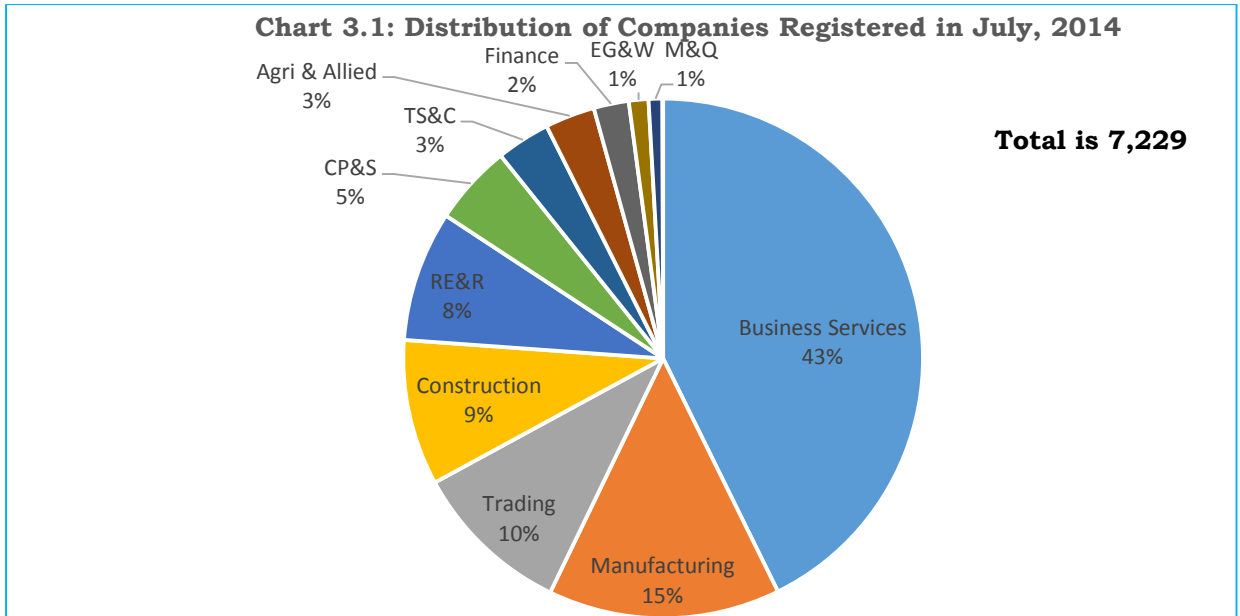

III. REGISTRATION OF NEW COMPANIES DURING JULY, 2014

7. During the month of July, 2014, a total of 7,229 companies were registered with collective authorized capital of Rs. 2,360.73 crore. Of them 7,199 companies were registered as Companies Limited by Shares with authorized capital of Rs. 2,360.57 crore; 25 companies were registered as Companies Limited by Guarantees with authorized capital of Rs. 9 lakh; 5 companies were registered as Unlimited Company with collective authorized capital of Rs. 7 lakh (**Table-3.1**).

8. Economic-activity wise classification of companies registered during July, 2014 (**Table-3.2 and Chart 3.1**) reveals that the predominant share of newly registered companies are in Business Services (3,088) followed by Manufacturing (1,044), Trading (717), Construction (655) and Real Estate & Renting (587).

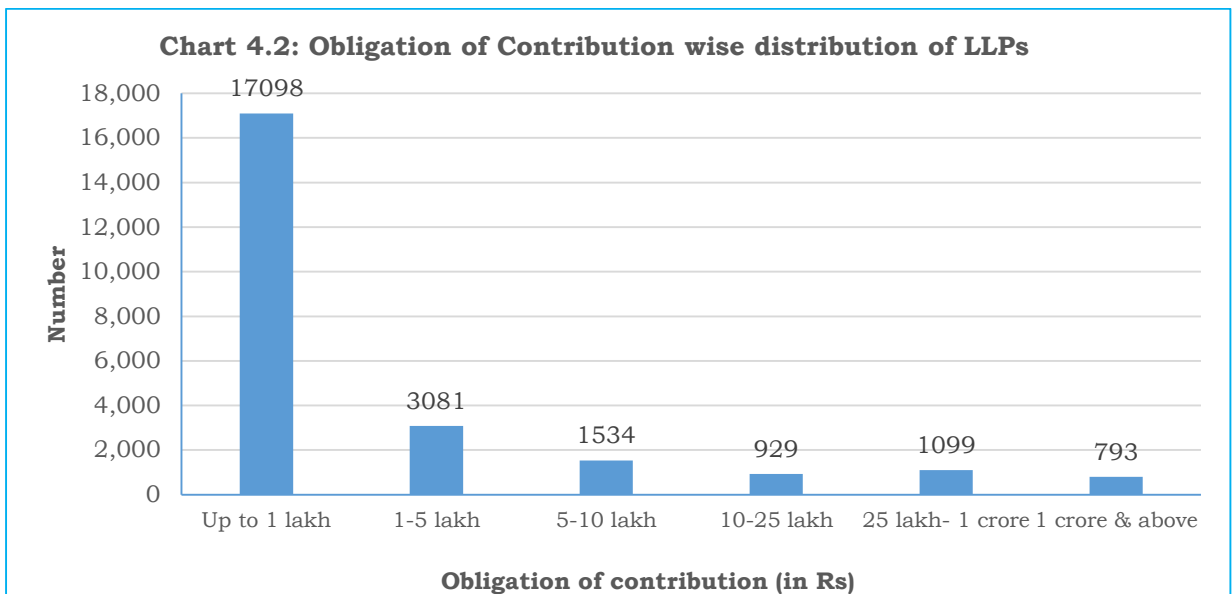

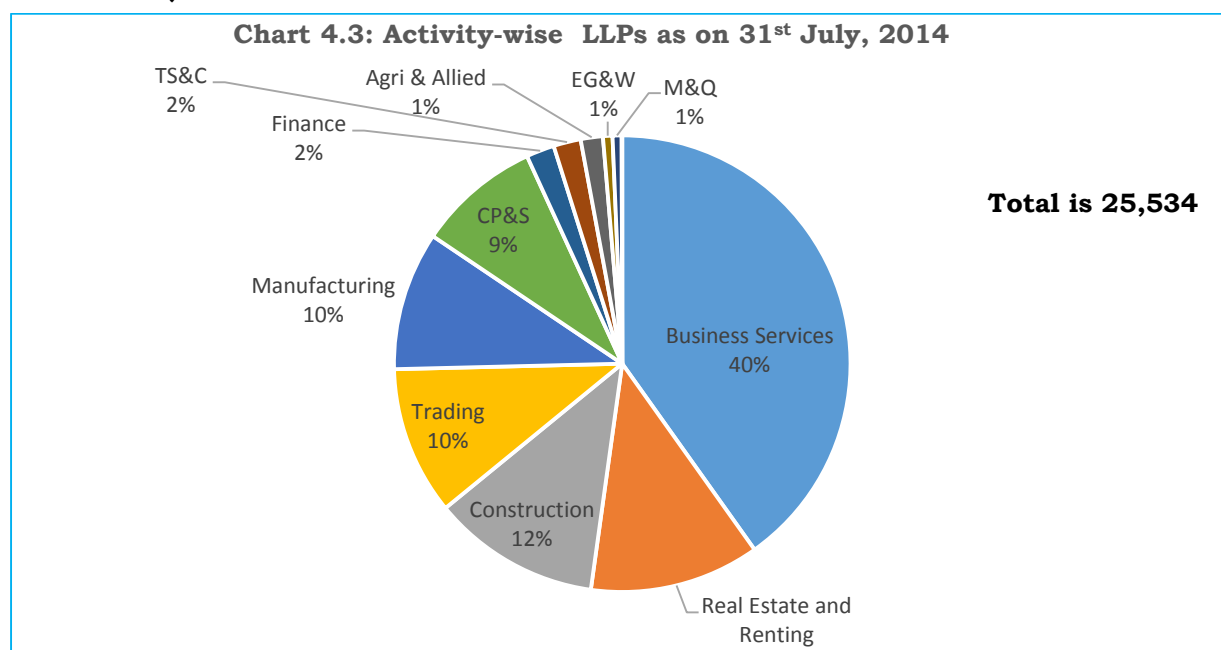
9. During July, 2014 Maharashtra has 1,382 (19.12%) newly registered companies, followed by Delhi with 1,263 (17.47%), and Uttar Pradesh with 633 (8.76%) (**Table-3.3**).

IV. Limited Liability Partnerships (LLP) and Foreign Companies

10. As on 31st July, 2014, a total number of 24,833 LLPs were registered in the country and 24,534 of them were active. About 82.25% active LLPs (20,179 in number) have obligation of contribution less than or equal Rs. 5 lakh each; and only about 3.23% (793 in number) of LLPs have obligation of contribution of above Rs.1 crore each. (**Table-4.1 and Chart 4.2**)

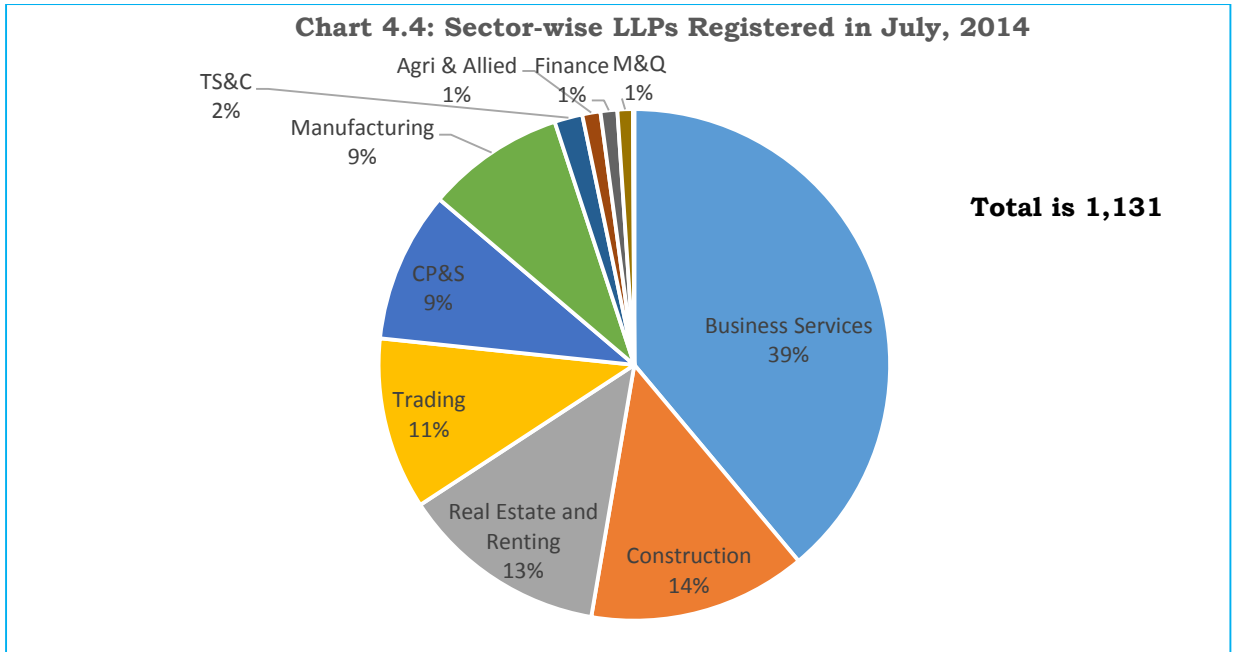


11. Broad economic sector wise classification of active LLPs as on 31st July, 2014 reveals that Service sector account for 18,497 LLPs, followed by Industry and Agriculture sectors accounting for 5,650 and 385 respectively. Economic-activity wise classification of active LLPs as on 31st July, 2014 reveals that a large number of LLPs are in Business Services (9,852) followed by Real Estate & Renting (2,955), Construction (2,919) and Trading (2,580) (**Table-4.2 and Chart 4.3**).

12. A total of 1,131 Limited Liability Partnerships (LLPs) were registered during July, 2014 with collective obligation of contribution of Rs. 270.31 crore. Economic activity wise classification of LLPs during the month reveals that highest number of 440 LLPs were registered in Business Services, followed by 156 in Construction and 148 in Real Estate and Renting (**Table-4.3 and Chart 4.4**). Highest number of 382 LLPs were registered in Maharashtra (33.78%) followed by 147 in Delhi (12.98%) during the month of July 2014.

Foreign Companies

14. As on 31st July, 2014, a total of 3,269 foreign companies were doing business in India. During the month of July, 2014, 17 foreign companies were registered in India, 10 in Maharashtra, 4 in Delhi, and 1 each in the state of Gujarat, Karnataka and West Bengal. A total of 11 foreign companies were registered under Business Services during the month.

Note:

1. Dormant Companies are those which have not filed their statutory annual filings consecutively for three years or have been assigned dormant status u/s 455 of Companies Act, 2013.
2. AIPG (Active in Progress): A dormant company is allowed 21 days by the Ministry to do its pending annual filings. During this period the status of company remains Active in Progress.
3. Under Section 560 of the Companies Act, 1956 Registrar of Companies is empowered to strike off the names of defunct companies. This is different from liquidation of Companies (either by Tribunal or Voluntary).
