

### **HIGHLIGHTS**

## I. REGISTERED COMPANIES AS ON 30th NOVEMBER, 2015

- 1. The total number of companies registered in the country as on 30<sup>th</sup> November, 2015, stood at 1,512,476. Of them, 281,400 companies were closed; 455 companies were assigned dormant status as per the Companies Act, 2013; 138,895 companies have not filed their statutory annual filings for 3 years consecutively; 5,412 companies were under liquidation; 22,139 companies were in the process of being struck-off and 156 companies were in the process of being re-activated. Taking the above into account, there were 1,064,019 active companies as on 30<sup>th</sup> November, 2015.
- 2. Out of the 281,400 closed companies, about 10,345 companies were liquidated/dissolved; 248,870 companies were defunct (and hence struck-off); 16,377 companies were amalgamated/ merged with other companies; 5,808 companies were dissolved and converted to LLP. **Table-1.1** presents the summary picture of companies count as on 30<sup>th</sup> November, 2015.
- 3. Out of the 1,057,382 active companies limited by shares; 993,992 were Private companies limited by shares; and 63,390 were Public companies limited by shares, of which 6,938 were Listed and 56,452 were Unlisted Companies (**Table 1.2**).
- 4. Authorized Capital wise distribution of active companies as on 30<sup>th</sup> November, 2015 **(Table-1.3)** indicates that about 66.29% of companies (705,344 in number) have authorized capital less than or equal to Rs.10 lakh each and about 2.14% of companies (22,752 in number) have authorized capital of above Rs.10 crore each.
- 5. State/UT-wise distribution of registered companies indicates that Maharashtra has the highest number of companies (304,578), followed by Delhi (281,442) and West Bengal (187,324). Similarly, amongst 'Active Companies', Maharashtra has the maximum number of active companies (223,603), followed by Delhi (202,798) and West Bengal (138,356) as on 30<sup>th</sup> November, 2015 (**Table-1.4**).
- 6. Economic-activity wise classification of active companies reveals that highest number of companies are in Business Services (2.60 lakh) followed by Manufacturing (2.19 lakh), Trading (1.54 lakh) and Construction (1.09 lakh). Business Services comprise Information Technology, Research & Development


and other business activities (such as law, audit & accounts and consultancy, etc. (**Table-1.5 and Chart 1.1**).

#### II. ONE PERSON COMPANY


7. Up to 30<sup>th</sup> November, 2015, a total number of 4,691 One Person Company (OPC) were registered with collective authorized capital of Rs. 117.36 crore. Economic activity wise classification of OPC up to 30<sup>th</sup> November, 2015 reveals that highest number of OPC are in Business Services (2,629) followed by Community, personal & Social Services (714), Manufacturing (642) and Trading (360) (Chart 2.1). During the month of November, 2015, a total of 288 OPC were registered with authorized capital of Rs. 7.09 crore. Economic activity wise classification of OPC during the month reveals that highest number of 180 OPC were registered in Business Services, followed by 44 in Community, personal & Social Services and 26 in Manufacturing (Table 2.1). Highest number of 52 OPC were registered in Delhi (18.06%), 39 each in Karnataka (13.54%) and Maharashtra (13.54%) and 29 in Uttar Pradesh (10.07%) during the month of November, 2015 (Table-6.1).


#### III. TREND OF REGISTRATION OF NEW COMPANIES AND LLPs

8. An analysis of registration of new companies during January 2013 to November 2015 indicates that monthly registration of companies is showing an increasing trend after hitting its lowest of 765 in April 2014 (Chart 3.1). A total of 6,150 companies were registered in November 2015 as compared to 5,471 in November, 2014. A slight decreased in registration of companies has been witnessed in November, 2015 over the previous month. A decreasing trend is observed in monthly registration of LLPs in last few months with minimum registration of 1,074 LLPs in November, 2015. (Table 3.1).



#### IV. REGISTRATION OF NEW COMPANIES DURING NOVEMBER, 2015

- 9. During the month of November, 2015, a total of 6,150 companies were registered with collective authorized capital of Rs. 764.21 crore. Of them 6,120 companies were registered as Companies Limited by Shares with authorized capital of Rs. 762.97 crore; 28 companies were registered as Limited by Guarantees with authorized capital of Rs. 122.00 lakh; 2 companies were registered as Unlimited Company with authorized capital of Rs. 2.00 lakh. (**Table-4.1**).
- 10. Economic-activity wise classification of companies registered during November, 2015 (**Table-4.2 and Chart 4.1**) reveals that the predominant share of companies are in Business Services (3,134) followed by Manufacturing (740), Trading (581), Construction (352) and Community, personal & Social Services (345).




11. During November, 2015, 1,074 (17.46%) companies were registered in Maharashtra, followed by 976 (15.87%) in Delhi, and 625 (10.16%) in Karnataka (**Table-4.3**).

### V. <u>Limited Liability Partnerships (LLP) and Foreign Companies</u>

12. As on 30<sup>th</sup> November, 2015, a total number of 50,290 LLPs were registered in the country and 49,476 of them were active. About 81.70 % active LLPs (40,423 in number) have obligation of contribution less than or equal Rs. 5 lakh each; and only about 3.10% (1,532 in number) of LLPs have obligation of contribution of above Rs.1 crore each **(Table-5.1 and Chart 5.1).** 




13. Broad economic sector wise classification of active LLPs as on 30<sup>th</sup> November, 2015 reveals that Service sector account for 37,236 LLPs, followed by Industry and Agriculture sectors accounting for 11,288 and 934 respectively. Economic-activity wise classification of active LLPs as on 30<sup>th</sup> November, 2015 reveals that a large number of LLPs are in Business Services (19,429) followed by Real Estate & Renting (5,940),Trading (5,831) and Construction (5,326) (**Table-5.2 and Chart 5.2**).

14. A total of 1,074 Limited Liability Partnerships (LLPs) were registered during November, 2015 with collective obligation of contribution of Rs. 343.09 crore. Economic activity wise classification of LLPs during the month reveals that highest number of 419 LLPs were registered in Business Services, followed by 142 in Trading and 119 in Transport, storage and Communications (**Table-5.3** and **Chart 5.3**). Highest number of 338 LLPs were registered in Maharashtra (31.47 %) followed by 146 in Delhi (13.59 %) during the month of November, 2015 (**Table-6.1**).

#### Foreign Companies

15. As on 30<sup>th</sup> November, 2015, a total of 3,326 foreign companies were doing business in India. During the month of November, 2015, 13 foreign companies were registered in India including 8 in Delhi, 3 in Maharashtra and 1 each in Haryana and Telangana. Out of these 13 foreign companies, 8 were registered under Business Services and 2 in Manufacturing, 1 each in Community, personal& Social Services, Construction and Trading.
