

# STAY ALERT ALONG LOC, ARMY CHIEF ASKS TROOPS

PRESS TRUST OF INDIA  
Jammu, 10 November

Army chief Gen Dalbir Singh Sahag today reviewed security situation along the LoC in Jammu and Kashmir and asked the troops to be alert against any inimical activity in the wake of heightened tension in Indo-Pak ties.

"The Chief of Army Staff, General Dalbir Singh visited Headquarters Northern Command at Udhampur today", a senior Army officer said. The visit comes a day after Pakistan said the Indian Army killed seven of its soldiers in shelling.

Gen Sahag exhorted the troops to be alert against any inimical designs and be aggressive in their approach.

The general interacted with the Formation Commanders and reviewed the situation along the Line of Control (LoC) as well as internal security situation in the Command theatre, he said. The Army chief commended the soldiers for boldly responding to ceasefire violations along the LoC.

He also lauded the synergy and cooperation between the Northern Command, Air Force, Paramilitary Forces, Civil Administration, Central Police Organisations operating in the region.

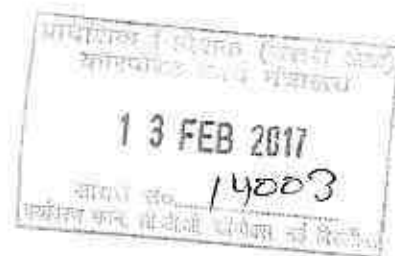

# विपक्षी दल विकास विरोधी कार्यों में संलिप्त

उन्होंने स्थानीय कांग्रेस विधायक निर्मला देवी और उनके पति एवं पूर्व मंत्री योगेश साव पर अपने निजी स्वार्थ के लिए आम लोगों को भड़काने का आरोप लगाया। उन्होंने दावा किया कि राज्य सरकार पूरे मामले की उच्चस्तरीय जांच करवा रही है और बहुत जल्द बौधियों का पता लग जाएगा और उनके खिलाफ सख्त कार्रवाई की जाएगी। जयंत सिन्हा ने कहा कि लोकतंत्र में हिंसा को कोई जगह नहीं है और सभी मामलों का शांतिपूर्ण समाधान होना चाहिए। उन्होंने कहा कि हजारोंवाग में बड़कागांव के प्रभावित रैयत की पूरी बात सुनकर ही एनटीपीसी के भूमि अधिग्रहण मामले का समाधान किया जाएगा और वह सुनिश्चित किया जाएगा कि वहां किसी के साथ भी जोर जबरदस्ती न हो। उन्होंने आरोप लगाया कि जहां राज्य सरकार राज्य को विकास के रास्ते पर ले जाना चाहती है, वहीं दूसरे कुछ लोग इसे विनाश के रास्ते पर ले जाना चाहते हैं। उन्होंने अपने ऊपर कांग्रेस सांसद प्रदीप बालमुखु द्वारा 'त्रिवेणी सैनिक कंपनी' के साथ साझेदारी करने का आरोप लगाए जाने पर गहरा दुख प्रकट किया और कहा कि यह पूरी तरह से गलत है। इस मामले में उन्होंने कांग्रेस नेता के खिलाफ अवमानना का मामला दर्ज कराने की घोषणा की। सिन्हा ने कहा कि पुलिस कार्रवाई में मारे गये लोगों के परिजनों में से एक-एक को नौकरी भी देने की बात सरकार सुनिश्चित कराएगी। साथ ही राज्य सरकार द्वारा घोषित दो-दो लाख रुपए की सहायता राशि को बढ़ाने का प्रयास वह स्वयं करेंगे।

# धर जैसी एक जेल में जीवन बिताते हैं कैदी

खुली जेल में कैदियों को भोजन के लिए एक चयन प्रक्रिया है। इन सभी मापदंडों पर खरा उतरने के बाद ही कैदियों का खुली जेल में रहने के लिए चयन किया जाता है। उन्होंने कहा, 'इसमें विशेषतौर पर ऐसे कैदियों का चयन किया जाता है जो कि आवंटन अपराधी नहीं होते तथा 10-12 वर्ष की कैद के बाद उनकी सजा के अंतिम एक-दो साल ही शेष रहते हैं।' बैनर्जी ने बताया, 'होशंगाबाद खुली जेल का प्रयोग सफल रहा है। अब सतना में एक और खुली जेल का निर्माण किया जा रहा है जो कि अगले साल तक चालू हो जाएगी। इसके बाद प्रदेश के भोपाल, ग्वालियर, जबलपुर, और उज्जैन में भी इस तरह की खुली जेल शुरू की जाएगी। प्रत्येक जेल में 25 कैदियों के परिवार सहित रहने की व्यवस्था रहेगी।' खुली जेल में रहने वाले मुकेश केवट का कहना है कि परिवार के भरण पोषण के लिए वह सब्जी का व्यवसाय करता है। खुली जेल में अन्य बंधी भी रोजगार से जुड़े हुए। कोई कैदी न चलता है, तो कोई फल बेचता है। आमदनी से परिवार का भरण पोषण किया जाता है। उसने कहा, 'हम खुश हैं कि हमें सजा के दौरान परिवार का साथ मिल रहा है और हमारे बच्चे पढ़ने भी जाते हैं।' होशंगाबाद खुली जेल के अधीक्षक मनोज साहू ने बताया कि होशंगाबाद खुली जेल में 25 कैदियों के रहने की व्यवस्था है।

दुई, 7 अक्टूबर (भावा)।

प्रवर्तन निदेशालय (ईडी) ने शुक्रवार बंबई हाई कोर्ट को बताया कि उसने ओशो रजनीश के एक ट्रस्ट के क्रोध में कथित गड़मड़ी और जालसाजी की शिकायतों की जांच शुरू कर दी है। दूसरी ओर, अपनी छानबीन में शिथिलता बरतने के लिए पुणे पुलिस को न्यायालय की कड़ी फटकार सुननी पड़ी।

न्यायमूर्ति एनएच पाटिल और न्यायमूर्ति पीडी नाइक की खंडपीठ बेंगलूर टक्कर नाम के एक शख्स की याचिका पर सुनवाई कर रही थी। टक्कर ने आरोप लगाया था कि ओशो इंटरनेशनल फाउंडेशन के ट्रिस्टियों ने ओशो की वसीयत में उनके वरतखत वा फर्जीवाड़ा किया था। टक्कर के मुताबिक, ट्रिस्टियों ने ट्रस्ट के पैसे अपनी निजी कंपनियों में कथित तौर पर अंतरित कर लिए। 2012 में टक्कर ने पुणे पुलिस के आयुक्त को पत्र लिखा था, जिसके बाद 2013 में ट्रिस्टियों के खिलाफ प्राथमिकी दर्ज की गई थी, लेकिन अब तक इसमें कोई प्रगति नहीं हुई। इसके बाद टक्कर ने हाई कोर्ट का रुख कर मामले की जांच सीबीआई को सौंपने की मांग की थी। ओशो रजनीश का 1990 में निधन हो गया था और उनकी वसीयत 1989 में तैयार की गई थी। टक्कर का आरोप है कि वसीयत में फर्जीवाड़ा किया गया। अपने आरोप के समर्थन में उन्होंने एक निजी हैडक्वार्टरिंग विशेषज्ञ की रिपोर्ट भी दाखिल की। उन्होंने मामले की सीबीआई जांच करने की मांग की। इस बीच, पुणे पुलिस ने शुक्रवार अदालत को बताया कि उसने केंद्र सरकार को पत्र लिखकर कुछ देशों को लैटर्स रोगेटरी (न्यायिक अनुरोध पत्र) जारी करने की मांग की है ताकि मामले से जुड़े कुछ दस्तावेज हासिल किए जा सकें।

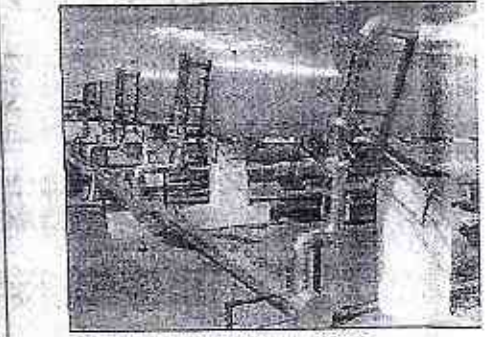
