
OFFICE ORDER

2. The above named probationers are designated as Assistant Director while undergoing professional training in ICLS Academy, IICA, Manesar. Their pay is hereby fixed at Rs. 56,100/- in Level 10 (Rs. 56,100- Rs. 1, 77,500/-) of Pay Matrix as per CCS (Revised Pay) Rules, 2016.
3. As per instructions of DoPT, the appointment is subject to the following conditions:
 - a) In case, enquiry, as envisaged under Rule 20 of Civil Services Examination Rules, is pending against them, their appointment will be subject to them being found suitable on the basis of such enquiry as may be considered necessary by the Government, having regard to their character and antecedents.
 - b) If at any point in future, it is found that any certificate or document or testimonial or information furnished by any officer, having a bearing on their eligibility for this appointment, is not in order, or any information/ facts having bearing on his/her eligibility have not been disclosed, or misrepresented by his/her, then his/her appointment will be liable to be cancelled forthwith, without prejudice to any other punitive action under the relevant rules.
4. The appointment is also subject to satisfaction of all terms and conditions as mentioned in the 'Offer of Appointment' issued by Ministry of Corporate Affairs to officers, the provisions of ICLS Rules, 2015 and other relevant rules on the subject.
