Subject : Approval of the decisions taken in the DPC Meeting held in RD Chennai on 21-8-2011 for promotions/MACPS/ACP

The undersigned is directed to refer to the Minutes (in 3 parts) of the DPC Meeting forwarded by RD Chennai vide F.No. 1(76)/2011-DPC dated 17-11-2011 and to convey the approval/decision of the competent authority in MCA for promotions in existing/future/consequential vacancies and ACP/MACPS benefits, as below :

(a) Regular promotion from Steno Grade II to Steno Grade I

(see Para 1.6, 1.7 of Minutes Part I) :

(d) Regular promotions from UDC to JTA

(see para 4.11, 4.12 of Minutes Part I) :

(i) The nodal agency, the DOPT, by its clarification dated 1-12-2011 (photocopy enclosed) has stated that ---

'posts are to be filled (by promotion) as per eligibility conditions prescribed in the recruitment rules in force at the time of occurrence of the vacancies unless the amended RRs are brought into force with retrospective effect.'

(ii) The amended RRs of JTA are applicable from the date of notification, that is from 25-7-2011. Therefore, for JTA vacancies upto 24-7-2011, the old RRs shall apply (in which for promotion from UDC to JTA, it is 8 years qualifying service). For vacancies from 25-7-2011 onwards, the new RRs shall apply (in which for promotion from UDC to JTA, it is 10 years qualifying service). RD Chennai is therefore requested to screen all vacancies in JTA, considered in the said DPC, on the basis of above clarification from DOPT and re-forward the promotion proposal for acceptance by the Ministry.

(e) Regular promotion from LDC to UDC

Ministry is not concerned as promotion is in Group C post of UDC.

(f) Regular promotion from MTS to LDC

Ministry is not concerned as promotion is in Group C post of LDC.

(g) Adhoc promotion from UDC to JTA

Same comments as in Para 3(d) above.

(h) ACP benefit to 1 officer in the Pay Scale of 2610-4000 w.e.f. 01.05.2002

Ministry is not concerned as ACP benefit is in erstwhile Group C/D pay scales.

(i) MACP benefit to 15 officers in Group B and C Grade Pay

(see para 8,9 and 12 and Annexure B of Minutes Part III) :

Ministry is not concerned with MACPS benefits in Group C Grade Pay. However, for MACPS in Group B Grade Pay, the following decision is communicated :

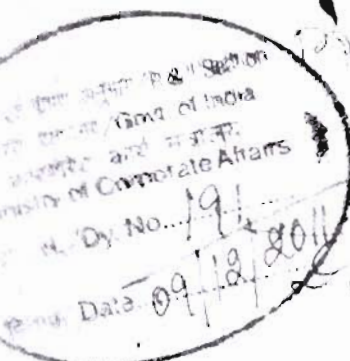
