**Postings on promotion**

2.1 The RD Noida may issue promotion-cum-posting order, in all above mentioned Group B promotion cases and other Group C promotion cases, continuing all of them in their present offices on promotion, except the below mentioned two cases.

2.2 In view of large vacancies in JTA grade in MCA Headquarters (which is a part of the Northern Region, for the purpose of direct recruitment and promotion in JTA), Sh. GL Katyal and Smt. Shyamli Bagchi, on their promotion to JTA grade, are posted in Ad.III Section and Ad.II Section of MCA Headquarters respectively.

**Re-verification of vigilance status and other service details**

3. Since the DPC recommendations are based on the vigilance status of 06-11-2012, before issuing promotion-cum-posting orders and before relieving them for joining in promotion posts, the RD Noida has to verify that all mentioned officers are clear from vigilance angle.
