
2. The appointment is subject to following conditions, as per instructions of DOPT given in their OM No. F.No. 13012/ /2011-AIS-I dated 3.2.2011 (enclosing therewith DOPT OM No. 13012/1/2007-AIS(I) dated 27-6-2007) :-

(a) In case the enquiry as envisaged under Rule 20 of Civil Services Examination Rules is pending in your case, your appointment to a service will be subject to you being found suitable on the basis such enquiry as may be considered necessary by the Government having regard to your character and antecedents.

(b) In case, at any stage, it is found that any certificate/document/testimonial etc. furnished by you and having a bearing on your eligibility is not in order or any information/ material facts having bearing on your eligibility have been hidden/misrepresented by you, at any stage, right from the filing application for Civil Services Examination, then your appointment is liable to be cancelled forthwith without prejudice to any other punitive action under relevant rules."

3. The appointment is further subject to satisfaction of all the terms and conditions as mentioned in the 'Offer of Appointment' issued by Ministry of Corporate Affairs in Dec 2010/Jan 2011 to respective candidates as well as the existing provisions of ICLS Rules 2008.

4. It is clarified that entitlements of salary (and arrears) shall be from the actual date of appointment mentioned in Para 1 above wherever exemptions from foundational training were allowed. In remaining cases, it shall be either from 30-8-2010 (if attended foundational training) or joining dates after relieving from previous employer.
