Office Memorandum

Subject: Seniority list of Senior Technical Assistants (STA) in Ministry of Corporate Affairs as on 01.01.2015.

A provisional seniority list of Senior Technical Assistants (STA) as on 01.01.2015 was circulated on 27.01.2015. In this context, the Ministry has received

(a) 34 similar representations requesting to fix the Seniority as per instructions of DoPT vide OM No. 20011/1/2012-Estt. (D) dated 04th March 2014. The names of STA who have made representations as above placed at **Annexure-A**. It is stated that in pursuance of Hon'ble Supreme Court judgement on 27.11.2012 in Civil Appeal No. 7514-7515/2005 in the case of N.R. Parmar Vs. UOI & Ors., DOPT has issued an OM dated 4th March, 2014 stating, inter alia, that its OM dated 03.03.2008 is to be treated as *non-existent/withdrawn ab initio* and that all existing instructions on seniority were consolidated by DoPT vide its OM dated 03.07.1986 which need to be followed for determination of inter se seniority of Direct Recruits and Departmental Promotes against the vacancies of a recruitment year.

(b) A representation from Ms. Soma Sen Gupta disputing her seniority in relation to Shri Ashish Chatterjee based on the date of joining.

(c) 05 representations for correction/entry of data in the column of date of joining government service/date of joining in STA cadre.

(d) 08 similar representations requesting that the Seniority of the 40 JTAs who were promoted under DP quota are to be fixed considering the vacancy year in which it arises in spite of year 2012-13. The names of STAs who has represented are indicated at **Annexure-B**. Subsequently, this Ministry has received another representation dated 20.01.2016 and 06.01.2016 from Ms. Yamini Gupta and Sh. K.G. Chawla, respectively on the same issue which is duly acknowledged.

2. In this background, the representations for correction/entry of data in the column of date of joining government service/date of joining in STA cadre have been considered based on recommendations of their controlling officers and suitable entries



in the column of date of joining government service/ date of joining in STA cadre have been done for following five STAs:-

- (a) Shri Rajkumar S.
- (b) Shri Manoj G. Dalal
- (c) Shri A.S. Rana
- (d) Shri Krishan Paul Dutt
- (e) Shri O.P. Badhania

3. As far the representation of Ms. Soma Sen Gupta is considered, she along with Shri Ashish Chatterjee were promoted by recommendation of same DPC. In the recommendation of DPC, Shri Ashish Chatterjee is placed at Sr. No. 1 and Ms. Soma Sen Gupta at Sr. No. 2. In the provisional seniority, accordingly, Shri Ashish Chatterjee was placed above Ms. Soma Sen Gupta. This is as per instructions on seniority by DoPT vide OM dated 03.07.1986. Therefore, the contention of Ms. Soma Sen Gupta is devoid of merits and therefore rejected.

4. DoPT OM dated 07.02.1986 inter-alia stipulates that the unfilled Direct Recruitment (DR) Quota Vacancies would be carried forwarded and added to the corresponding direct recruitment vacancies of the next year (and to subsequent years where necessary) for taking action for direct recruitment for the total number. Thereafter, in that year while seniority will be determined between direct recruits and promotes, to the extent of the number of vacancies for direct recruits and promotes as determined according to the quota for that year, the additional direct recruits selected against the carried forward vacancies of the previous year would be placed en-bloc below the last promote (or direct recruitments as the case may be).

5. In this regard it is mentioned that earlier in the old RRs of STA there was a provision of Departmental Promotion Examination (DPE) quota. Since 2005-06 there was no departmental exam, vacancies from DPE quota occurred during the year 2005-06, 2006-07, 2007-08, 2009-10, 2010-11, 2011-12, 2012-13 were 02, 02, 03, 07, 02, 18 and 03, which could not be filled. These vacancies were carried forwarded to the vacancy year 2012-13 under DP quota, upon notification of Revised RRs in 2012. Accordingly, eligibility has been considered as on 01.01.2012, Officials promoted against these vacancies may be given seniority of 2012-13.

6. As far as 34 representations mentioned in para 1 above are concerned, the available records of direct recruitments and departmental promotes were examined with reference to instructions of DoPT OM dated 03.07.1986. Based on examination and extant instructions, the seniority list of STA as on 01.01.2015 has drawn (placed at Annexure-C) based on factual position indicated below:-

S.No. 1 & 2- DP Candidates appointed against the Vacancy Year 2006-07 and there is no DR Candidate in the vacancy year 2006-07.

S.No. 3- One DP Candidate appointed against the Vacancy Year 2007-08 and there is no DR Candidate in the vacancy year 2007-08.

S.No. 4 to 15- DP and DR Candidates have been appointed against Vacancy Year 2008-09. The Seniority among DP & DR candidates has been fixed in the ratio of 50:50 as DP: DR: DP: DR against vacancy year 2008-09 and rest of the excess DRs have been bunched below S. No. 10, after the last promotee.

S. No. 16 to 44- DP and DR Candidates have been appointed against Vacancy Year 2009-10. The Seniority among DP & DR candidates has been fixed in the ratio of 50:50 as DP: DR: DP: DR against vacancy year 2009-10 and rest of the excess DRs have been bunched below the last promotee at S. No. 32.

S.No. 45 to 49- DP Candidates appointed against the Vacancy Year 2010-11 and there is no DR Candidate in the vacancy year 2010-11.

S. No. 50 to 68- DP and DR Candidates have been appointed against Vacancy Year 2011-12. The Seniority among DP & DR candidates has been fixed in the ratio of 50:50 as DP: DR: DP: DR against vacancy year 2011-12 and rest of the excess DRs have been bunched below the last promotee under S. No. 63.

S.No. 69 to 106- DP Candidates appointed against the Vacancy Year 2010-11 and there is no DR Candidate in the vacancy year 2012-13.

S.No. 107 to 116- DP Candidates appointed against the Vacancy Year 2013-14 and there is no DR Candidate in the vacancy year 2013-14.

7. The objections, if any, in the seniority list may be brought to the notice of the Ministry (Administration-II, Ministry of Corporate Affairs, Room No. 518,'A'Wing, Shastri Bhawan, New Delhi) latest by 28.03.2016. Errors and omissions, if any, may also be pointed out by 28.03.2016.
