**OFFICE ORDER**

3. The appointment is also subject to satisfaction of all terms and conditions as mentioned in the 'Offer of Appointment' issued by Ministry of Corporate Affairs to Sh. Vivek, the provisions of ICLS Rules, 2008 and other rules of the Competent Authorities on the subject.
