ORDER

This is an appeal filed under Section 454 (5) of the Companies Act, 2013 by the above Applicants in Form ADJ vide SRN No. R35944594, dated 20.03.2020 against the Adjudication Order No. ROC/S-454/10A/136/2020, dated 20.01.2020 under Section 454 (3) passed by the Registrar of Companies, Kerala for default in compliance with the requirements of Section 10A of the Companies Act, 2013 read with the Companies (Adjudication of Penalties) Rules, 2014.

2. The subject Company was incorporated on 14.12.2018. E-form INC-20A should have been filed within a period of 180 days from the date of incorporation as required under sub-clause (a) of sub-Section (1) of Section 10A of the Companies Act, 2013 (hereinafter referred to as the Act, 2013) and had filed the said form belatedly with a delay of 43 days on 25.07.2019. The Registrar of Companies, Kerala examined the said default and passed the Adjudication Order No. ROC/S-454/10A/136/2020 dated 20.01.2020 (impugned order) under Section 454 (3) & (4) of the Act, 2013 for the delay of 43 days in filing the Form INC-20A under Section 10A(2) of the Act, 2013 read with Rule 23A of the Companies (Incorporation) Rules, 2014 (hereinafter referred to as the Rules, 2014) and imposed a penalty of Rs. 50,000/- upon the Company and Rs. 43,000/- upon the Director in default viz. Shri. Rahul Renuka Thulaseedharan @ Rs. 1,000 per day.

3. The Appellants have assailed the impugned order on the grounds that no proper notice was sent and opportunity of being heard was not given and also contended that the delay was not intentional.

4. An opportunity of being heard was given to the Appellants on 30.12.2020. The Authorized Representative Shri. S. Suresh Kumar, FCA, Chartered Accountant has appeared for the Appellants while reiterating the grounds taken in the appeal had stated that the company had delayed in filing Form INC-20A by 43 days and non-compliance was not deliberate and hence sought condonation..

5. Though there is a default committed, there is a ground in interfering with the impugned adjudication order of the Registrar of Companies to the extent of reducing the quantum of penalty. Accordingly, the penalties imposed are reduced to 25 % for both i.e. from Rs. 50,000/- to Rs. 12,500/- for the Company and from Rs. 43,000/- to Rs. 10,750/- for the Director. The Appellants shall pay the penalty in 30 days.
