**Adjudication Order**

This office has issued a SCN to the company & its director vide letter No; ROC/NIDHI/MANISHA/2019/1632-1635 dated 28.10.2020 in response to Regional Director, Northern Region vide letter no: RD (NWR) NIDHI company /2020/1587 dated 21.10.2020 stating that Order issued by the O/o RD, NWR dated 08.10.2020 returned undelivered from the R.O. of the company with the postal remark " bar bar paryas karne par bhi praptkarta ka pata nhi chala ". The company has replied vide its letter dated 10.11.2020 stating that the company affixed its name, and the address of its registered office in legible letters on the outside of the R.O. of the Company.

Further, the hearing in the matter was held on 09.12.2020 and further hearing adjourned as requested by Authorized representative of the company for 06.01.2021. On 06.01.2021 Authorized representative of the company was appeared. The Authorized representative of the Company has furnished additional information & documents which shows that the company has maintained the Registered office of the Company at Survey No. 345 ,ward No .1, Basotia Marriage Garden Ke pas , Nawalgarh, Jhunjhunu , Rajasthan -333042.

Further, this office SCN vide No ROC/NIDHI/MANISHA/2019/1632-1635 dated 28.10.2020 and hearing notices dated 20.11.2020 & 28.12.2020 delivered on the address of registered office of the company.

Taking in to the consideration of facts, the undersigned has reasonable cause to believe that the company has maintaining it registered office and not made violation of section 12 (1) of Companies Act, 2013.

In view of above and in exercise of power u/s 454 (3) read with sub-section 1 of section 12 of Companies Act, 2013 no penalty imposed against the company & its directors.

Hence, the matter has been stands disposed off without any penalty.
