SALE NOTICE

1. Pursuant to the orders of the Hon'ble Bombay High Court dated 30.03.2017 passed on the Official Liquidator's Report No. 49 of 2017 dated 15/03/2017 offers are invited in sealed covers from the intending purchasers along with Earnest Money Deposit ("EMD") by way of demand draft/pay order drawn in favour of **"The Official Liquidator, High Court, Bombay"** payable at Mumbai for sale of the following **movable assets** of M/s Etisalat DB Telecom Pvt. Ltd. (In Liqn.) on **"as is where is and whatever there is basis"** situated at following locations.

2. The main object of M/s Etisalat DB Telecom Pvt. Ltd. (In Liqn.) was of providing telecom services and thus the movable assets included in the Lot Nos. 1 to 5 are mainly consisting of the equipments utilized by telecom industry and allied sectors located at several locations. The Lot No. 6 comprises of the burnt copper wires and Lot No. 7 & 8 consists of Non-technical movable assets i.e. office furniture, office equipments etc. at Mumbai and Warangal.

3. The Lot Nos. 1,3,4 and 5 are also put up for sale in sub lots, however, the Composite offer for the whole Lot of MSC / Warehouse at Lot Nos. 1,3,4 and 5 would be preferred over the offers received for the individual sub-lots.
