### Office Memorandum

Subject:- Revised provisional Seniority List of Junior Administrative Grade(JAG) officers of Indian Corporate Law Service as on 01.01.2012.

The undersigned is directed to forward herewith the revised provisional seniority list of officers in Junior Administrative Grade of Indian Corporate Law Service as on 01.01.2012 drawn in terms of Rule 8 of the Indian Corporate Law Service Rules, 2008.

- 2. It is mentioned that in the JAG DPC dated 30.11.2009, the UPSC assessed 27 candidates out of which a panel of 20 candidates were recommended for promotion to JAG for the vacancy year 2008-09.
- 3. The same JAG DPC also assessed Dr. M.M. Cholan but placed its recommendation in the sealed cover due to pendency of vigilance case against him, at the time of DPC.
- 4. After conclusion of the said vigilance case, the competent authority decided to open the sealed cover, which contained the following recommendation, regarding his seniority on promotion:
- ".... On the basis of assessment of Dr. M.M. Cholan, the committee recommended that his name may be included in the panel for the year 2008-09 at SL No. 7A below Sh. R.K. Meena (ST) (at SL. No. 7) and above Sh. G. Mukhopadhyay (at SL. No. 8)....."
- 5. In this JAG- DPC, Sh. R.K. Meena was recommended for JAG promotion as a Departmental Promotion (DP) candidate, alongwith other candidates. Simultaneous to this DPC, Sh. R.K.Meena was also selected for JAG grade by UPSC under Direct Recruitment (DR) quota. Because of this selection, Sh. R.K. Meena opted for his appointment under DR quota, instead of DP quota.
- 6. In the JAG seniority list, the position of an officer changes, if method of his appointment changes from DP appointee to a DR appointee. Accordingly, as per rules of fixation of inter-se-seniority between DR and DP appointee, Sh. R.K. Meena, migrated from his position of DP appointment (by JAG-DPC), to a higher position, due to DR appointment, in JAG list as on 01.01.2010.

- 7. The JAG-DPC recommendations, regarding placement of Dr. M.M. Cholan below Sh. R.K. Meena, is relevant with respect to Sh R.K. Meena continuing as a DP appointment in JAG grade. In view of change over, in respect of Sh. R.K. Meena, from DP appointee to DR appointee, the recommendations cannot be acted upon.
- 8. In this regard, after receipt of representation dated 09.07.2012 of Dr. M.M. Cholan, the comments of UPSC were sought. UPSC vide its letter dated No. F.1/5(3)/2009-AP.1V dated 23.08.2012 (copy enclosed as <u>Annexure B</u>) have made no comments to offer on the corrigendum proposed to be issued. However, it has clarified that in case there is a change in the seniority position of Shri R.K. Meena (ST) by virtue of his appointment to the JAG under direct recruitment quota, it is implied that Dr. M.M. Cholan is required to be placed above his immediate junior i.e. Shri G. Mukhopadhyay as per recommendations of DPC.
- 9. Therefore, the Para 2 of Officer Order No. PFG(480)/1989-Ad.II dated 18.05.2012(copy enclsed as <u>Annexure A</u>) regarding placement in seniority list as on 01.01.2012 of Dr. M.M. Cholan has to be superseded and he will be placed at SL. No. 34-A above Sh. G. Mukhopadhyay (SL. No. 34) in the seniority list of JAG as on 01.01.2010 and accordingly he will be placed at SL. No. 25-A above Sh. Arvind Shukla (SL. No. 25) (as he is immediate to Junior to Sh. G. Mukhopadhyay who voluntarily retired w.e.f. 01.05.2010) in the seniority list of JAG as on 01.01.2012.
- 10. It is requested that the revised Provisional Seniority List may be circulated amongst all concerned officers under your administrative control. The objections, if any, in the revised provisional seniority list may be brought to the notice of the Ministry (Administration -II, Ministry of Corporate Affairs, Room No. 518, 'A' Wing, Shastri Bhavan, New Delhi) latest by 20.10.2012. Errors and omissions, if any, may also be pointed out by 20.10.2012.
