OFFICE MEMORANDUM

Sub: Seniority list as on 01.01.2013 of officers of Junior Time Scale (JTS) in the Indian Corporate Law Service (ICLS).

Reference is invited to this Ministry's OM of even No. dated 10.02.2015 vide which Revised (recasted) provisional seniority list as on 01.01.2013 of officers of Junior Time Scale (JTS) in the Indian Corporate Law Service (ICLS) was circulated based on DoPT OM no. 20011/1/2012-Estt. (D) dated 4th March 2014 that all the existing instructions on seniority were consolidated by DoPT through a single OM dated 07.02.1986/ 03.07.1986 and treating OM dated 03.03.2008 as non-existent/ withdrawn *ab initio*.

2. DoPT OM dated 07.02.1986 inter-alia stipulates that the unfilled Direct Recruitment (DR) Quota Vacancies would be carried forward and added to the corresponding direct recruitment vacancies of the next year (and to subsequent years where necessary) for taking action for direct recruitment for the total number. Thereafter, in that year while seniority will be determined between direct recruits and promotees, to the extent of the number of vacancies for direct recruits and promotees as determined according to the quota for that year, the additional direct recruits selected against the carried forward vacancies of the previous year would be placed en-bloc below the last promotee (or direct recruitments as the case may be).

3. The vacancies under Direct Quota occurred during 2001-02 to 2003-04 and reported to UPSC on 20th October 2005 have been taken as vacancies for the vacancy year 2005-06 and the selected officers have been placed below the last promoted officer recommended by UPSC against vacancy year of 2004-05. Seniority of officers at Sl.No.3 to 14 has been fixed, accordingly.

4. Officers at Sl.No. 15,16 and 17 were promoted for vacancy year 2006-07 and no Direct Recruitment vacancies during the year 2006-07.

5. Seniority of officers at Sl.No. 18 to 29 were fixed on the basis of rotation of quota of vacancies during the vacancy year 2007-08.

6. After November 2008, ICLS officers in JTS grade (DR) were recruited through Civil Services Examination (CSE). First vacancies for CSE 2009 were reported in 2008 and these vacancies were confirmed to UPSC in January 2010. Hence, inter-se seniority of officers selected through CSE 2009 were fixed with the promotee officers of vacancy year 2009-10. This inter-se seniority has been maintained in respect of officers recruited through CSE 2010 and CSE 2011 also.

7. Based on the criteria outlined in preceding paragraphs and in the light of DoPT OM dated 07.02.1986/ 03.07.1986, revised (recasted) provisional seniority list as on 01.01.2013 of officers of Junior Time Scale (JTS) in the Indian Corporate Law Service (ICLS) was circulated vide OM dated 10.02.2015.

9. The issues raised in these representations on the Seniority List circulated vide aforesaid OM have been examined in the Ministry based on the following criteria:

- i. Vacancies in JTS of ICLS had arisen in 2001-2002, 2002-03, 2003-04 for which requisition was sent to UPSC on 20.10.2005 (i.e. in 2005-06).
- ii. Against these vacancies, UPSC had given a single panel of officers and they were considered for the vacancy year 2005-06. Accordingly, inter se seniority of DR & Departmental Promotee (DP) officers has been fixed in terms of DOPT OM dated 04.03.2014. DOPT has also been consulted in the matter.

10. In view of above mentioned facts, the twelve representations are disposed of as per details given below:
