

Posts of CP III/LA/Inspectors have been merged with CP II and the pay scale has been upgraded by the Vth Pay Commission, and re-designated as CP, hence the CP III/LA/Inspectors, in position as on the date of issue of notification, have been placed *enbloc* at the bottom of the CP II. The benefit is for the purpose of upgrading the pay and not for the purpose of seniority. The seniority of CP III/Jr. Insp/LA/Insp merged into combined CP seniority list will be calculated as per notification dated 29.08.2008.
